Independent Auditor's Report

To the Trustees and Plan Administrator of
Planet Aid 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Planet Aid 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. DESCRIPTION OF PLAN

The following description of Planet Aid 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering substantially all employees of Planet Aid, Inc. (the Plan Sponsor), excluding nonresident aliens with no U.S. income, independent contractors reclassified as an employee by the Internal Revenue Service (IRS) and residents of Puerto Rico. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor's Trustees and Plan Administrator are responsible for oversight of the Plan.

b. Eligibility

Participants are eligible to make contributions into the Plan and are eligible to receive the Plan Sponsor's discretionary matching and discretionary contributions upon completing 90 days of service and attaining 18 years of age.

c. Contributions

Each year, participants may contribute up to 100% of pre-tax and post-tax (Roth) annual compensation, subject to Internal Revenue Code (IRC) limitations. Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

Employees of the Plan Sponsor who do not affirmatively elect otherwise or opt out, are automatically enrolled in the Plan at a deferral contribution rate of 3% and their contributions are invested in a designated balanced fund until changed by the participant. Each year, effective January 1, 2025, the automatic elective deferral contribution shall increase 1%, until a maximum automatic elective deferral contribution of 6% is reached.

The Plan Sponsor may elect to make discretionary matching contributions calculated at a percentage determined by the Plan Sponsor. The Plan Sponsor funded discretionary matching contributions equal to 50% of a participant's contributions up to 6% of the participant's eligible plan compensation for the year ended December 31, 2024, totaling \$219,718.

The Plan Sponsor may also elect to make an additional discretionary contribution which is allocated using annual compensation for the plan year. For the year ended December 31, 2024, the Plan Sponsor did not make an additional discretionary contribution to the Plan.

d. Participant Accounts

Each participant's account is credited with the participant's contributions, the Plan Sponsor's contributions, plus earnings or losses thereon, and is charged with an allocation of administrative fees that are paid by the Plan. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are vested in the Plan Sponsor's contributions plus actual earnings based on the schedule below:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1 years	0%
At least 1 year, but less than 2	33%
At least 2 years, but less than 3	66%
3 years or more	100%

Participants become fully vested upon attainment of normal retirement age, death or disability.

f. Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan allowed is \$1,000. The loans are secured by the balance in the participant's account. Participants may not have more than one loan outstanding at any time. Loan terms range from one to five years. The interest rate is set at a commercially reasonable rate determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

g. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the normal retirement age of 65, with no option for early retirement. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of their account, installment payments or partial withdrawals. There are also retirement benefits available upon disability or death. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan Administrator will authorize the benefit payment without the participant's consent. Effective January 1, 2024, the limit of involuntary cash-out distributions was increased from \$5,000 to \$7,000 per the provisions of the SECURE Act 2.0.

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant may also request a withdrawal upon demonstration by the participant to the Plan Administrator that the participant is suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to Section 401(k) of the IRC or standards established by the Secretary of the Treasury or their delegate.

h. Forfeitures

Forfeitures represent non-vested Plan Sponsor contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeitures are retained by the Plan and are used to reduce future Plan Sponsor contributions and pay plan expenses. The Plan had unallocated forfeitures of \$15,893 as of December 31, 2024. The Plan had no unallocated forfeitures as of December 31, 2023. During 2024, there were \$47 of forfeitures used to pay plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of registered mutual funds are stated at quoted market prices on public exchanges, which represent the net asset value (NAV) of shares held by the Plan at year-end. Units held by the Plan in pooled separate account and the common collective trusts are based on each fund's daily NAV as a practical expedient, which is considered by the Plan Administrator to be the best approximation of fair value. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisor and the qualified institutions. See Note 4 for discussion of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. There were no defaulted loans for the year ended December 31, 2024.

Contributions

Contributions from plan participants and the discretionary matching contributions from the Plan Sponsor are recorded in the year which the contributions are withheld from compensation. The Plan Sponsor's discretionary contributions are recorded when such contributions are authorized by the Plan Sponsor's Board of Directors.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to advisory services and the administration of notes receivable from participants and processing of distributions are charged directly to participant accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation of investments.

Subsequent Events

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued. Except as noted in Note 1c, there were no other events that met the criteria for recognition for disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTIONS

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company) (collectively, Principal), the qualified institutions, have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use, based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Common collective trusts: Valued at the NAV of units of the collective trusts. The NAV, as provided by the qualified institutions, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. As of December 31, 2024 and 2023, the Plan had no plans to sell the common collective trusts at amounts different from NAV. There are no unfunded commitments.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are valued using observable inputs.

Pooled separate account: The fair value of the Plan's interest in the pooled separate account is based on the fund's daily NAV as a practical expedient, which is considered by the Plan Administrator to be the best approximation of fair value. The NAV is used as a practical expedient to estimate the fair value unless it is probable that all or a portion of the pooled separate account will be sold for an amount different from NAV. As of December 31, 2024 and 2023, the Plan had no plans to sell the pooled separate account at amounts different from NAV. Units are available for transactions at the closing accumulation unit value on an open exchange, and even though the underlying assets of the pooled separate account cannot be quickly sold and converted to liquid assets, it is backed with a liquidity guarantee to ensure funds are available to meet participant directed withdrawals.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. COMMON COLLECTIVE TRUSTS

The Plan's investments in the common collective trusts are represented by the common collective trusts' underlying investments in funds which invest in marketable securities, exchange traded funds, bonds, treasury securities, mutual funds, and interval funds. The Plan's investment in the CCTs is not considered a fully benefit-responsive investment contract and is reported at fair value (see Note 4).

6. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intention to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants would become fully vested in their employer contributions and all accrued benefits would be paid to participants in accordance with plan provisions.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institutions and notes receivable from participants are considered party-in-interest transactions. During the plan year 2024, there was \$16,238 of administrative expenses paid to the qualified institutions.

9. RISK AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that these changes could materially affect the amounts reported in the statements of net assets available for benefits.
