## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the East Management Services 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the East

Management Services 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

## **Basis for Opinion**

**Note A - Description of Plan:**

*General* - The East Management Services 401(k) Plan (the Plan), as amended and restated January 1, 2022, with amendments through January 1, 2024, is a defined contribution plan covering eligible employees of the following (the Company) as of December 31, 2024:

East Management Services, LLC	JKLM Energy, LLC
Black River Entertainment, LLC	Western New York Lacrosse, LLC
Hockey Western New York, LLC	Rochester Hockey, LLC
Western New York Arena, LLC	Rochester Arena, LLC

Pegula Sports & Entertainment, LLC was a participating employer until December 31, 2023.

The Plan document is the governing instrument and should be referred to for a full description of the Plan and its provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Eligibility* – Employees that have attained the age of 21 are eligible to make before-tax contributions, rollover contributions and after-tax Roth 401(k) contributions. For employees hired before January 1, 2023, employees must also have completed 500 hours of service in a 6 consecutive month period, or after 1 year of service, in order to become eligible to participate. In addition, employees are eligible to receive matching contributions, provided under the terms of the Plan as described below. Residents of Puerto Rico, employees covered by a collective bargaining agreement, leased employees, non-resident aliens with no U.S. source income, and seasonal/part-time employees under age 21 and who have not completed 1,000 hours of service in a 12 consecutive month period, are not eligible to participate in the Plan. Additionally, employees of Hockey Western New York, LLC who are eligible for the National Hockey League Pension Plan are not eligible to participate in the Plan.

*Contributions* – Upon meeting the eligibility requirements, for those employees hired prior to January 1, 2023, an employee may opt-into the Plan and elect to contribute before-tax or after-tax earnings in an amount up to 90% of his or her compensation. For those employees hired on or after January 1, 2023, the Plan was amended in which employees are automatically enrolled in the Plan with a contribution rate of 2% of his or her compensation. The sum of before-tax and after-tax Roth 401(k) contributions are subject to annual limitations prescribed by the Internal Revenue Code (IRC).

Employees may also elect to make catch-up contributions provided they have reached age 50 by the end of the current calendar year.

Eligible compensation is defined as the taxable compensation paid excluding reimbursements or other expense allowances, fringe benefits, moving expenses, deferred compensation, and payments in lieu of wages for qualified military service and welfare benefits. Eligible compensation is subject to annual limitations prescribed by the IRC.

The Company makes matching contributions to participants of the Plan equal to 100% of the first 4% of eligible compensation contributed to the Plan by a participant. Such contributions amounted to \$1,150,568 for the year ended December 31, 2024.

Participants may direct their own contributions, as well as the Company's matching contributions, into any of a number of separate mutual funds or a fixed annuity fund maintained by Empower Trust Company, LLC.

**Note A - Description of Plan (continued):**

**Participant Accounts** - Each participant's account is credited with the employee's contribution, the Company's matching contribution, Plan earnings, and administrative fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are fully vested in the value of their contributions plus actual earnings thereon at all times. Participants vest in the value of the Company's matching contributions ratably over five years.

**Forfeitures** - The Plan permits the Company to first reduce administrative expenses with forfeitures, which represent the unvested portion of accounts for participants who terminated employment with the Company, and then any remaining amounts can be used to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$30,000 and \$18,000 respectively. In 2024, forfeitures of \$37,416 were used to reduce administrative expenses.

**Benefit Payments** - Individual accounts can be distributed upon the death, disability, retirement or termination of employment of the Plan participant. In-service distributions are available as long as the participant has attained the age of 59 ½. If the participant's account balance is greater than \$5,000, the participant has the option to remain in the Plan or to receive a distribution of their account balance in the form of either a lump-sum distribution, individual retirement account or various annuity payments. If the participant's account balance is \$5,000 or less, the account will automatically be distributed in the form of one lump sum payment. In April 2024, the threshold for automatic distribution of a participant's account balance was increased to \$7,000. Subsequent to year end, the threshold was reduced back to \$5,000. In the event of an immediate and heavy financial burden, the Plan also permits a hardship withdrawal of a participant's deferral contributions, including any applicable taxes and penalties, up to an amount required to alleviate the hardship.

**Note B - Summary of Significant Accounting Policies:**

The financial statements of the Plan have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America. The following are the significant accounting policies followed by the Plan:

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make significant estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from these estimates.

**Contributions** - Employee contributions and company matching contributions are recognized as additions to Plan assets in the year designated by the employee.

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value (Note E). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis, and dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses on mutual funds includes the Plan's gains and losses on mutual funds bought and sold as well as held during the year.

**Benefit Payments** - Benefits are recorded when paid.

**Corrective Distributions** - Amounts payable to participants for contributions in excess of amounts allowed by IRC are recorded as a liability with a corresponding deduction in net assets recognized in the statement of changes in net assets available for benefits. At December 31, 2023, the liability was \$24,516, which was distributed to the applicable participants in 2024. There was no such liability at December 31, 2024.

**Note B - Summary of Significant Accounting Policies (continued):**

*Expenses* - A portion of the expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees relating to certain participant selected managed account services are paid by the Plan.

*Subsequent Events* - Management has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

**Note C - Tax Status:**

The Internal Revenue Service has determined by a letter dated December 5, 2023 that the prototype plan used to set the guidelines of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), as amended, and the regulations thereunder, and the Plan is thereby tax-exempt within the meaning of Section 501(a) of the IRC. Although the Plan has been amended, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable authorities. The Plan's tax returns for 2021, 2022, and 2023 are subject to examination by the taxing authorities, generally for three years after they were filed.

**Note D - Investments (Certified):**

For the years ended December 31, 2024 and 2023, the Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Empower Trust Company, LLC, the Trustee, as complete and accurate, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental schedule:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment earnings as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

Investments in the fixed annuity fund and mutual funds are recorded at fair value as described in Note E. Changes in the market value of mutual funds are recorded as gains or losses.

The statements of net assets available for benefits present the fair value of all investment contracts. The statement of changes in net assets available for benefits is prepared on the fair value basis as there are no investments held at December 31, 2024 in fully-benefit responsive investments which are required to be reported at contract value.

The Plan invests in a variety of mutual funds and a fixed annuity fund. The investment strategies of these mutual funds vary among growth, income and equity objectives. A prospectus describing each mutual fund is available from the plan administrator. The investment strategy of the fixed annuity fund is to seek consistent returns to support a competitive credited rate.

**Note E - Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, “*Fair Value Measurements and Disclosures*,” establishes a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs into three broad levels. Level 1 inputs are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are inputs other than quoted prices for similar assets in active markets or inputs that are observable for the asset, either directly or indirectly through market corroboration, for substantially the full term of the asset. Level 3 inputs are unobservable and significant inputs developed by the plan sponsor based on the best information available about the assumptions market participants would use in pricing the asset. A financial asset’s classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used in measuring Plan assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds** - Determined based upon the net asset value of shares held by the Plan and normally calculated as of the close of business on the New York Stock Exchange. The mutual funds held by the Plan are deemed to be actively traded.

**Fixed Annuity Fund** – Determined based upon all contributions made by or on behalf of the participant to the fund, plus all interest credited to the fund on an annual effective basis pursuant to the guaranteed interest rate applicable, less any amounts transferred or distributed from the fund, less any applicable charges.

**Note F - Party-in-Interest:**

The Plan’s assets invested in the fixed annuity fund is maintained by Empower Trust Company, LLC. Transactions executed in this account are party-in-interest transactions. Fees relating to certain participant selected managed account services are paid by the Plan. These fees paid by the Plan for advisory services, management services, and third party administration totaled \$76,385. These transactions qualify as party-in-interest transactions and are exempt from the IRC and ERISA’s rules on prohibited transactions.

**Note G - Plan Termination:**

Although there is not a present intent to do so, the Company has reserved the right to terminate or partially terminate the Plan. In the event of Plan termination, all participants will become fully vested in any funds which have been allocated to them.

**Note H - Plan Amendments:**

During 2024, the Plan was amended to remove Pegula Sports & Entertainment, LLC as a participating employer and for the conversion of East Management Services, L.P. to East Management Services, LLC.

During 2023, the Plan was amended for employees hired on or after January 1, 2023. Changes included the elimination of the requirement to complete 500 hours of service in a 6 consecutive month period, or 1 year of service, in order to become eligible to participate, and the implementation of an automatic deferral provision at 2% of eligible compensation for each payroll period.

**Note I – Risks and Uncertainties:**

Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note J – Subsequent Events:**

The Plan was amended to add certain withdrawal provisions of the SECURE 2.0 Act effective January 1, 2025. Additionally, the Plan was restated effective January 1, 2025. There were no significant changes to the restated Plan.
