Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Premier Banks Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Premier Banks Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Premier Banks Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following description of Premier Banks Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General Information

The Plan is a defined contribution plan which was established on December 8, 2022. The Plan covers substantially all employees of Premier Bank and Premier Bank Minnesota (the Companies) who have met the eligibility requirements as defined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Contributions

All employees of the Companies who have thirty days of service are eligible to participate in the elective deferral portion of the plan. Each year, participants may contribute from 1% to 100% of pretax compensation (or post-tax compensation for the Roth portion of the 401(k) plan) not to exceed the limits of the Internal Revenue Code (IRC), as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are also eligible to make catch-up contributions in any amount up to the limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2024, the Plan includes a provision for automatic salary deferrals. Absent an election otherwise, 6% of each eligible participant's compensation is contributed to the Plan as an employee deferral. Each subsequent Plan year, again absent an election otherwise, a participant's deferral in the Plan under the auto-enrollment feature is increased by 1%, subject to a cap of 10% of the participant's eligible compensation.

The Companies may contribute a nonelective contribution to the Plan. To be eligible to receive the nonelective contribution, a participant must have been employed for one year during which they completed at least 870 hours of service. The Companies' nonelective contribution, if any, is allocated to participants eligible to share in the contribution based upon a percentage calculated by dividing the participant's eligible plan compensation by the total eligible plan compensation of all eligible participants. Participants direct the investment of their nonelective contributions into various investment options offered by the Plan. The Companies' contributions do not exceed the maximum amount deductible by the Companies under the regulation of the IRC.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Participant Accounts

Each participant's account is credited with the participant deferrals, employer nonelective contribution and an allocation of Plan earnings. Allocations of plan earnings are based on the valuation of the investments (participant-directed) held in each participant's account. Participant's accounts are valued on a daily basis. The benefit the participant is entitled to is the benefit that can be provided from the participant's account.

Notes Receivable from Participants

The Plan does not allow for participants to borrow from their fund accounts.

Vesting

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Vesting in the Companies' nonelective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service, with one year of service equal to 870 hours. A participant is fully vested in their account after 6 years of service, upon reaching age 60 (with at least five years of employment after first becoming eligible to participate in profit sharing contributions), upon death or upon permanent disability. Termination of employment before any of the above occurs activates the following vesting schedule for the profit sharing portion of their accounts:

Forfeited Accounts

Terminated participants forfeit their non-vested balance upon the earlier of the receipt of their vested benefits or after incurring five consecutive one-year breaks in service. Forfeitures are used for paying reasonable Plan expenses and any remaining forfeitures at the end of the Plan year are allocated to the remaining eligible participants' accounts based upon a formula as defined in the plan document.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Forfeited Accounts (continued)

Forfeitures for the years ended December 31, 2024 and 2023 were \$44,745 and \$51,350, respectively. Forfeitures in the amount of \$46,159 and \$29,975 were used to pay plan expenses during the years ended December 31, 2024 and 2023, respectively. Forfeitures in the amount of \$82,369 were allocated to remaining eligible participants' accounts during the year ended December 31, 2024. There were no amounts allocated to remaining eligible participants' accounts during the year ended December 31, 2023. There were no unallocated forfeitures as of December 31, 2024. There were unallocated forfeitures in the amount of \$82,369 as of December 31, 2023.

Payment of Benefits

Upon termination of employment, death, disability or retirement, participants may receive the value of the participant's vested interest in the form of a lump sum payment or if the balance exceeds \$7,000, elect to defer the benefit payment in accordance with Plan guidelines. If the participants' vested account balance is less than \$7,000 and the participant fails to make an election regarding their account balance, the Plan will distribute their vested account balance in a lump-sum payment to an Individual Retirement Account for the benefit of the participant.

The Plan also allows for early retirement distributions at the later of age of 60 or the tenth anniversary of the year in which the participant commenced participation in the Plan.

Benefit payments are recorded upon distribution to participants.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

Administrative Expenses

Administrative expenses paid by the Plan during the years ended December 31, 2024 and 2023 were for management of certain Plan investments. These expenses are included on the statements of changes in net assets available for benefits.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

2. Certification of Investments

The Board of Trustees has appointed The Standard Insurance Company and Principal Life Insurance Company as custodians of the Plan's assets. The custodians have supplied the plan administrator with certifications as to the completeness and accuracy of Plan investments aggregating \$30,826,382 and \$25,833,543 as of December 31, 2024 and 2023, respectively, and the related investment income of \$3,592,107 and \$2,965,471 for the years then ended. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule of the Plan based on such certifications from the custodians.

3. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

3. Fair Value Measurements (Continued)

The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts are valued based upon the unit value of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although they are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Concentration Risk

Individual investments representing 20% or more of the Plan's total investments subject the Plan to potential concentration risk. As of December 31, 2024 and 2023, the investment over the 20% threshold was as follows:

5. Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

6. Plan Tax Status

The Companies have adopted an individually designed plan document, which has received an opinion letter from the Internal Revenue Service stating that the plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Plan management evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, Plan management does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal tax returns generally remain open for the last three years.

7. Risk and Uncertainties

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Party-In-Interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists.

The Standard Insurance Company and Principal Life Insurance Company are the custodians of the Plan's assets and manage certain Plan investment transactions; therefore, the transactions qualify as party-in-interest transactions and are indicated as such on the supplemental Schedule of Assets Held at End of Year. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

For a portion of 2023, the Companies were parties-in-interest as defined by ERISA, as a result of holding deposits on behalf of the Plan. However, such transactions are specifically exempted and are not prohibited by ERISA as the Companies are banking institutions that are supervised by federal and state agencies.

Additionally, certain employees of the Companies provide certain accounting and administrative services to the Plan for which no fee is charged. These transactions are also permitted under ERISA regulations.
