Note 1. Description of the Plan

General

The following description of Heaven's Hands Community Services, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Heaven's Hands Community Services, Inc. (the Sponsor) for the benefit of its employees. Employees become eligible to participate on January 1, April 1, July 1, or October 1, immediately following employment.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC serve as the custodians of the Plan.

Contributions

Participants may contribute a percentage or specific dollar amount of their annual compensation, as defined, subject to certain IRS limitations. Participants who attain age 50 by the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts distributed from other qualified plans.

The Plan provides for safe harbor contributions. The contribution is a mandatory safe harbor matching contribution and is given to all eligible employees. The Plan Sponsor will match 100% up to 6% of the employee's eligible compensation.

At its discretion, the Sponsor may contribute employer profit sharing contributions to the Plan for each employee that meets the eligibility requirements. During the plan years ended 2024 and 2023, the Plan Sponsor elected not to make a discretionary contribution to the Plan.

Participant Investment Account Options

Each participant has the option of directing contributions into any of the investment account options selected by the Sponsor and may change the allocation to the extent permitted by the individual agreements. A participant may suspend contributions at any time or may increase or decrease their level of participation monthly.

Participant Accounts

Each participant's account is credited with the participant's pre-tax and post-tax contributions, the Sponsor's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and employer safe harbor contributions plus earnings thereon. Vesting in the Plan Sponsor discretionary contributions are in accordance with the following vesting schedule:

Notes Receivable from Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms range from one to five years unless they are used to purchase a primary residence. The interest rate is 1% over the prime rate as published by Wall Street Journal. All loans are considered a direct investment of the participant, and payments of principal and interest are credited to the participant's account. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

During employment, a participant may make withdrawals of vested amounts in the instances of hardship, death, or disability. After attaining age 59-1/2, participants may elect to withdraw an amount equal to any whole percentage not to exceed 100% of the participant's vested account for any reason. In the event of termination of employment, a participant shall receive, as a lump-sum distribution, their participant contributions, and earnings thereon and vested employer contributions and earnings thereon.

Forfeited Accounts

Forfeited accounts may be used to offset plan expenses or to reduce future employer contributions to the Plan. In 2024 and 2023, there were \$19 and \$0 of forfeitures used, respectively. There were no balances as of December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Fair value measurements are discussed further in *Note 6*.

The fair value of guaranteed investment contracts (excluding fully benefit-responsive investment contracts) are calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Sponsor or the Plan, at the Sponsor's discretion.

Note 3. Certification of Plan Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

The custodian has not certified to the completeness and accuracy of certain investments of the Plan held by another financial institution as of December 31, 2024 and 2023 in the amounts of \$8,511 and \$7,865, respectively.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are managed by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC, the custodians of the Plan. These transactions qualify as party-in-interest transactions. Loans to participants which are secured by the balances in the participant accounts are permitted party-in-interest transactions. In addition, the Plan has certain investment related expenses, which have been offset by investment income.

Total administrative fees to affiliates of the custodians of the Plan were \$8,836 and \$7,806 during the years ended December 31, 2024 and 2023, respectively. The Sponsor provides certain administrative services at no cost to the Plan.

Note 5. Plan Amendments

Effective February 1, 2023, the Plan was amended to allow mandatory cash outs for benefits of \$5,000 or less.

Note 6. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to participants' accounts shall be 100% vested and non-forfeitable. All participants shall receive a total distribution of their accounts as described in the Plan. Any amount in the forfeiture account upon termination, which has not been applied, shall be allocated on a pro rata basis to the participant's account.

Note 8. Tax Status

The Plan operates under a volume submitter agreement in connection with a volume submitter plan sponsored by DATAIR Employee Benefit Systems, Inc. This volume submitter Plan Document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Subsequent Events

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.
