Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the LifeStream Services, Inc. Retirement Savings Plan (the "Plan") have been prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition

Certain investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Expenses

Certain expenses of the Plan were paid by LifeStream Services, Inc. (the "Company") and accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation in fair value of investments.

Related Party Transactions

Certain plan assets are in investment funds managed by American United Life Insurance Company (AUL) or its affiliates. AUL is the trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions.

Several employees of Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the service of the employees to the Plan.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Payments of Benefits

Benefits are recorded when paid.

Subsequent Events

In preparing its financial statements, the Plan has evaluated events subsequent to the balance sheet date through August 28, 2025, which is the date the financial statements were available to be issued.

NOTE 2 GENERAL DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was adopted by LifeStream Services, Inc., effective May 1, 1990, and most recently restated on November 13, 2019. The Plan is a defined contribution plan. Employees are eligible to make elective deferrals beginning on their date of hire. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). Effective on January 1, 2024, the Plan was restated in its entirety and amended to allow for post-tax salary deferral contributions.

Contributions

Participants may voluntarily make deferral contributions to the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For December 31, 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution under the Plan. The Company has elected to make a matching contribution in an amount equal to 200% of each participant's elected deferrals, up to a maximum amount equal to 6% of the participant's salary for each pay period during 2024.

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and the Company's contribution, and an allocation of the Plan earnings. Allocations of plan earnings are based on the participants' balances in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon a participant's retirement after age 65, death, disability, or other termination of employment with the Company, a participant may receive their benefit in a lump-sum or annuity.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits in a lump sum payment.

In conditions of "financial hardship" a participant may apply to the Plan administrator for approval to withdraw that portion of their deferral account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Vesting

Participants are immediately vested in their voluntary contributions. Vesting in matching contributions is based on a five-year scale. Participants become fully vested in these accounts after five years of service.

Forfeited account balances are applied to reduce employer contributions. During December 31, 2024, forfeitures in the amount of \$28,869 were used to offset employer contributions. The balance of unallocated forfeitures was \$-0- and \$2 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their respective accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Loan terms range from one to five years or beyond five years, as agreed upon by the participant and the loan administrator, for the purchase of a primary residence. Principal and interest is paid ratably through semimonthly payroll deductions.

NOTE 3 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has entered into investment contracts with AUL to maintain contributions in a general account. During 2021, the contract was amended to freeze the fixed interest fund and add the stable value fund. At December 31, 2024 and 2023, the contract value of this fixed interest account is \$560,595 and \$580,801, respectively. At December 31, 2024 and 2023, the contract value of the stable value fund is \$242,593 and \$207,505, respectively. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

The general account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The minimum crediting interest rate under the contract is equal to the annual effective interest rate.

Interest rates are established and declared for new contributions that will be received in a calendar quarter. The stable value rate is based on current market conditions. The crediting rate will always equal or exceed the contractually guaranteed rate.

Liquidation of the entire contract may cause a one-time adjustment to the aggregate contract value, limiting the ability of the Plan to transact at contract value with AUL. This total liquidation is a contingent event, which cannot be initiated by the Plan participants and can only be initiated by the Plan trustee upon termination of the Plan or complete termination of the contract. The occurrence of these events that may limit the ability of the Plan to transact at contract value is not probable.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS OF PLAN

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (“IRC”). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan Administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b).

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
