Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of National Wildlife Federation Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about National Wildlife Federation Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of National Wildlife Federation Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about National Wildlife Federation Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion —

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the National Wildlife Federation Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 403(b) of the Internal Revenue Code (IRC) established by National Wildlife Federation (NWF) on July 1, 1982. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by an NWF employee who has been appointed by the NWF Board of Directors. The NWF Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reviews new and upcoming regulations.

Plan assets are held and managed by Principal Trust Company and Principal Life Insurance Company serves as the plan recordkeeper (collectively, "the custodian" or "Principal").

Eligibility

The Plan covers all employees of NWF who normally work 20 hours per week or more, except for enrolled students or interns. Eligible employees may enter the plan immediately following or coincident with the date they meet the eligibility requirements.

Contributions

Participants may contribute on a pre-tax or after-tax basis up to 100% of their annual eligible compensation, as defined in the Plan, subject to the statutory limitations established by the Internal Revenue Code (IRC). The after-tax "Roth" contributions are subject to federal income taxes in the year of deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans referred to as rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a fully benefit responsive guaranteed investment contract as investment options for participants.

NWF matches participant contributions up to 3% of a participant's base compensation for less than three years of continuous service; matches up to 4% of a participant's base compensation for at least three but less than five years of continuous service; and matches up to 5% of a participant's base compensation for five or more years of continuous service. NWF also provides a non-elective employer contribution of 2% of year-end eligible earnings for all eligible employees, as defined in the Plan document. During the years ended December 31, 2024 and 2023, NWF made matching contributions (net of forfeitures) to the Plan in the amount of \$1,318,333 and \$1,291,945, respectively, and non-elective employer contributions in the amount of \$768,825 and \$703,066, respectively.

Participant Accounts

Each participant’s account is participant-directed and is credited with the participant’s contribution and allocations of NWF’s contributions, if any, and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant investments held, account balances, or specific participant transactions, as defined. Plan participants have daily access to their account via phone or internet and may change the allocation of their investments to any of the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

The current value of the Plan’s assets attributable to the individual participant’s contribution portion and NWF’s matching contribution portion of the participant’s account is 100% vested at the date contributed to the Plan. Vesting in the non-elective NWF contributions is based on years of vested service. Generally, an employee is credited with one year of service for each Plan year during which he or she works at least 1,000 hours. Regardless of years of service, participant accounts are 100% vested when the participant reaches normal retirement age, becomes permanently disabled, or dies.

Notes Receivable from Participants

Participants in the Plan may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their eligible account balance, reduced by any outstanding note balance. The notes are secured by the balance in the participant’s account and bear interest at reasonable rates as determined by the plan administrator based on the prevailing rates. The maximum duration of a loan is not to exceed five years for general purposes and up to 15-years for the acquisition of a primary residence. Participants may have two outstanding loans at any time. Principal and interest are paid ratably through regular payroll deductions. Interest rates on outstanding loans at December 31, 2024 and 2023 ranged from 4.25% to 9.50%.

Payment of Benefits

Upon termination of service due to retirement, death, full and permanent disability or attaining age 65, participants may elect to receive either a lump-sum amount equal to the value of their account, installments, a direct rollover into a qualified retirement plan, in the form of an annuity or a combination of cash and direct rollover distribution. For termination of service due to other reasons, participants may receive their benefits in the form of a distribution equal to the value of the vested interest in their account. The Plan allows in-service withdrawals at age 59 1/2 and hardship withdrawals under certain circumstances, as defined in the Plan document.

Forfeitures

Forfeitures of nonvested balances of terminated participants may be used to pay administrative expenses or reduce employer contributions. At December 31, 2024 and 2023, unallocated forfeitures totaled \$29,391 and \$74,570, respectively. During 2024 and 2023, the Plan used \$31,359 and \$3,409, respectively to pay Plan expenses and \$118,980 and \$3,828, respectively to reduce employer contributions to the Plan.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting standards generally accepted in the United States of America (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts (FBRIC). Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to FBRIC because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for FBRIC, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly

transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions

Contributions from Plan participants and the associated employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

Administrative Expenses

Administrative expenses may be paid either by the Plan or directly by the plan sponsor. The Plan is not required to reimburse the plan sponsor for expenses paid on behalf of the Plan. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

The Plan has an agreement with the Plan custodian for maintaining an ERISA Budget account (revenue credit account), funded with excess revenue generated by the Plan in the form of a plan servicing credit and other adjustments. Revenue credit funds received are reported as "other income" in the statements of changes in net assets available for benefits and are used to pay general Plan administrative expenses. Any remaining amount in excess of expenses, is allocated to plan participants as a fee adjustment (expense credit). At December 31, 2024 and 2023, the balance available to offset future expenses totaled \$196 and \$193, respectively. During 2024 and 2023, the Plan received \$60,749 and \$-0-, respectively, in the ERISA Budget account. Plan expenses totaling \$29,173 and \$-0-, respectively, were paid from revenue sharing funds.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified by Principal Trust Company (“Principal”, the custodian of the Plan), as complete and accurate in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

The fair values are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT - FBRIC

The Plan participates in a fully benefit-responsive investment contract (FBRIC) with Principal. The FBRIC is a single group annuity contract with a fixed rate of interest. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Under the terms of the existing contract, the crediting interest rate is based on a formula agreed upon with the issuer. Principal determines the guaranteed minimum interest rate for each set of guaranteed interest balances by taking the dollar-weighted average of the guaranteed minimum reference rates for all the guaranteed interest balances and rounding this amount to the nearest 0.05%. The dollar-weighted average of the guaranteed minimum reference rate uses the account values of each guaranteed interest balance as of the last day of the month prior to the date the composite crediting rate is calculated. In no case will the guaranteed minimum interest rate be less than 0.15% or greater than 3%. The guaranteed minimum reference rate is the average of 5-year Constant Maturity Treasury Rates in effect 12 months prior to the date the guaranteed interest balance is established reduced by 1.25%. Principal determines the guaranteed minimum reference rate for each guaranteed interest balance at the time the guaranteed interest balance is established and state the guaranteed minimum reference rate in the applicable rate schedule. In no case will any guaranteed minimum reference rate be less than 0.15% or greater than 3%. The guaranteed minimum reference rate is used to calculate the guaranteed minimum interest rate and does not affect the guaranteed interest rate for any guaranteed interest balance.

Benefit payments to participants for plan benefit events, including retirement, termination of employment, disability, plan termination, death, loans, withdrawals including participant-directed transfers, as allowed by the plan, are made without any surrender charge or early termination charge. Upon a plan fiduciary-directed contract termination, the plan interest will be paid out in six installments (subject to additional contractual limitations that may result in a surrender charge equal to 10% of the cumulative investment transfer amount). The first installment payment will be made six months after the notice to terminate. Each of the following five installment payments will be made on the anniversary of the first payment date. Plan activity prior to, and during, the installment payment period, will affect the amount paid on installment payment dates. During the installment payment period benefit payments will continue to be made and participant investment transfers out of the FBRIC may be allowed, subject to the recordkeeper's ability to enforce an equity wash when competing options are available. Alternatively, the authorized plan representative may elect an accelerated payment instead of installment payments after providing notice to terminate the contract and have the Plan interest paid as a single sum subject to an early termination charge (could be 0%) and may be billed to the Plan sponsor or deducted from the Plan interest.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The FBRIC is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by issuer, represents

contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at account value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any interest to do so, NWF has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will be distributed in accordance with the Plan agreement.

NOTE 7 - TAX STATUS

The Plan and related trust are designed in accordance with Section 403(b) and 403(b)(7) of the Internal Revenue Code (IRC). The Plan has adopted a 403(b) volume submitter plan sponsored by Principal Life Insurance Company. The prototype 403(b) plan has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, which states that the prototype 403(b) plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 - TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan's assets include investments in funds managed by the Plan's custodian and recordkeeper Principal Trust Company and Principal Life Insurance Company, respectively. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the plan.

There were no financial transactions recorded between the Company and the Plan other than contributions made. Notes receivable from participants also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

Effective March 1, 2025, the Plan documents were amended to change the non-elective employer contributions from 2% to a discretionary percentage as determined by the Plan sponsor.

Subsequent events have been evaluated through September 5, 2025, which is the date the financial statements are available to be issued.
