We have performed audits of the accompanying financial statements of Port Amherst, Ltd. 401(k) & Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Port Amherst, Ltd. 401(k) & Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1 – Plan Description

The following description of the Port Amherst, Ltd. 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all of the employees of Port Amherst, Ltd. and its subsidiaries (collectively referred to as the "Company") who have six months of service and are the age of eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make contributions to the Plan by deferring salary of an amount equal to at least 1%, but not more than 90%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Post-tax Roth contributions are also allowed under the Plan.

The Company matches participant contributions up to a maximum of 4% of each participant's compensation, as determined by the Company's Board of Directors. The Company may also make additional discretionary contributions to the Plan for all eligible participants at the option of the Company's Board of Directors. No additional discretionary contributions were made for the years ended December 31, 2024 and 2023. The discretionary contribution is only made to those employees still employed with the Plan Sponsor as of the last day of the Plan year. Participants may also contribute rollover distributions from other qualified retirement plans.

Effective January 1, 2019, the Plan was amended and restated to adopt a safe harbor provision under which the Company is required to match 100% of the first 4% of each participant's compensation contributed, and participants will be immediately vested in such matching contributions.

Participant Accounts

Each participant's account is credited with the participant's and employer's contributions and allocations of the Plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their employee contributions plus actual earnings thereon. As of January 1, 2019, employer contributions are vested immediately. Prior to January 1, 2019, vesting in the employer contribution portion of their accounts plus earnings thereon is based on years of credited service as follows:

After 2 years of service	20% vesting
After 3 years of service	40% vesting
After 4 years of service	60% vesting
After 5 years of service	80% vesting
After 6 years of service	100% vesting

Forfeited Accounts

If a participant is separated from service and is not fully vested, the non-vested portion of the participant's account balance is forfeited. If a former participant takes a distribution of his or her partially vested balance, the forfeited amount will be used in the following Plan year. If the former participant does not take a distribution of his or her partially vested balance, the forfeited amount will be used during the Plan year following the Plan year during which the former participant incurs his or her fifth consecutive one year break in service. Forfeitures are applied to reduce future employer contributions. As of December 31, 2024 and 2023, the balance of unallocated forfeitures was \$4,459 and \$3,975, respectively. During 2024 and 2023, no forfeitures were applied to reduce employer contributions.

Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance, an annuity, or a combination of these, depending upon marital status and participant elections. Married participants may elect to receive a joint and survivor annuity. Participants meeting specified criteria may also receive in-service and hardship distributions.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The date through which events occurring after December 31, 2024, have been evaluated for possible adjustment to or disclosure in the financial statements is October 8, 2025, which is the date the financial statements were available to be issued.

Note 4 – Fair Value Measurements

The framework for measuring fair value establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs to the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued based on quoted net asset values of the shares held by the Plan at year end.

Stable value common trust fund: The net asset value (NAV), as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an

amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Party-in-Interest Transactions

Certain administrative functions are performed by employees of the Company. These employees are also Plan participants. No such employee receives compensation from the Plan.

The Company pays certain administrative expenses on behalf of the Plan, including legal, trustee, accounting, and insurance fees.

Plan participants invest in funds held or managed by the Plan Trustee, T. Rowe Price Trust Company, as well as other investment management companies. Investments in funds issued and managed by the Trustee are considered party-in-interest transactions. Fees paid to the Trustee by the Plan for administrative services were \$53,132 and \$52,648 during 2024 and 2023, respectively.

Plan participants are charged a quarterly fee based on a percentage of their account balances to cover Plan recordkeeping services provided by the Trustee. In addition, the Trustee earns administrative fees directly from certain mutual funds in which Plan assets are invested, which are included as operating expenses of the mutual funds. Participants with amounts

invested in these mutual funds receive fee credits allocated to their accounts on a quarterly basis to offset the charges flowing directly through the mutual funds. During 2024 and 2023, fee credits were \$49,804 and \$44,991, respectively.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Plan was restated and amended effective January 1, 2022, to a non-standardized, pre-approved plan sponsored by T. Rowe Price Retirement Plan Services, Inc. The Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Company has obtained the most recent favorable determination letter from the IRS dated August 19, 2020. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
