### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Cape Fear Orthopaedic Clinic, P.A. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("financial statements").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## Notes to Financial Statements

---

### 1. Description of Plan

The following description of the Cape Fear Orthopaedic Clinic, P.A. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan available to eligible employees of the Cape Fear Orthopaedic Clinic (the “Company” or “Employer”). To be eligible to participate in the Plan, an employee must have attained age 21 and completed one year of service. Employees may begin participation on January 1, or July 1, coinciding with or following the date they meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Company was acquired by Cape Fear Valley Health in October 2024. Effective May 31, 2025, the Plan terminated as a result of this acquisition, with liquidation of Plan assets expected to be completed in 2026.

#### **Contributions**

Participants may elect to contribute a percentage of their pre-tax and/or after-tax (“Roth”) compensation, as defined by the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained the age of 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). The Company makes a safe harbor matching contribution equal to 3% of each eligible participant’s compensation. The Company may also make additional discretionary matching contributions up to a maximum of 4% of the participant’s compensation, and/or a discretionary nonelective contribution, both of which are to be determined annually by the Board of Directors. No discretionary contributions were made during 2024.

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered through the Plan. Participants may change their investment options and deferral percentages at any time.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s and the Company’s contributions and an allocation of the Plan’s net earnings and administrative expenses. Allocations are based upon participant contributions, participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions and Company safe harbor matching contributions, plus any income or loss thereon. Company discretionary matching and nonelective contributions vest according to the following schedule:

### 1. Description of Plan (Concluded)

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive a lump-sum, or installment payments. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

#### ***Notes Receivable from Participants***

A participant may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms are generally up to five years, with the exception of borrowings for primary residences which can be up to fifteen years. The notes are secured by the vested account balance in the participant's account and bear interest at the prime rate plus 1% at the date of application. Participants may have two outstanding notes at a time. Principal and interest are paid ratably through payroll deductions.

#### ***Administrative Expenses***

The Company absorbs substantially all expenses incidental to the administration of the Plan, including internal administrative costs. Note receivable and distribution fees, as well as fees incurred from self-directed brokerage accounts ("SDBA"), are paid out of affected participant accounts.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared under the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through the Voya Retirement Insurance and Annuity Company ("Voya") Fixed Account. See Note 8.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

### 2. Summary of Significant Accounting Policies (Concluded)

#### ***Payment of Benefits***

Benefit payments to participants are recorded when paid.

#### ***Subsequent Events***

Management has evaluated events occurring subsequent to the date of the financial statements through October 9, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya.

SDBA of approximately \$5,644,000 and \$5,232,000 as of December 31, 2024 and 2023, and investment income including net appreciation in fair value of investments and interest and dividends of approximately \$382,000 for the year ended December 31, 2024 are not certified. See Note 10.

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Income Tax Status

The Plan has adopted a prototype non-standardized plan document sponsored by Trinity Pension Group, LLC ("Trinity"). The IRS has determined and informed Trinity by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC.

### 6. Plan Termination

The Company was acquired by Cape Fear Valley Health in October 2024. As a result, the Company terminated the Plan effective May 31, 2025, with liquidation of Plan assets expected to be completed in 2026.

### 7. Party-in-Interest Transactions

Certain plan investments are shares of mutual funds and a money market fund managed by Voya, the Plan's custodian and, therefore, these transactions qualify as party-in-interest.

Fees of approximately \$56,000 were paid for the maintenance of participant SDBA in 2024.

### 8. Investments at Contract Value

The Fixed Account is a group annuity contract issued by Voya from its general account. Principal and interest, minus any applicable fees, are guaranteed for the life of the contract. The contract is designed to be a long-term investment for participants seeking stability of principal and guaranteed minimum rates, featuring a current rate determined monthly that is guaranteed minimum not to be less than the floor rate declared each calendar year. The minimum crediting rate under the contract was 1.60% and 1.48% at December 31, 2024 and 2023. Transfers from the Fixed Account can be made at any time without limitations or restrictions to non-competing funds.

### 9. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurement***

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Self-directed brokerage accounts:* Comprised of primarily of cash and equivalents, common stocks, mutual funds and government securities. Mutual funds are valued at quoted market prices which represent the NAV of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market. Common stocks and government securities are valued at the closing price reported on the active market on which the securities are traded. These investments are classified within Level 1 of the valuation hierarchy.

*Mutual funds and money market funds:* Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common collective trust funds:* Valued at NAV as determined by the issuer based on the fair market value of the underlying investments, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
