Opinion on 2024 Financial Statements

We have audited the financial statements of CPT Employee Stock Ownership Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

1. Description of the Plan

The following description of the CPT Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

General

Effective January 1, 2023, Cast Net Holdings Co. established and adopted the Plan for its employees and their beneficiaries. The Plan is comprised of two portions: a stock bonus plan portion and a profit sharing plan portion, which taken together, comprise a single plan that qualifies as an employee stock ownership plan ("ESOP"). The stock bonus plan portion is intended to qualify under Sections 401(a), 409 and 4975(e)(7) of the Internal Revenue Code of 1986, as amended (the "Code"), and also constitutes an ESOP within the meaning of Section 4975(e)(7) of the Code and Section 407(d)(6) of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan is administered by an ESOP Committee consisting of one or more persons appointed by Cast Net Holdings Co. or its Board of Directors. An independent advisor serves as the trustee of the Plan ("Trustee").

On February 6, 2024, the Plan purchased 1,000,000 shares of common stock of the Company (defined below) with a loan of \$73,929,736 owed to the Company's former sole shareholder. See Note 6. The borrowing is collateralized by the unallocated shares of common stock. The lender has no rights against the shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024, and for the year then ended, present separately the assets and liabilities and changes therein pertaining to:

- a. the accounts of employees with rights in allocated common stock (allocated), and
- b. common stock not yet allocated to employees (unallocated).

Eligibility

Employees of Cast Net Holdings Co. and its wholly owned subsidiaries, H.F. Cox, Inc. and Cast Net Leasing CA, LLC (collectively referred to as the "Company"), are eligible to participate in the Plan upon meeting eligibility requirements. Employees of the Company who reached the age of eighteen (18) and were employed on February 6, 2024 became participants effective as of January 1, 2023. If not employed on February 6, 2024, employees of the Company are eligible to participate in the Plan after one year of service provided that they worked at least one thousand hours and have reached the age of eighteen (18) during such Plan year provided that he or she remains employed as of the last day of the Plan year.

Contributions

The Plan is noncontributory; the Company makes all contributions to the Plan. The Company's contribution, if any, is determined annually at the discretion of the Board of Directors. Except to the extent otherwise prohibited by applicable law, the contribution may be made in cash, in shares of Company Stock, or by the Company's payment of indebtedness owing by the Trust to any third party, or any combination of the foregoing. Company contributions to the Plan for the year ended December 31, 2024 consisted of \$4,976,309 in cash.

Participant Accounts

The ESOP Committee shall maintain a separate individual account for each participant. Each participant's account is credited as of the last of the Plan year with an allocation of (a) the Company's contribution, and (b) forfeitures of terminated participants' non vested accounts. Only those participants who are eligible employees of the Company on the last day of the Plan year will receive an allocation. Allocations are based on the ratio that the annual compensation for the Plan year of each participant eligible to share in the allocation bears to the total annual compensation for the plan year of all participants eligible to share the allocation.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, death or permanent disability, such participant will vest in the balance in their account based on total years of service with the Company as per the following vesting schedule:

Payment of Benefits

Distributions from the Plan are made in cash in either lump-sum or installments based on the participant's total vested account balance. Distributions on account of death, disability or retirement commence in the Plan year following the event. Distributions for other separations from service commence one year after the last day of the fifth Plan year following the Plan year in which the participant's employment terminates.

Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. There were no forfeitures during the year ended December 31, 2024.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The Company can pay for the purchase in a lump sum or over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age fifty-five with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to twenty-five percent (25%) of their account balance, less the amounts previously diversified. In the sixth year, the percentage changes to fifty percent (50%). Participants who elect to diversify receive a cash distribution.

Voting Rights

To the extent permitted by ERISA, all voting rights on shares of Company stock held by the Trust are exercised by the Trustee as directed by the ESOP Committee, unless directed by the participants acting in their capacity as named fiduciaries in accordance with the Plan document with respect to shares allocated to their individual accounts.

Termination or Modification of the Plan

The Company intends to maintain the Plan indefinitely. However, the Company reserves the right to amend or terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Accounts of the affected Participants will be valued as of the date of the termination and will become one hundred percent (100%) vested.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Allocations

The financial statements of the Plan present separately on the assets and liabilities and changes therein pertaining to (a) the accounts of employees' rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

Investments, comprised of shares of the Company's common stock, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of the Plan are paid by the Company and not included in the statement of changes in net assets available for benefits. Investment related expenses are included in net depreciation of fair value of investments.

3. Administration of Plan Assets

The Plan's assets, which will consist principally of the Company's common stock, are held by the trustee of the Plan. At December 31, 2024, the assets of the Plan were administered by the ESOP Committee.

The Company's contributions are held and managed by the Trustee, which invests cash received, interest and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the loan, which is reimbursed to the Trustee through contributions, as determined by the Company.

5. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Company stock: Determined by an annual independent appraisal.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management of the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Loan Payable – Related Party

On February 6, 2024, the Plan entered into an \$73,929,736 loan agreement with the Company. See Note 1. The proceeds of the loan were used by the Plan to purchase 1,000,000 shares of the Company's common stock. Unallocated shares held by the Plan are pledged as collateral for the loan. The loan is to be repaid in quarterly installments of principal and interest through maturity in February 2039. Interest is accrued annually at a rate of 8% commencing in March 31, 2024. The Plan is funded by contributions made by the Company in amounts sufficient to make its regularly scheduled payments of principal and interest on the loan. As of December 31, 2024, the outstanding balance of the loan is \$67,479,736.

7. Related Party and Party-in-Interest Transactions

The Plan invests in the Company's common stock. As described in Note 2, the Company may pay for expenses and fees incurred in the administration of the Plan. As described in Note 6, the Plan entered into a loan agreement with the Company. These are related party and party-in-interest transactions. The Plan also has service providers, including a recordkeeper, which are parties-in-interest under ERISA.

8. Risks and Uncertainties

The Plan's investments consist of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with the investment in the Company's common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the Company's common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

9. Reconciliation of Financial Statements to Schedule H of Form 5500

Net assets available for benefits at December 31, 2024 and the statement of changes in net assets available for benefits for the year ended December 31, 2024, as reported in the accompanying financial statements, are consistent with amounts reported in Schedule H of the Form 5500.

10. Income Tax Status

The Plan has not obtained a tax determination letter from the Internal Revenue Service ("IRS"). However, the Company believes that the Plan and related trust are currently designed and being operated in accordance the applicable requirements of the Code. See Note 11.

GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

11. Subsequent Events

The IRS has determined and informed the Company by letter dated May 22, 2025, that the Plan and the related trust are designed in accordance with the applicable sections of the Code. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Management has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued. There were no other material subsequent events that required recognition or additional disclosures in these financial statements.
