Report on the Financial Statements

Opinion

We have audited the accompanying financial statements of ASM Research, LLC Health & Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of the Plan's benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits and of changes in Plan's benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and of the Plan's benefit obligations of ASM Research, LLC Health & Welfare Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and of changes in the Plan's benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of ASM Research, LLC (the Company) Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan and Trust were established July 1, 2021 to provide health and other benefits to eligible participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Employees are eligible to participate in the Plan on the first day of the month following one month of continuous employment.

Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management makes contributions to the Plan on their behalf. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

The Company makes monthly contributions for participating employees covered under the Plan. For employees covered under contracts issued by federal, state, municipal or other contracting authorities which require the payment of specified fringe dollar amounts, the Company contributes to the Plan based upon an hourly funding formula. Company contributions are recognized as income in the month the employees worked. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis. In addition to deductibles and copayments, participants may contribute specified amounts to extend coverage to their eligible dependents.

Benefits

The Plan provides dental, vision, life insurance, accidental death and dismemberment, short and long term disability, telemedicine service, and employee assistance programs for eligible participants and their beneficiaries. The Plan provides these benefits through various annual contracts with insurance companies. Premiums for these insured benefits are paid to the insurance companies directly from the assets of the Plan. The Plan provides medical and prescription drug coverage benefits on both a level-funded basis and through contracts with insurance companies, depending upon participant classification. The Plan carries a stop-loss insurance policy which covers aggregate claims in excess of the funding factor as specified in the contract.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Health Reimbursement Arrangement

The Plan has a HRA that is funded solely through Company contributions on a per employee per month basis. The contributions are deposited into a claims reimbursement allotment from which the HRA administrator reimburses eligible participants for qualified medical expenses subject to a specified ceiling. Amounts remaining in the claims reimbursement allotment account at the end of the policy period (policy period is July 1, 2023 through June 30, 2024) are subject to administrative and guarantee fees paid to the claims processor and 80% of any leftover amount is returned to the Plan. As of December 31, 2024, \$7,072 was due to the Plan for the policy period of June 30, 2024.

Retirement Plan Contributions

Participants could opt out of some plan benefits and have their contribution allocated to ASM Research LLC 401(k) Plan. After subtracting premiums and fees incurred by the Plan, the Plan forwards the excess contributions to the Company's retirement plan. The retirement plan payable represents excess contributions received from the Company that have not been forwarded to the Company's retirement plan by the end of the year. For the year ended December 31, 2024 total retirement plan contributions totaled \$286,193. Retirement plan contributions payable as of December 31, 2024 and 2023 were \$87,821 and \$44,007, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Concentration of Credit Risk

The Plan maintains its demand deposits in commercial bank accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan management does not believe the Plan was exposed to any significant credit risk on cash.

Contributions Receivable

Company contributions due but not paid at year-end are recorded as contributions receivable. There was no allowance for uncollectible accounts as of December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Pre-funding Contributions

The prepaid contributions (liability) represent the initial deposit paid by the Plan sponsor and subsequent funding that exceeded their contracted obligation to the Plan. This liability will be used in subsequent years as a "premium holiday" based on available funds to pay benefits as they come due. The Plan sponsor is ultimately liable to fund any deficiency in the Plan's obligations.

Insurance Premiums Payable

Insurance premiums payable are based upon the actual premiums due for December 31, 2024 and 2023, but paid by the Plan after year-end.

Payment of Benefits

Premiums paid by the Plan are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Benefits are recorded when paid.

Administrative Expenses

All administrative expenses may be paid out of the Plan unless paid by the Company. During the year ended December 31, 2024, the Plan paid for substantially all administrative expenses, which consisted of administration fees, accounting fees, and other miscellaneous expenses.

Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes. The Plan was required to pay federal and state taxes on unrelated business income as defined by Internal Revenue Code Section 512(e)(3)(E). Unrelated business income consists of the investment income earned on the excess of the net assets available for benefits over the required reserve balance allowable under the Internal Revenue Code. The Plan administrator believes the Plan does not have any net taxable income for the years ended December 31, 2024 and 2023; therefore, no tax liability was reflected in these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

NOTE 3 TAX STATUS

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

NOTE 4 PLAN TERMINATION

The Plan shall remain in existence from year-to-year unless written termination notice is given by the Plan management or Plan administrator to the other at least 60 days prior to the anniversary date of effective coverage under the Plan.

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 5 EXCESS LOSS COVERAGE

The Plan has entered into an excess loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The Plan maintained insurance policies with Fidelity Select Life Insurance Company (FSLI) for the period from July 1, 2021 to June 30, 2024. The policies provide reimbursement to the Plan for claim amounts paid in excess of the monthly funding factor for each participant. FSLI has set a limit of \$1,000,000 as the maximum reimbursement amount during the policy coverage period. The insurance companies are responsible for paying claims incurred in excess of the funding factor account balance. The funding factor account balances totaled(\$1,022,995) and \$(272,041), as of December 31, 2024 and 2023, respectively. The negative cash position in the funding factor account balance at December 31, 2024 and 2023, was reimbursed by the insurance company through cash calls in the subsequent years.

The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants from Plan assets and the Plan is subsequently reimbursed by the insurance company if the funding factor is exceeded. As of December 31, 2024 and 2023, there are reimbursements due from the insurance carrier totaling \$916,512 and \$272,041, respectively. These reimbursements due from the insurance carrier are presented as stop loss receivable in the accompanying statements of net assets available for benefits.

NOTE 6 RISKS AND UNCERTAINTIES

The estimate for claims incurred but not reported is based on certain assumptions pertaining to claims lag and historical claims data. The liability recorded is the Plan's maximum exposure to the claims incurred but not reported. Should the Plan's claims be lower than the amount deposited into the funding factor account, the Plan may be entitled to the residual balance in the funding factor account. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 8 SUBSEQUENT EVENT

ASM Research, LLC (ASM)'s parent company, Accenture Federal Services (AFS), acquired Cognosante LLC in 2024. As a result of the acquisition, a portion of Cognosante LLC's employees, including their entire Service Contract Act (SCA) employee population, became employees of ASM effective January 1, 2025.

These SCA employees also became participants of the ASM Research, LLC Health & Welfare Plan effective January 1, 2025. In addition, the remaining assets in the Cognosante LLC Fringe Benefit Trust were transferred to ASM's Plan and Trust. Assets totaling approximately \$109,000 were transferred into the Plan along with the transfer of the Premium Reserve Account (PRA) balances of the transferred employees. In July 2025 the PRAs balances were converted to a Health Reimbursement Account (HRA) within the Plan.
