## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements**

**Note 1: Description of the Plan**

The following description of the Clark Center 401k and Profit Sharing Plan (the Plan), provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering employees of Clark Community Mental Health Center (the Company). Employees are eligible to immediately participate provided they are 21 years of age and have no service requirements with entry on the first day of the month after hire. Employees are eligible for non-elective deferrals after 1 year of service which is defined as 1,000 work hours with entries on January 1 and July 1. Participants must be employed on the last day of the year with 1,000 hours for safe harbor nonelective. Employees are given 90 days to opt out of the Plan. If no such election is made they are automatically enrolled at 1% with 1% increases annually on September 1 of each year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Employee Contributions**

Participating employees may elect to contribute a percentage of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred basis or after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Transfers from qualified plans are allowed under the provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Employer Contributions**

The Company may make a discretionary contribution equal to a uniform percentage of the employee's salary, which percentage is determined annually at the discretion of the Company's Board of Directors. The Plan has a Safe Harbor employer contribution rate of 3% of the employee's salary in addition to any discretionary contribution. During 2024 the Company contributed the 3% safe harbor and a 5% discretionary contributions amounting to \$773,207. During 2023 the Company contributed the 3% safe harbor and a 5% discretionary contributions amounting to \$625,485.

**Participant Accounts**

Each participant's account is credited with the participant's voluntary contribution, any employer discretionary profit-sharing contribution and plan earnings, which are allocated proportionately among all participants based on participant earnings or account balances, as defined. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. The Plan provides vesting in the employer's discretionary contributions of 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% after six years of service. Participants are fully vested in the safe harbor discretionary employer contribution. An employee who becomes disabled, dies, or reaches age 65 will become 100% vested in employer's contributions.

**Payment of Benefits**

Terminated participants shall receive a lump-sum amount equal to the value of the participant's vested interest in his or her account if the balance is less than \$5,000. For an account balance greater than \$5,000, the participant must authorize the benefit payment distribution. An in-service distribution may be made to a participant who has attained age 59 1/2.

**Forfeitures**

Forfeitures represent the non-vested portion of participant account balances upon termination. Forfeitures of Company discretionary funds are used to reduce plan fees and any employer contributions the following year. Match was reduced by \$22,937 and \$8,535 for years ended December 31, 2024 and 2023, respectively. Amounts forfeited during the years ended December 31, 2024 and 2023 totaled \$16,950 and \$3,535, respectively. The forfeiture account balances at December 31, 2024 and 2023 were \$0 and \$4,323, respectively.

**Participant Loans**

As of July 15, 2021 participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participants' accounts and bear interest at a rate determined by the Plan Administrator. Loan repayments are made ratably through payroll deductions. Generally, the loan term may not exceed five years. However, if the loan is for the purchase of a principal residence, the Plan Administrator may permit a longer repayment term. For the years ending December 31, 2024 and 2023 the interest rates on outstanding loans were 4.25%.

At the end of each year there were no loans in default.

**Note 2: Summary of Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits**

Benefits are recorded when paid. As of December 31, 2024 and 2023, the Plan had no pending distributions of participants requesting distribution but not receiving it until the subsequent year.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants accounts are charged directly to the participants account. Other expense are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

**Investment Valuation and Income Recognition**

The Plan's investments are presented as determined and certified by American United Life Insurance Company (the Custodian) as of December 31, 2024 and 2023. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Investments in common stocks, corporate bonds, and publicly traded limited partnerships are valued at the closing price reported on the active market on which the individual securities are traded. Investments in unit investment trusts are valued at the closing price of the underlying assets. Net appreciation consists of both realized and unrealized appreciation (depreciation) on investments bought and sold as well as held by the Plan during the year.

**Investment Valuation and Income Recognition (Continued)**

Investment contracts are reported at contract value. Contract value is the relevant measurement attributed for that portion of the net assets available for benefits of a defined-contributions plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**Participant Loans**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions upon a distributable event, as defined in the Plan document.

**Note 3: Fair Value Measurements (Continued)**

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

**Pooled Separate Accounts and Money Market Funds**

The Custodian and investments are held in mutual funds valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Custodian believes that the Pooled Separate Accounts should be filed as Mutual Funds on the Form 5500 because they have not made the filing with the Department of Labor as a Direct Filing Entity. They have listed the interest in the AUL separate account under the group annuity contract to complete Schedule D showing the assets as being the separate account units and then complete the Schedule H to show the value of the Plan's portion of the investments that underlie the separate account.

**Note 4: Related Parties and Parties in Interest**

The Company absorbs some administrative expenses of the Plan, the cost of audit fees related to the Plan, and the cost of fidelity bonds. The Company provides administrative services on behalf of the Plan. As the Plan does not reimburse the Company for the cost of such services, they are not included in these financial statements. Also, certain plan investments are shares of proprietary funds managed by the Custodian (or its affiliates). These transactions qualify as exempt party-in-interest transactions.

Administrative functions are performed by officers or employees of the Company. Additional party-in interest transactions include audit fees paid to Varney & Associates, CPAs, LLC, and investment fees paid to the Custodian. These transactions qualify as exempt party-in-interest transactions.

**Note 5: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 6: Tax Status**

The Company adopted a non-standardized prototype plan document. The Internal Revenue Service issued an opinion letter, dated August 19, 2020, on the prototype plan document, indicating the basic plan document is acceptable under Code Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

**Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 10: Investment Contracts**

Participants in the Plan have the option to invest in the American United Life Insurance Company (AUL) Stable Value Fund. The account earns a declared interest rate for new deposits in each calendar quarter. Interest rate guarantees of the account are backed by assets held by the general account. Credited rates are set based on yields earned on new purchases of fixed income securities for the general account for new deposits each quarter. The contract value of funds held in the account generally represents principal plus accrued interest. The fair value of these funds reflects the relationship between credited rates earned by funds held in the account and current market rates. Market interest rates are deemed to be the same rates to be credited to new issues of the same contract with like guarantees issued as of the date of the fair value determination.

Certain events may limit the ability of the Company and/or Plan participants to transact at contract value with AUL. Examples of these events would include, but would not be limited to, premature termination of this contract and termination of the retirement plan. In these examples, the contract value could be reduced by any applicable surrender charges upon distribution of contract's funds. Under no event may the Custodian terminate this contract and settle at an amount different from contract value.
