**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the US Salt, LLC 401(k) Plan (the Plan) provides general information about the Plan's provisions. US Salt, LLC (the Company) is the Plan sponsor. Participants should refer to the Plan agreement and the summary Plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General: The Plan was organized effective October 4, 2021, as a defined contribution plan covering substantially all non-union and union employees of US Salt, LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Non-union employees are eligible to participate in the Plan after 30 days of service. Union employees are eligible to participate in the Plan after 90 days of service. Union participants that are employed on the last day of the plan year are eligible for the non-elective contribution. Both non-union and union employees must be at least 18 years old in order to participate in the Plan and enter the Plan immediately upon satisfaction of the eligibility requirements.

Contributions: Participants may contribute up to 75% of eligible compensation on a pre-tax basis but must defer at least 1% subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may designate all or a portion of their contributions as Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company may administratively impose a more restrictive maximum deferral limit applicable to only highly compensated employees. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan provides for non-union safe harbor matching contributions of 100% of the participant's contribution not to exceed 3% of the employee's eligible compensation plus 50% of the participant's contribution that exceeds 3% but does not exceed 5%. The plan also provides for an union non-elective contribution of 2.5% of the employee's eligible compensation for the year. Eligibility for the union non-elective contribution require 3 months of service and participants must be employed on the last day of the Plan year..

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings/(loss), and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are immediately vested in their contributions, rollover contributions, non-union safe harbor match plus actual earnings thereon. Union participants are 100% vested in the employer match and non-elective contributions after one year of credited service.

Participant Loans: Effective March 1, 2023, loans are permitted in the Plan. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of: (a) \$50,000 (reduced by their highest outstanding loan balance), or (b) 50% of their vested account balance (reduced by any outstanding loan balance, outstanding during the previous 12 months). The loans are to be repaid over a period not to exceed 5 years. During 2024, the provision to allow loans to exceed 5 years was removed. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. Principal and interest are repayable throughout payroll deductions. Employees may not make and the Plan will not accept a Director Rollover of a loan note from the qualified plan of a Participant's former employer.

**NOTE 1 - DESCRIPTION OF PLAN** (Continued)

Payment of Benefits: Participants become eligible for benefit payments upon death, disability, retirement, or termination. Participants may elect to receive either a lump-sum cash distribution equal to the value of the vested interest in his or her account, a direct rollover distribution or defer receipt of their account balance until age 70½. Participants may also take distributions from the Plan upon attainment of age 59½. Participants may also receive a distribution for reasons of proven financial hardship, up to the amount the employee has deferred (excluding earnings thereon) under the Plan.

Forfeitures: Forfeitures of employer matching contributions and earnings on those contributions resulting from employees that leave the Company prior to vesting are retained in an unallocated forfeiture account. The Company may use forfeitures in any manner as the discretion of the Plan administrator. At December 31, 2024 and 2023, the forfeiture account totaled approximately \$5,250 and \$2,350, respectively.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Risks and Uncertainties: The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market volatility, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Subsequent Events: Management evaluated subsequent events for the Plan through September 16, 2025, the date the financial statements were available to be issued.

**NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company ("EAIC") (collectively, Empower, trustee of the Plan).

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1*: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2*: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3*: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

**NOTE 4 - FAIR VALUE MEASUREMENTS** (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled Separate Account: Participants may direct the investment of their accounts into a pooled separate account issued by Empower Annuity Insurance Company. The fair values of participation units held in the Empower Annuity Insurance Company Pooled Separate Account are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. The pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

**NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The Plan holds a fully benefit-responsive investment contract that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan's fully benefit-responsive investment contract (traditional guaranteed investment contract) was \$2,247,358 and \$2,414,225 at December 31, 2024 and 2023, respectively.

**NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (Continued)**

The Plan entered into a fully benefit-responsive investment contract with EAIC via an investment in the Empower Annuity Insurance Company Guaranteed Income Fund (Guaranteed Income Fund). EAIC maintains the contributions in a general account. The account is credited with interest and charged for administrative expenses. In certain instances when total distributions or transfers in the Guaranteed Income Fund within a calendar year exceed predetermined thresholds (e.g., 10% of the balance of the Fund on the first day of the year), transactions in the Guaranteed Income Fund may face certain restrictions, in accordance with contract terms. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants within 90 days, is probable. There are no events that allow the EAIC to terminate the contract and which require the plan sponsor to settle at an amount different than contract value within 90 days.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds a pooled separate account as well as a guaranteed investment contract managed by EAIC; therefore, these transactions and the Plan's payment of trustee and recordkeeping fees qualify as party-in-interest transactions. Participant loans are also considered party-in-interest transactions.

**NOTE 7 - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated September 16, 2022 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to income tax examinations for the period from October 4, 2021 (date of plan inception) to December 31, 2024.
