## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of  
The Perryman Company New Comparability Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**NOTE 1—DESCRIPTION OF PLAN**

The following description of The Perryman Company New Comparability Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** – The Plan was established by The Perryman Company (the “Company”) on January 1, 1997 as a defined contribution profit sharing plan for eligible employees of the Company. All full-time employees who are 18 years or older and have completed three months of service are eligible to participate and can enter the Plan monthly. The Plan includes an auto enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** – Participants may elect to contribute up to 100% of his or her compensation, subject to IRS dollar limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations as defined in the Plan agreement and as limited by statute. The Plan is required to make corrective distributions when the IRS limits are exceeded due to excess deferrals, excess contributions and excess annual additions, which are returned to employees during the subsequent Plan year. The Plan includes an automatic contribution provision for employees hired after February 1, 2021. If a participant fails to elect an alternative contribution amount or fails to elect not to contribute, the Company will automatically defer 3% of the participant’s compensation beginning on the participant’s eligibility date.

The Company will make a safe harbor contribution of 3% of eligible compensation regardless of whether the employee chooses to make salary deferrals.

The Company may make discretionary profit-sharing contributions to the Plan. Such contributions are allocated on a cross-tested basis consisting of three allocation groups. Groups I and II consist of Company owners and their spouses. Group III includes all other eligible participants. The allocation of each group is made pro-rata based on each participant’s compensation in that group. Participants must be employed on the last day of the Plan year to receive a contribution and, for the year ended December 31, 2021 only, no service is required. Participants will receive a share in the profit-sharing contribution for the year regardless of the amount of service completed during the plan year in the year of death, disability, or retirement.

**Participant Accounts** – Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and Plan earnings (losses) and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – Participants are immediately vested in their voluntary contributions and actual earnings thereon. They are also immediately vested in the Company’s safe harbor contribution. Participants became vested in the Company’s other discretionary contributions in accordance with the following vesting schedule:

Participants attaining the age of 65 while employed by the Company and those who have died or become disabled before termination of employment are 100% vested.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. A participant may only have one outstanding loan at a time. The period of payment for participant loans can be a maximum of five years, or longer if for the purchase of a primary residence. Such loans are secured by the balance in the participants' accounts, and each loan bears interest at a rate commensurate with local financial institutions for similar loans at the time the loan is made, as determined by the Plan administrator. They are measured at their unpaid principal balances plus any accrued but unpaid interest. Principal and interest are paid at least quarterly, generally through payroll deductions or ACH agreements. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. As of December 31, 2024, participant loans carried interest rates at 3.25%, with various maturities through 2026. Loans will only be permitted during the period beginning April 13, 2020 and ending December 31, 2020.

**Payment of Benefits** – Participants are eligible to receive distributions upon disability or termination of employment with the Company. Distributions can also be approved for immediate financial hardships. Distributions are paid via either a lump-sum cash payment, cash installments, or annuity payments. A participant's account may be distributed as soon as practicable after the date of his or her disability or termination.

**Forfeited Accounts** – Any portion of a participant's account, which is not vested, is forfeited upon the participant's termination of service. Forfeitures of employer contributions are used to reduce employer contributions to the Plan. Forfeitures available for use by the Plan (cash account) were \$14,965 and \$33,009 as of December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, forfeitures in the amount of \$180,146 and \$300,558, respectively, were used to reduce the Company's contributions.

**Plan Expenses and Costs** – Certain administrative expenses are paid for by the Company, while others are paid for by the Plan.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan's financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value, including the stable value fund (a common/collective trust fund), which holds indirect investments in fully benefit-responsive investment contracts. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Net appreciation or depreciation in fair value of investments includes realized gains and losses on investments sold during the year as well as the current year change in unrealized appreciation and depreciation of investments held at the end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded as earned.

All investments are considered to be participant-directed.

**Payment of Benefits**

Benefits are recorded when paid.

**Income Taxes**

The Plan has adopted a pre-approved profit sharing plan document sponsored by Fidelity Management & Research Company. The IRS has determined by a letter dated June 30, 2020, that the plan document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in these financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 3—INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)**

The custodian of the Plan has certified that certain information disclosed in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31, 2024 and 2023, in accordance with Section 2520.103-5 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information includes the composition, cost and current value of all investments and notes receivable from participants held as of December 31, 2024 and 2023, as reported in the statements of net assets available for benefits and supplemental schedule, and the interest, dividends, and net appreciation (depreciation) in fair value of investments and interest from notes receivable from participants, as reported in the statements of changes in net assets available for benefits for the years then ended.

**NOTE 4—FAIR VALUE MEASUREMENTS (UNAUDITED)**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1*            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2*            Inputs to the valuation methodology include:

- Quoted Prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3*            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Shares of registered investment companies (Mutual Funds) are reported at fair value based on the quoted market price of the fund, which represents the net asset value of the investments held by the fund at year-end. The Mutual Funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The Mutual Funds held by the Plan are considered to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5—AMENDMENT AND TERMINATION**

It is the intention of the Company to continue the Plan indefinitely and to make contributions as herein provided. The Company reserves the right, in its sole discretion, by written action of the Plan Committee, to amend the plan, terminate the plan, or to reduce or cease contributions at any time. Notwithstanding any other provision of this Plan, no action to amend or terminate the Plan may have the effect of decreasing, denying or otherwise adversely affecting any benefit to a participant that is a “protected benefit” within the meaning of Code Section 411(d)(6) and the Treasury Regulations thereunder. In the event of Plan termination, participants will become 100% vested in amounts attributed to the Company’s contributions.

The Plan was last amended effective March 29, 2024, related to the changing of eligibility rules.

**NOTE 6—RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others.

Notes receivable from Plan participants qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

Certain funds of the Plan are invested in funds managed by Fidelity Management Trust Company, who is the custodian as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions.

During the years ended December 31, 2024 and 2023, administrative fees of \$269,369 and \$234,844, respectively, were paid by the Plan to the custodian, which qualify as party-in-interest transactions. The Plan sponsor also pays certain fees and expenses of the Plan.

**NOTE 8—SUBSEQUENT EVENTS**

Management has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements as of the date of the independent auditor's report, which is the date the financial statements were available to be issued. There were no subsequent events requiring adjustments to the financial statements or disclosures, as stated herein.
