### Note 1 Description of Plan

The following description of the S&S Cycle, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution profit sharing plan with elective deferral 401(k) features sponsored by S&S Cycle, Inc. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Administrators are responsible for the oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Eligibility

Employees of S&S Cycle, Inc. (the Company) who have attained the age of 18 and completed 60 days of service, as defined in the Plan, are eligible to begin participating on the first day of each month coinciding with or next following date requirements are met. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options.

#### Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Participants are automatically enrolled in the Plan upon meeting eligibility requirements at a rate of six percent. There are no annual increases to the deferral rate unless the participant elects to do so. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes a safe harbor matching contribution equal to 100% of employee contributions up to 1% and 50% of employee contributions, not to exceed 6% of participants' compensation. For the year ended December 31, 2024, the Company matching contribution was \$457,431. The Company may, at its discretion, elect to make additional contributions to the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching and discretionary contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

### Note 1 Description of Plan (Continued)

#### Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes receivable are secured by the balance in the participant's account and bear interest at a rate of 4.25%-9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants had a balance of \$417,245 and \$388,382 at December 31, 2024 and 2023, respectively.

#### Payments of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in annual installments if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000, it can be distributed only in a single lump sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Effective January 1, 2020, the new IRS hardship distribution regulations were implemented to allow participants to have access to earnings on the deferral portion of their account, to include federal disasters as a hardship category, to eliminate the suspension period subsequent to receiving a hardship distribution, and to eliminate the requirement to exhaust plan loans. Written amendments to the Plan to reflect these operational changes have been adopted in accordance with applicable law and IRS guidance.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions. These forfeitures may be reallocated to participants in the same manner as Company contributions or may be used to pay administrative expenses in accordance with the Plan document. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$74,460 and \$83,021, respectively. During the years ended December 31, 2024 and 2023, employer contributions were reduced by \$19,184 and \$0, respectively.

### Note 2 Summary of Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Risks and Uncertainties

The Plan holds various investments. Investment securities are exposed to various risks such as interest rates, market, and credit. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that change in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Also, the Plan has a fixed annuity related to a key guaranteed portfolio fund, which is measured at contract value.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### Payments of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

### Note 3 Fair Value Measurement

#### Fair Value Hierarchy

Accounting standards establish a framework for measuring fair value. The framework establishes a three-level fair value hierarchy that prioritizes the inputs used to measure fair value. The three levels of the hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and inputs that are observable for the asset either directly or indirectly.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset's classification within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement of that asset.

#### Valuation Methodologies

- Mutual Funds – Valued at the daily closing price as reported by the fund. These investments are actively traded on national exchanges and are classified as Level 1.
- Collective Investment Trusts (CITs) – Valued at the net asset value (NAV) of units held at year-end as reported by the trustee. The NAV is based on the fair value of the underlying assets held by the fund, less liabilities. As a practical expedient, investments valued at NAV are not classified in the fair value hierarchy.
- Fixed Annuity Contract – Key Guaranteed Portfolio Fund (KGPF), a general account product issued by Empower Annuity Insurance Company of America (EAICA). Reported at contract value, which approximates fair value and represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Classified as Level 2.

#### Fixed Annuity Contract Disclosure – Key Guaranteed Portfolio Fund

The Plan invests in the Key Guaranteed Portfolio Fund (KGPF), a general account group annuity product of Empower Annuity Insurance Company of America (EAICA).

Guarantees: EAICA guarantees the payment of principal and credited interest for participant-directed withdrawals.

Crediting Rates: Interest is credited daily at a rate established periodically by EAICA. The annualized crediting rates were 1.45% at December 31, 2024 and 1.30% at December 31, 2023.

Liquidity: Participant withdrawals are permitted at contract value. Employer-initiated events (such as plan termination, layoffs, or mergers) may be subject to restrictions, including delayed payout of up to 12 months or market value adjustments. Competing fund restrictions also apply.

Underlying Investments: The contract is backed by the insurer's general account, which holds a diversified portfolio of fixed-income securities and other assets with average maturities of three to seven years.

Creditworthiness of Insurer: As of June 30, 2025, EAICA reported admitted assets of \$47.1 billion, liabilities of \$42.7 billion, and surplus of \$5.0 billion. EAICA's financial strength ratings were AA (S&P), Aa3 (Moody's), AA (Fitch), and A+ (A.M. Best).

Risks: The contract is subject to the credit risk of EAICA and to interest rate risk inherent in the underlying portfolio.

At both December 31, 2024 and 2023, contract value equaled fair value, and no adjustments were necessary.

### Note 4 Information Prepared and Certified by Trustee

Certain information related to the investments in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024 was obtained and derived from the information furnished to the plan administrator and certified as complete by Empower Trust Company, LLC, the custodian of the Plan.

### Note 5 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

### Note 6 Tax Status

The Company adopted a nonstandard prototype document with an IRS opinion letter dated June 30, 2020, which states the prototype Plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan remains open to examination through the applicable statutory periods.

### Note 7 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 8 Party-in-Interest Transactions

Certain Plan investments for the years ended December 31, 2024 and 2023 were managed by Empower Trust Company, LLC and Empower Retirement Services. Empower Trust Company, LLC is the trustee as defined by the Plan. These investment transactions qualify as exempt party-in-interest transactions.
