**NOTE A -- Description of plan and significant accounting policies**

The following description of Bone & Joint Clinic, S.C. 401(k) Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Bone & Joint Clinic, S.C. (the Company) has adopted, with subsequent amendments, the Alerus Financial N.A. (Alerus) Defined Contribution Volume Submitter Plan and Trust, under the name Bone & Joint Clinic, S.C. 401(k) Plan (the Plan) with the most recent restatement effective January 1, 2024. The Plan was originally effective July 1, 1995.

**General**

The Plan is a defined contribution plan with elective deferral 401(k) features covering all non-leased or reclassified employees of the Company. Non-excluded employees become eligible to participate for purposes of elective deferrals upon their entry date, which is defined as the first day of each month coinciding with or following the date they satisfy the eligibility requirements. To be eligible for the purposes of discretionary matching company contributions, employees must have completed: 1) one year of service, defined as at least 750 hours of service, and 2) attained age 21. To be eligible for nonelective company contributions, employees must also be employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of the Company oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan's federal identification number is 39-1130341, and the Plan's number is 004.

**Contributions**

Each year, participants may contribute up to the maximum percentage of pretax and after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has an automatic enrollment provision, which will automatically defer 4% of the participant's eligible compensation. Participants may elect out of the automatic enrollment provision or select an alternative deferral amount at any time.

The Company contributes up to 6.4189% of eligible compensation, as defined in the Plan, as well as 5.7% of excess compensation, defined as annual compensation greater than \$168,600. Contributions are determined annually by the Board of Directors. The Company made a nonelective profit sharing contribution of \$1,305,306 for the year ended December 31, 2024.

The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount of participant elective deferrals, which is updated at the discretion of Plan management each year. For 2024, the matching contribution was 100% of the first 4% of a participant's elective deferral. The Company made a discretionary matching contribution of \$707,318 for the year ended December 31, 2024.

Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

**Contributions receivable**

Contributions receivable are written off when they are determined to be uncollectible. The allowance for credit losses is estimated based on expected credit losses considering the Plan's historical losses, existing economic conditions, and the financial stability of the Company.

**Participant accounts and "rollovers"**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's profit sharing and discretionary contributions, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined, and allocation of Company contributions are based on participant compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the rollover of funds from other qualified plans to a participant's account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's nonelective profit sharing and discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested ratably over five years of credited service. Participants, who leave the Plan because of death or disability, as defined in the Plan, are considered 100% vested in all amounts.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates that range from 4.25% to 9.50%, which are commensurate with the local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

**Benefits**

On termination of service due to death, disability, retirement (age 59 ½) or termination of employment, a participant may elect either a lump-sum distribution of the entire vested account balance or in a single sum distribution of a portion of the participant's vested interest in his or her account. In-service distributions are allowed provided the participant has attained age 59 ½. A participant with an account valued at less than \$1,000 shall receive a lump-sum distribution. An automatic rollover of a participant's account will occur if the account is valued between \$1,000 and \$5,000. For accounts exceeding \$5,000, the participant may elect a lump sum distribution or may elect to defer such distribution to any valuation date subsequent to his/her termination but no later than the valuation date of his/her normal retirement date; or the participant may elect to rollover the distribution to another qualified plan.

**Forfeited accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts were \$8 and \$12,742, respectively. These accounts will be used to pay administrative expenses, if so directed by the plan administrator, or to reduce future Company nonelective or matching contributions. Forfeited non-vested accounts of \$57,451 were used to pay administrative expenses in 2024.

A summary of significant accounting policies follows:

**Basis of accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

**Cash**

The Plan maintains its cash in bank deposit accounts, which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. Management believes it is not exposed to any significant credit risk on cash and cash equivalents.

**Use of estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition**

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits**

Benefits are recorded when paid.

**Administrative expenses**

The Company pays some of the administrative expenses of the Plan, which are excluded from these financial statements. The major administrative expenses are recordkeeping and investment management fees.

**Notes receivable from participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

**Subsequent events**

These financial statements have not been updated for subsequent events occurring after October 3, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

**NOTE B -- Information certified by asset custodian and trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments, cash and notes receivable from participants held at December 31, 2024 and 2023, and dividends, net appreciation and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus, the asset custodian and trustee of the Plan.

**NOTE C -- Party-in-interest transactions**

Alerus is the asset custodian and trustee of the Plan as of and for the year ended December 31, 2024, and is therefore designated as a fiduciary and party-in-interest. Alerus provides recordkeeping services for the Plan. Orgel Wealth Management provides investment advisory services to the Plan; therefore, is designated as a fiduciary and party-in-interest. Transactions with these parties-in-interest occur in the course of ordinary business and are exempt transactions.

Alerus receives revenue from some mutual fund service providers for services Alerus provides to the funds. This revenue is used to offset certain amounts owed to Alerus for its recordkeeping services to the Plan. During the year ended December 31, 2024, revenue received from mutual fund service providers used to offset amount owed to Alerus totaled \$17,589 and are included in net appreciation in fair value of investments on the Statement of Changes in Net Assets Available for Benefits.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

**NOTE D -- Fair value measurements (Continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies: Valued based on quoted net asset values of the shares held by the Plan at year-end. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Stable value collective fund: A stable value fund composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

**NOTE F -- Tax status**

The Alerus Financial N.A. (Alerus) Defined Contribution Volume Submitter Plan and Trust that the Plan has adopted effective January 1, 2024, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the volume submitter plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

**NOTE G -- Concentration of market risk**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE H -- Plan amendment**

Effective January 1, 2024, the Plan was restated. As part of the restatement, the Plan was amended to exclude compensation paid after termination (as defined), move/relocation stipend, referral award, and all non-earned income items from the definition of eligible compensation.
