INDEPENDENT AUDITOR'S REPORT

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Gastro Florida 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The Supplemental Schedule of Assets Held at End of Year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

INDEPENDENT AUDITOR'S REPORT (CONTINUED)

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Gastro Florida 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan became effective January 1, 2011, and was subsequently amended and restated to change the Plan name to "Gastro Florida 401(k) Plan" and to comply with various Internal Revenue Service (IRS) requirements and incorporate previous amendments.

Effective January 1, 2023, the Plan was amended to add Gastro Florida Pharmacy, LLC as a participating employer to the Plan.

The Plan covers all eligible employees of West Central Gastroenterology, LLP d/b/a Gastro Florida and Gastro Florida Pharmacy, LLC (collectively the "Company") who have met certain eligibility requirements.

Eligibility

Employees of the Company who have attained age twenty-one and completed one year of service are eligible to participate in the Plan.

Contributions

After enrollment in the Plan, participants may elect to contribute, in the form of salary deferrals, up to 100% of their annual compensation, not to exceed the regulatory maximum. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions from another qualified plan or individual retirement account are permitted under the Plan.

The Company may make discretionary matching and profit sharing contributions to the Plan. The employer's discretionary matching contribution is a percentage of participant's compensation or a discretionary dollar amount to be determined by the employer on a uniform basis for all participants.

The discretionary profit sharing contribution is allocated to eligible participants based on eligible compensation and participant classification. The discretionary matching and profit sharing contributions are determined annually by the Company. The Company will make safe harbor contributions to each eligible participant in an amount equal to 3% of the participant's compensation for the Plan year. Eligible employees for the purpose of the safe harbor contributions exclude highly compensated employees. There was no matching contribution for 2024 and 2023. The Company made profit sharing and safe harbor contributions totaling \$1,941,965 and \$1,497,083 for 2024 and 2023, respectively.

Participants direct the investment of their contributions among various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value fund. Each investment fund has unique and varied investment objectives.

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and employer contributions, as well as investment earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances, equally among participants or to specific participants for transactions specifically incurred by them. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and in Company safe harbor contributions and earnings thereon and, if applicable, any amounts "rolled over" into their accounts. Vesting of the employer discretionary contributions and earnings thereon is based on the participant's period of service with the Company. Participants vest 20% per year beginning in the second year of service and are fully vested after six years.

Forfeitures

Forfeitures may be used to reduce future employer contributions or pay Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$21,937 and \$12,518, respectively. For the year ended December 31, 2024, the entire balance of forfeitures were applied against the 2024 employer contributions which were allocated in 2025. During 2024, \$3,156 forfeitures were applied against the 2022 employer contributions which were allocated in 2024. For the year ended December 31, 2023, none of the forfeitures were applied against the 2023 employer contributions allocated in 2024.

Notes Receivable from Participants

The Plan allows participants to borrow up to the lesser of 50% of their vested balance or \$50,000. Loans must be for a minimum of \$1,000 and are limited to one loan per participant at a time. Loans to participants are secured by the participant's vested account balance. Interest rates are based on the Wall Street Journal Prime Rate plus 1%, and loans must be repaid within five years.

Payment of Benefits

Participants are eligible to receive benefits upon termination of service, retirement, disability or death. Distributions will be made in one lump sum payment in cash. The Plan also allows in-service distributions from fully vested account balances for participants age 59½ or older. Hardship distributions for immediate and heavy financial need are allowed but are limited to the participant's elective deferral accounts. Distributions of rollover contributions may be made at any time as elected by the participant.

Plan Administration Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Also, Company personnel provided administrative services to the Plan at no charge in 2024 and 2023. Fees related to the administration of notes receivable from participants and withdrawals are charged directly to the participant's accounts. Investment related expenses are included in net appreciation of fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Contributions

Employer profit sharing contributions are accrued by the Plan based on participants' eligible compensation for the Plan year and authorized rate for each participant classification. Employee contributions and the related employer matching contributions are accrued when wages are paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment transactions are recorded on the trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. A loan is considered in default if payment is not made by the last day of the calendar quarter following the calendar quarter when the participant missed the scheduled payment or upon termination of employment. Upon default the entire principal balance shall become immediately due and payable. Loans in default are reclassified as distributions based upon the terms of the Plan documents.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the risk associated with investment securities and the uncertainty related to changes in the value of such securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

3. Investments

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, a qualified institution.

The only non-participant directed investments are forfeitures (Note 1) and unused service provider credits (Note 7) totaling \$54,807 and \$38,648 at December 31, 2024 and 2023, respectively, which are included in the stable value fund.

4. Fair Value Measurements

GAAP provides a framework for measuring fair value and has established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of other than publicly quoted prices that are observable, either directly or indirectly, and Level 3 inputs consist of unobservable inputs and has the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The level is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

- Mutual funds: The fair value is based on quoted net asset values of the shares held by the Plan at year-end (market approach).
- Stable value fund: As a practical expedient, the net asset value of units of the bank collective trust is used to estimate fair value.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. There are no Level 2 or 3 type investments.

4. Fair Value Measurements (continued)

The Key Bank EB MaGIC Stable Value Fund, a collective investment fund, seeks to provide investors with a reasonable level of income together with stability of principal. The fund invests in traditional guaranteed investment contracts (GICs), synthetic GICs, bank investment contracts, separate account GICs, repurchase agreements, other collective investment trusts, cash and cash equivalents and other investments having the characteristics of a guaranteed return of principal and fixed rate of interest. An investment in the fund is not insured or guaranteed. Generally, participant directed transfers and withdrawals from the Fund will be made at book value, as determined pursuant to the terms of the Trust documents governing the Fund. Withdrawals for participant benefit payments in accordance with the provisions of the Plan (including benefit distributions, elections to change investments, or to obtain a loan), will be processed as soon as administratively practicable, subject to available liquidity of the Fund. However, participants are prohibited from transferring from the Fund to a “competing investment”, as defined in the Trust document of the Fund, without first investing in a “non-competing investment” for a period of three months. Employer directed withdrawals may be delayed for up to twelve months at the sole discretion of the trustee of the Fund.

5. Tax Status

Effective January 1, 2022, the Plan was restated and adopted the KB Pension Services, Inc. Defined Contribution Pre-Approved Plan. The Pre-Approved Plan obtained an opinion letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Related Party and Party-In-Interest Transactions

The Plan has investments consisting of mutual funds with American Funds totaling \$11,975,875 and \$10,284,273 as of December 31, 2024 and 2023, respectively, which were managed by Capital Research and Management Company, an affiliate of American Funds and Capital Bank and Trust Company, the trustee. Therefore, these transactions qualify as party-in-interest.

7. Related Party and Party-In-Interest Transactions (continued)

Capital Research and Management Company or any assignee or agent thereof (collectively referred to as the “service provider”) provides recordkeeping and administrative services to the Plan pursuant to a Recordkeeping Services Agreement. The service provider may receive revenue from investments held by the Plan. Revenue received is used to offset service provider fees otherwise payable by the Plan. If revenue received is in excess of service provider fees, the Plan is given credits to use against future Plan expenses.

Recordkeeping fees of \$15,626 and \$14,314 paid to Capital Research and Management Company, Inc. for the years ended December 31, 2024 and 2023, respectively, are included in administrative expenses net of revenue sharing credits applied.

Administrative and investment advisory fees of \$70,937 and \$72,248 paid to the Plan investment advisor for the years ended December 31, 2024 and 2023, respectively, are included in administrative expenses net of revenue sharing credits applied.

Investment management fees relating to the mutual funds and administration fees relating to the stable value fund are charged against the participant’s investment, and are reflected in the return on the investment.

8. Subsequent Events

The Plan’s management has evaluated events occurring subsequent to year end through October 10, 2025, the date the financial statements were available to be issued, for financial reporting and disclosure purposes. Plan management concluded that no events occurred that required adjustments to or disclosures in the financial statements.
