## **INDEPENDENT AUDITORS' REPORT**

To the Trustees of  
Allegheny Millwork 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Allegheny Millwork 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule of assets held for investment purposes at December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to

the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO FINANCIAL STATEMENTS

---

#### 1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of Allegheny Millwork 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document and adoption agreement for a more complete description of the Plan's provisions.

*General* - The Plan, established effective January 1, 2004, and restated effective January 1, 2022, is a defined contribution plan which covers substantially all employees of Allegheny Diversified Holding Company and Subsidiaries (the "Sponsor"). Employees are eligible to participate upon completion of six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Basis of Accounting* - The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Use of Estimates* - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in assets during the reporting periods. Actual results could differ from those estimates.

*Contributions* - The Company deposits cash to the Plan based on withholdings from the employees' pretax and/or after-tax earnings. Participants may elect to contribute to the Plan up to the limit established by the Internal Revenue Service.

The Plan provides for employer matching contributions at 50% of the first \$10 of participant salary deferrals per pay period, and 20% of any participant salary deferrals beyond the first \$10 per pay period. Total matching contributions were \$182,324 and \$224,041 for the years ended December 31, 2024 and 2023, respectively.

The Plan also provides for discretionary non-elective profit sharing contributions, which hourly employees are eligible for upon completion of six consecutive months of service and 1,000 hours of service, based on a percentage of their gross pay, according to the following schedule:

4 or less	2%
5 through 8	3%
9 through 12	4%
More than 12	5%

Employees must be employed as of the end of the plan year to receive a non-elective profit sharing contribution. Total discretionary non-elective profit sharing contributions were \$299,158 and \$285,299 for the years ended December 31, 2024 and 2023, respectively, which were reflected as employer contributions receivable at December 31, 2024 and 2023.

*Participant Rollovers* - Participant rollovers represent nonforfeitable transfers from other qualified plans.

*Participant Accounts* - Each participant's account is credited with the employee and applicable employer contributions and an allocation of the plan's earnings. Allocations of plan earnings are based on a participant's account balance as a percentage of the total account balances for the applicable investment option. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Investment Options* - Participants may direct their contributions as well as their share of employer contributions and any related earnings into various investment options. The Plan is invested in various funds maintained by Transamerica Life Insurance Company (Transamerica).

*Vesting* - Participants are immediately vested in their voluntary contributions, employer matching contributions, and investment income thereon. Employer non-elective profit sharing contributions vest according to the following schedule:

3 but less than 4	40%

6 or more	100%

*Forfeitures* - When a participant withdraws from the Plan prior to becoming fully vested, the nonvested portion of the participant's account is invested in the Stable Value Core Fund and utilized to reduce future employer contributions or pay plan expenses. Available forfeitures were \$5,476 and \$34,235 at December 31, 2024 and 2023, respectively.

*Payment of Benefits* - On termination of service due to death, disability, retirement or other reasons, and subject to certain restrictions, a participant or designated beneficiary may elect to receive an amount equal to the value of the vested interest in his or her account, subject to applicable tax withholding requirements. If a participant's vested account balance exceeds \$5,000, he or she may elect to receive a distribution in a lump-sum payment or IRA rollover. If a participant's vested account balance is less than \$5,000 (or \$7,000, effective January 1, 2024), his or her account will be automatically distributed.

*Notes Receivable from Participants* - Participants may borrow a minimum of \$1,000 up to the lesser of 50% of their vested account balance or \$50,000 from their account. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Interest rates on outstanding loans at December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Repayment is required within five years unless the purpose of the loan is to purchase a principal residence. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

*Cash and Cash Equivalents* - The Plan considers all highly liquid debt securities with original maturities of three months or less to be cash equivalents. Cash and cash equivalents are categorized with investments in the statements of assets available for benefits and represent revenue sharing which may be used to pay the Plan's administrative expenses. For the years ended December 31, 2024 and 2023, revenue sharing income credited was \$58,880 and \$54,350, respectively, and administrative expenses paid out of this account were \$36,524 and \$50,114, respectively. Other activity in the account consisted of interest income. The revenue sharing income and interest income are both presented with net appreciation in fair value of investments in the statements of changes in assets available for benefits.

*Administrative Expenses* - The Plan's expenses are paid by the Company or the Plan as provided by the plan document.

*Investment Valuation and Income Recognition* - The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

*Fair Value Measurements* - U.S. GAAP establishes a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs are not quoted prices in active markets but they are observable either directly or indirectly.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value

measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued using quoted prices in an active market (Level 1 measurement).

*Stable Value Core Fund:* Fully benefit-responsive group annuity contract valued at contract value, which the Custodian has determined is equal to fair value (Level 2 measurement).

The methods described above may produce fair value calculations that may not be indicative of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting dates.

*Risks and Uncertainties* - Plan assets are composed of various investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits and the statement of changes in assets available for benefits.

*Subsequent Events* - The Sponsor has analyzed subsequent events for recognition and disclosure purposes through September 30, 2025, the date which the financial statements were available to be issued.

The Stable Value Core Fund maintains contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Transamerica is financially obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

Because the Stable Value Core Fund is fully benefit-responsive, contract value is the relevant measurement attribute. If an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable, such as plan termination, a significant decline in creditworthiness of Transamerica, etc., the Stable Value Core Fund investment choice may no longer be considered fully benefit-responsive. However, the occurrence of such events is not considered to be probable.

### **3. PLAN TERMINATION**

The Sponsor anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at its discretion. In the event that such discontinuance results in the termination of the Plan, all amounts credited to participant accounts become 100% vested. The assets of the Plan will be distributed by the custodian in accordance with the trust agreement in a uniform and nondiscriminatory manner.

### **4. INCOME TAX STATUS**

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement. The Internal Revenue Service issued an opinion dated June 30, 2020 stating that the form of the pre-approved plan, as then designed, is acceptable for use by employers under Internal Revenue Code (IRC) Section 401. The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes that there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to U.S. federal or state income tax examinations by tax authorities for tax years before 2021.

### **5. CERTIFIED FINANCIAL INFORMATION**

Transamerica, the custodian, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of assets available for benefits as of December 31, 2024 and 2023.
- Net investment income, as shown in the statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for investment purposes at December 31, 2024, as shown on the accompanying schedule.

**6. RELATED PARTIES AND PARTIES-IN-INTEREST**

Transamerica serves as custodian of the Plan and is the issuer of the pooled separate accounts and Stable Value Core Fund.

Neither the Sponsor nor the employees of the Sponsor involved in administering the Plan receive any compensation from the Plan.
