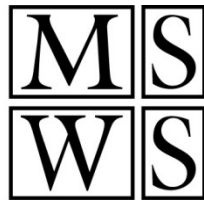

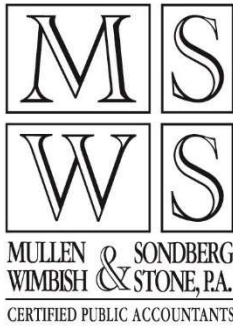

INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Delmarva Community Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Delmarva Community Services, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to *29 CFR 2520.103-8* of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1 - Description of Plan

The following description of the Delmarva Community Services, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Delmarva Community Services, Inc. 401(k) Plan (the Plan), established January 1, 2000, is a defined contribution plan covering substantially all employees of Delmarva Community Services, Inc. (the Employer). Under the provisions of the Plan, an employee may become eligible to participate and receive employer matching contributions after attaining age 21 and completing one year of service. Effective January 1, 2024, the Plan only requires the employee to be employed for one year, with no minimum hours requirement to complete that year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Eligible employees may elect to defer 100% of their compensation and have such deferrals contributed by the Employer to their account under the Plan. Participant contributions are subject to the annual Internal Revenue Service Code limits adjusted each year. This may be further limited so that the Plan complies with the 401(k) and 401(m) nondiscrimination tests. The Employer elected to make safe harbor basic matching contributions of 100% of the amount of the participant's elective deferrals (including catch-up contributions) that are not in excess of 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals (including catch-up contributions) that exceed 3% of the participant's compensation but not in excess of 5% of the participant's compensation. Additionally, the Employer elected to make discretionary matching contributions of up to 2% of eligible compensation. Total contributions made by the Employer for the years ended December 31, 2024 and 2023 were \$243,752 and \$207,249, respectively.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and, (b) Plan earnings, and charged with applicable fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Contributions are invested, at the discretion of the participants, in one, several, or all of the investment alternatives selected by the plan administrator.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. In addition, employees are immediately vested in Employer contributions made under the Plan's safe harbor provisions. Employer matching contributions are based on years of continuous service. A participant is 100% vested after five years of credited service. A year of credited service is a plan year in which the participant is credited with at least 1,000 hours of service with the Employer. Upon termination of employment due to death or disability (approved by Social Security), a participant becomes fully vested in their account.

Note 1 - Description of Plan (Cont.)

Notes Receivable from Participants: Under certain circumstances, as outlined in the Plan document, the Plan allows employees to obtain loans from the Plan. These loans are secured by the vested portion of the participants account and bear interest at rates ranging from 4.50% to 9.50%. Repayment of the loans must be completed within five years, unless the loan proceeds are used to purchase a primary place of residence. Repayment of loans is provided through automatic payroll deduction.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts: For the years ended December 31, 2024 and 2023, total forfeitures were \$7,448 and \$5,536, respectively. As of December 31, 2024 and 2023, there were \$25,288 and \$16,266, respectively, available to reduce future Employer contributions.

Administrative Expenses: The administrative expenses related to the Plan's custodian and the Plan's third party administrator are paid by the Plan. The Employer pays all other administrative expenses of the Plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues, and gains are recognized when earned, and expenses and losses are recognized when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Note 2 - Summary of Accounting Policies (Cont.)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined-contribution plan attributed to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statement of changes in net assets available for benefits is prepared on a contract value basis for fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. Benefits paid to participants amounted to \$1,506,391 and \$545,507, for the years ended December 31, 2024 and 2023, respectively.

Contributions and Related Receivables

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from the amounts paid. The Employer discretionary match is recorded in the year in which the Employer designated the contributions. All participant and employer contributions are participant-directed. Management of the plan evaluates employer contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection. Management has determined that all contributions receivable are fully collectible as of December 31, 2024 and 2023. Consequently, no amount has been recorded as an allowance for doubtful accounts in the accompanying statements of net assets available for benefits.

Note 3 - Data Obtained from the Custodian

Investment Data

The investment information included in the accompanying financial statements and supplemental Schedule H, Line 4i – Schedule of assets (held at end of year) was obtained from data that has been prepared and certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the Custodian of the Plan, as of December 31, 2024 and 2023, respectively.

Schedule of Assets Held for Investment Purposes

The accompanying Schedule H, Line 4i – Schedule of assets (held at end of year) represents a detailed listing of all investments held by the Plan as of December 31, 2024.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1: Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable and supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Note 4 - Fair Value Measurements (Cont.)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

In addition, under *FASB ASC 820* the fair value of certain investments may be measured using the net asset value (NAV) per share (or its equivalent). Such investments are not classified in the fair value hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023:

Pooled separate accounts: Valued at the net asset value of the pooled separate account, as reported by the custodian and calculated in a manner consistent with generally accepted accounting principles for investment companies. The net asset value is calculated based on the values of the underlying mutual funds, domestic stocks, international stocks, and other fixed securities held by the pooled separate account. As permitted by *FASB ASC 820*, net asset value is used as a practical expedient to estimate fair value and is not included in the fair value hierarchy. The total fair value of the Plan's pooled separate accounts as of December 31, 2024 and 2023 was \$3,480,118 and \$3,920,144, respectively.

Note 5 - Investments Measured at Contract Value

The Plan entered into fully benefit-responsive investment contracts with Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company, respectively maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at contract value as reported to the Plan by Voya Retirement Insurance and Annuity Company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed in the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The total contract value of the above investment contracts included in the financial statements as of December 31, 2024 and 2023 was \$34,416 and \$18,174, respectively.

Because the contracts are insurance contracts, the Plan may transact according to the terms defined in the contracts at any time. If the Plan wishes to terminate its interest in the contract, it would be paid the value of its interest. The issuer of the contract has the right to no longer receive deposits. Termination of the contract would occur when the deposit arrangement no longer exists and there are no guaranteed interest funds with a value greater than zero remaining under the contract. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

Note 6 - Parties-in-Interest

Certain Plan investments are shares of mutual funds managed by the Custodian of the Plan. Voya Retirement Insurance and Annuity Company is the Custodian as defined by the Plan as of December 31, 2024 and 2023, respectively; and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Custodian and third party administrator for the years ended December 31, 2024 and 2023 amounted to \$15,029 and \$12,283, respectively.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their accounts.

Note 8 - Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Reportable Transactions

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the end of the year. During the plan years ended December 31, 2024 and 2023, there were no reportable transactions.

Note 10 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11 - Subsequent Events

The Plan has evaluated the impact of significant subsequent events. There have been no subsequent events through October 3, 2025, the date the Plan's financial statements were available to be issued, that require recognition or disclosure.
