Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lake Regional Health System Employees' Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lake Regional Health System Employees' Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Description of the Plan

General

The following description of Lake Regional Health System Employees' Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees of Lake Regional Health System (Health System) who have completed one day of service and are age 21 or older. Lake Regional Medical Management, Inc., d/b/a Lake Regional Medical Group, is also a participating employer. The Plan is subject to the *Employee Retirement Income Security Act of 1974* (ERISA). Delaware Charter Guarantee and Trust Company, d/b/a Principal Trust Company (Principal Trust), serves as plan trustee.

Contributions

The Plan permitted eligible employees through a salary deferral election to have the Health System make annual contributions up to 70% of eligible compensation. Employee rollover and employee Roth contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The plan document includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise.

The Health System makes safe harbor matching contributions equal to 100% of employees' salary deferral amounts not exceeding 3% of compensation, plus 50% of each deferral between 3% and 5% of employees' compensation. The Health System may make an annual profit-sharing contribution to the Plan as determined at the discretion of the Board of Directors. To participate in employer matching and discretionary contributions, an employee must complete one year of service. No discretionary contributions were made in 2024 or 2023.

Contributions are subject to certain limitations.

Participant Investment Account Options

Participants have the option of directing their contributions into any of the various investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Health System's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and the Health System's safe harbor matching contributions plus earnings thereon. Vesting in the Health System's profit-sharing contribution portion of their accounts plus earnings thereon is based on years of credited service. A participant is fully vested in the Health System's profit-sharing contributions after three years of credited service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

If a participant ceases to be an employee of the Health System and his vested account balance does not exceed \$1,000, the entire vested account balance will be payable to the participant or his beneficiaries in a single lump-sum payment. Balances greater than \$1,000 but not exceeding \$5,000 are to be rolled over to an individual retirement account as designated by the Plan, absent an election by the participant. Participant balances in excess of \$5,000 can remain in the Plan until such time the participant elects to receive a distribution in the form of a lump-sum amount or installments. Withdrawals for reasons other than termination of employment are permitted under circumstances provided by the Plan. Under the SECURE 2.0 Act, qualified participants are permitted to take qualified birth/adoption distributions (QBA) of up to \$5,000 from the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,194 and \$2,589, respectively. These accounts will be used to pay administrative expenses or reduce future employer contributions. During 2024 and 2023, forfeitures of \$2,623 and \$0 were used to reduce the Hospital's contributions, respectively. During 2024 and 2023, administrative expenses of \$1,687 and \$1,058, respectively, were paid from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Pooled separate accounts and collective investment trusts are valued at NAV per unit of investment as a practical expedient to estimate fair value.

Effective March 20, 2020 through July 15, 2021, the Plan's investment in the Principal U.S. Property Separate Account was subject to certain restrictions including delaying the payment of most withdrawal or transfer requests, but for no more than three years from the effective date. In accordance with the terms of the plan's group annuity contract, delayed payment requests will be honored proportionately. This means transactions may be processed in a series of payments until enough cash is available to pay obligations. These restrictions were lifted effective July 15, 2021, and standard processing of withdrawal and transfer requests resumed until July 1, 2022, when Principal Trust again applied the withdrawal limitation. As of December 31, 2024 and 2023, participant distribution requests subject to withdrawal limitations amounted to \$445,224 and \$1,647,238, respectively.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Health System or the Plan, at the Health System's discretion.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain investments are issued by affiliates of Principal Trust. Principal Trust is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$148,598 and \$142,909 of direct record keeping fees to Principal Life Insurance Company, an affiliate of Principal Trust during 2024 and 2023, respectively.

The Health System provides certain accounting and administrative services at no cost to the Plan and directly pays any other fees related to the Plan's operations.

Note 6. Plan Document Restatements

Effective January 1, 2024, the Plan was restated to change the plan definition of compensation from W-2 Wages, to 3401(a) Wages.

Note 7. Plan Termination

Although it has not expressed an intention to do so, the Health System has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer profit sharing contribution accounts.

Note 8. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a pre-approved profit-sharing plan document sponsored by Principal Life Insurance Company (Principal Life). Principal Life received an advisory letter dated June 30, 2020, stating the form of the plan is acceptable under the appropriate section of the Internal Revenue Code (IRC). Therefore, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

Plan Restatement

Effective January 1, 2025, the plan was restated to reduce age requirements for participation from age 21 to age 18.
