NOTE 1 - DESCRIPTION OF PLAN

The following description of the WebpageFX LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General: The Plan is a defined contribution plan. It was established by WebpageFX LLC (the "Company") on January 1, 2019 to provide retirement benefits and additional incentives to eligible employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective August 22, 2022, the Company acquired Nutshell, Inc. and its employees became participants in the Plan.
- B. Eligibility: The Plan covers all employees who have completed three consecutive months of service during which time the employee completes at least 250 hours of service.
- C. Employee contributions: Each year, participants may contribute up to 100% of annual compensation as defined in the Plan. Rollovers from other qualified plans are included with employee contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participant may make pre-tax elective deferrals or post-tax Roth elective deferrals. Participants direct the investment of their salary deferral account balance into various investment options offered by the plan. Contributions are subject to certain statutory limitations.
- D. Employer contributions: The Company may make a discretionary matching contribution on behalf of a qualifying contributing participant. For 2024, the discretionary match was 100% of the participant contributions that are not in excess of 3% plus 50% of the participant contributions that are not in excess of 5% of the participant's compensation, excluding Phantom Equity Plan payouts and post-employment compensation. The Company may make a discretionary Profit-Sharing Contribution to eligible participants, to be allocated in the ratio that such participant's compensation bears to the compensation of all eligible participants.
- E. Participant Accounts: Each participant's account is credited with the participant's allocation of (a) the Company's contribution and elected deferrals, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled, is the benefit credited to the participant's account.

- F. Benefit Claims: Liability for benefit claims are recognized upon the processing and approval of a written request in accordance with the Plan's agreement. This policy applies to retiring and terminating employees.
- G. Vesting: Under the Plan's vesting schedule, participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in any qualified matching and profit-sharing contributions.
- H. Payment of Benefits: Benefits are generally payable in a lump sum as of the retirement date. Benefits are also payable in the event of disability, death or termination of service. If the vested value of the account is \$5,000 or less, an automatic lump sum distribution will be made after termination.
- I. Administrative expenses: Administrative expenses for plan management including trustee fees and plan administration are paid by the plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Plan operating expenses:

The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, then the expenses will generally be allocated among the accounts of all participants in the Plan. These expenses will be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. Certain expenses of the Plan are paid by the Company.

Payment of benefits:

Benefits are recorded when paid. Payment is made when the employee submits the proper documentation requesting the payment.

Risks and uncertainties:

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Subsequent events:

The Plan has evaluated subsequent events through October 6, 2025, the date which the financial statements were available to be issued.

NOTE 3 - INFORMATION PREPARED BY AND CERTIFIED BY TRUSTEE

The fair value measurements and investment information for 2024 and 2023 included in the accompanying financial statements and supplemental schedules were obtained from data that has been prepared and certified to as complete and accurate by the trustee, Ascensus Trust Company, by agreement with The Vanguard Group, Inc. which was also the investment advisor.

NOTE 4 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued at the daily closing price as reported by the fund, mutual funds held by the plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will receive benefits based upon participant balances accumulated to the date of termination of the Plan and will become fully vested in those accounts regardless of years of service.

- G. **Vesting:** Under the Plan's vesting schedule, participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in any qualified matching and profit-sharing contributions.

- H. **Payment of Benefits:** Benefits are generally payable in a lump sum as of the retirement date. Benefits are also payable in the event of disability, death or termination of service. If the vested value of the account is \$5,000 or less, an automatic lump sum distribution will be made after termination.

- I. **Administrative expenses:** Administrative expenses for plan management including trustee fees and plan administration are paid by the plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Plan operating expenses:

The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, then the expenses will generally be allocated among the accounts of all participants in the Plan. These expenses will be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. Certain expenses of the Plan are paid by the Company.

Payment of benefits:

Benefits are recorded when paid. Payment is made when the employee submits the proper documentation requesting the payment.

Risks and uncertainties:

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Subsequent events:

The Plan has evaluated subsequent events through October 6, 2025, the date which the financial statements were available to be issued.

NOTE 3 - INFORMATION PREPARED BY AND CERTIFIED BY TRUSTEE

The fair value measurements and investment information for 2024 and 2023 included in the accompanying financial statements and supplemental schedules were obtained from data that has been prepared and certified to as complete and accurate by the trustee, Ascensus Trust Company, by agreement with The Vanguard Group, Inc. which was also the investment advisor.

NOTE 4 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued at the daily closing price as reported by the fund, mutual funds held by the plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will receive benefits based upon participant balances accumulated to the date of termination of the Plan and will become fully vested in those accounts regardless of years of service.

NOTE 6 - TAX STATUS

The Company has adopted a Volume Submitter 401(k) Profit Sharing Plan. An IRS advisory letter dated January 1, 2018 has been obtained for this Volume Submitter Plan. The current version of the Plan has been amended to conform to the most recent requirements of applicable laws. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.
