Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Wisconsin Vision, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Note A - Description of Plan

The following description of Wisconsin Vision, Inc. 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Wisconsin Vision, Inc. 401(k) Profit Sharing Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Wisconsin Vision, Inc. (the "Company") and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Employees become eligible to make elective deferral contributions and receive employer matching contributions and safe harbor matching contributions on the first day of the first month of the Plan year or first day of the seventh month of the Plan year, coincident with or next following the date they attain age 21. Upon meeting the age and waiting period requirements, an employee can initiate participation in the Plan at any time. Eligibility for discretionary profit-sharing contributions requires 6 months of service, as defined in the Plan document. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options.

Contributions

Participants may make voluntary contributions to the Plan. The Plan does not limit the amount of contributions a participant may defer. Participants may also make after-tax Roth contributions. The combined pre-tax and Roth contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company makes a safe harbor matching contribution to the plan in which it will match 100% of participant deferrals that do not exceed 3% of participant compensation and 50% of participant deferrals that exceed 3% but not exceed 5% of participant compensation. The Company made safe harbor matching contributions of \$367,315 for the year ended December 31, 2024. Additional profit sharing and matching contributions may be contributed at the sole discretion of the Company's Board of Directors. There were no additional profit sharing or matching contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company safe harbor matching contributions, as well as allocations of the Company's additional profit-sharing and match contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is limited to the participant's vested account.

Vesting

Participants are 100% vested in the account balances of their salary deferral, rollover contributions, and Company safe harbor contributions. In the event of termination of employment, a participant is entitled to receive a percentage of the amount in their Company matching and profit-sharing contributions based on the number of years of service prior to such termination. A participant is 100% vested in discretionary matching contributions and profit sharing contributions after six years of credited service.

Note A - Description of Plan (Continued)

Payment of Benefits

On termination of service due to death, disability, separation or retirement, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account, an IRA rollover, or other qualified plan rollover. In addition, a participant may withdraw all or a portion of his or her account balance prior to termination in the event of a financial hardship or attaining age 59 ½.

Forfeited Accounts

Forfeited nonvested accounts will be used to reduce future employer contributions or plan administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. There were no forfeitures used to reduce employer contributions or plan administrative expenses during the year ended December 31, 2024.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D – Fair Value Measurements, for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain administrative expenses of the Plan are paid by the Plan and totaled \$84,880 for the year ended December 31, 2023. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Management has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued.

Note C - Certification of Investment Information

Voya Retirement Insurance and Annuity Company, the insurance company of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Note D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments held by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Units held in pooled separate accounts (PSAs) are valued using the net asset value (NAV) practical expedient as reported by the account manager. Pooled separate accounts are similar to mutual funds except they are issued by insurance companies and are not publicly traded like mutual funds. Each plan's share of a pooled separate account is determined on a participation-unit or variable-unit basis. The plan's equity account provides a cumulative record of the number of participation units credited to the account and the number of units allocated or withdrawn from the account. The balance of participation units credited to the account multiplied by the current participation-unit value equals the amount of equity accounts assets held on behalf of the policy-holder at any given time. The participation-unit value is adjusted periodically, usually each business day, to reflect investment results under the separate account.

Note E - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contribution accounts.

Note F - Tax Status

The IRS has determined and informed the Plan Committee by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note G - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances.

Note H - Related-Party Transactions

The Plan investments are held, invested, and maintained by Voya Retirement Insurance and Annuity Company, the insurance company, as defined by the Plan. Administrative and recordkeeping services are performed by PPG Retirement Plan Services and these transactions qualify as party-in-interest transactions. The fees for these services paid by the plan were approximately \$8,558 for the year ended December 31, 2024.
