## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Glenn Rieder, LLC 401(k) Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Glenn Rieder, LLC 401(k) Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - The Glenn Rieder, LLC 401(k) Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Key parties of the plan** - Glenn Rieder, LLC is the plan sponsor, plan administrator and employer. Participating employers include Shamrock Metals, LLC, and Glenn Rieder Residential, LLC. CPI Qualified Plan Consultants, Inc. ("CPI") is the third party administrator that maintains investment and participant records and performs various compliance tests as tax counsel. The stable value account is an obligation of CMFG Life Insurance Company ("CMFG"), who is also the custodian of the account. CPI and CMFG are member companies of CUNA Mutual Holding Company and are collectively referred to as "CUNA Mutual Group". Matrix Trust Company ("Matrix") is the trustee and custodian of the mutual fund investments. Spectrum Investment Advisors Inc. is the investment advisor.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through September 18, 2025, which is the date the financial statements were available to be issued.

**Investments** - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings, including the net appreciation (depreciation) in fair value of investments bought, sold and held during the years, are reflected in the statements of changes in net assets available for benefits.

**Investments at fair value** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

**Mutual funds** - Valued at the daily quoted market prices as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

**Investment at contract value** - The plan invests in a fully benefit-responsive stable value account through a group annuity contract between the plan and CMFG. The contract is an obligation of CMFG and is supported by the general account assets of CMFG. Interest rates are adjusted quarterly and credited daily. The average yield earned by the fund was 2.00% in 2024 and 1.93% in 2023. There are no penalties assessed for benefit payments or other withdrawals taken by participants.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount participants receive if they initiate permitted transactions under the terms of the plan. Contract value, as reported by CMFG, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of the investment at contract value at any time.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The contract is subject to a market value adjustment if the plan terminates the contract and elects a lump sum distribution, which may result in a payout of less than 100% of principal and interest credited. The contract will continue in full force until all assets have been distributed or no further payments are due.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its financial obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financial statements were available to be issued, the plan administrator is not aware of any events that may limit the ability of the plan to transact at contract value with the contract issuer or that would limit the ability of the plan to transact at contract value with the participants.

## 2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

**General** - The plan was established on July 1, 1985 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees are eligible to participate in the plan once they have completed three months of service and have reached age eighteen. An employee can enter the plan on the first day of the calendar quarter following meeting the eligibility requirements.

**Contributions** - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. New employees are automatically enrolled in the plan and have 5% of compensation withheld as elective deferral contributions. Beginning in January 2025, election deferral rates are increased by 1% each year up to a maximum of 15%. Participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. A safe harbor matching contribution is made equal to 100% of the first 3% and 50% of the next 2% of compensation contributed by the employee as elective deferral contributions, funding coinciding with each payroll.
- d. Nonelective contributions may be made at the plan sponsor's discretion. There were no such contributions in 2024 and 2023.

**Participant accounts** - Each participant's account is credited with the participant's elective deferral contributions, rollover contributions, and an allocation of the employer contributions. Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage each pay period.

**Vesting** - Participants are always 100% vested in their elective deferral contributions, rollover contributions, safe harbor matching contributions, and related earnings. Participants begin vesting in the nonelective contributions and related earnings upon two years of service, at which time they are 25% vested. Participants vest at the rate of 25% for each year thereafter. Upon death, disability, or qualified retirement while employed, participants become 100% vested.

**Payment of benefits** - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Distributions may be in the form of a single lump sum, installment payments, or partial withdrawals. In addition, hardship withdrawals are permitted under certain circumstances. In-service withdrawals can commence upon attaining the age of 59 ½.

**Administrative fees** - Certain administrative fees of the plan are paid by the plan sponsor. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for loan and distribution fees and nonparticipant directed charges for services, administrative fees and investment advisory fees. Non-participant directed charged are allocated to the participants on an account value basis.

**Forfeitures** - Forfeited non-vested nonelective contributions may be used to pay plan administrative fees or reduce employer contributions. Forfeitures used were insignificant in 2024 and 2023. There were no unused forfeitures as of December 31, 2024 and 2023.

**Notes receivable from participants** - Participants may take out loans against their account. The minimum loan amount is \$1,000 and loans cannot exceed the lesser of 50% of the participant's vested account balance or \$50,000 reduced by the highest outstanding balance of loans during the previous twelve months. Participants may have only one loan outstanding at a time. The repayment term generally cannot exceed 5 years unless used for the purchase of a principal residence. As of December 31, 2024, loans outstanding had various repayment schedules through November 2029 with interest rates ranging from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

### 3. PARTY-IN-INTEREST TRANSACTIONS

The CMFG Stable Value Account is managed by CUNA Mutual Group therefore any transactions between the plan and CUNA Mutual Group qualify as party-in-interest transactions. Direct fees paid by the plan to CUNA Mutual Group were \$37,000 in 2024 and \$32,000 in 2023. In addition, CUNA Mutual Group and Matrix provide certain administrative services to the plan pursuant to a service agreement between them and the plan sponsor. Both parties receive revenue from mutual fund service providers for services provided to the mutual funds. This revenue is used to offset certain amounts that would otherwise be owed by the plan to them for their administrative services to the plan. Pursuant to a service agreement between the plan sponsor and the custodians, the custodians remit certain service credits to the plan on a periodic basis. These service credits are held in an unallocated suspense account and are used by the plan to pay certain plan administrative expenses or reallocated to participants if not used by the plan in a timely manner as further described in the related plan documents. Service credits received, recorded by the plan as a component of net appreciation in fair value of investments, were \$11,000 in 2024 and \$14,000 in 2023. Service credits used to pay administrative expenses were \$11,000 in 2024 and \$14,000 in 2023. There were no unused suspense account credits as of December 31, 2024 and 2023. Notes receivable from participants also qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their nonelective contributions and related earnings.

### 5. INCOME TAX STATUS

The plan adopted a CMFG Life Insurance Company Non-Standardized Pre-Approved Profit Sharing Plan that received a favorable opinion letter on June 30, 2020. The letter from the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan, however, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

### 6. INFORMATION CERTIFIED BY THE CUSTODIANS

Management has obtained certifications from the custodians (as defined in Note 1), qualified institutions under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the contract and fair values of such as of December 31, 2024 and 2023;
- b. Net appreciation (depreciation) in fair value of investments, dividends from mutual fund investments, and interest income on CMFG Stable Value Account during 2024 and 2023; and
- c. Contributions to, withdrawals from, purchases, sales and interfund transfers between investment accounts during 2024 and 2023.
