NOTE 1 - PLAN DESCRIPTION

The following description of the RFS Technologies Inc. Savings Plan (Plan) (previously Radio Frequency Systems, Inc. Savings Plan) is provided for general information purposes. Participants should refer to the Plan document and any amendments thereto for more complete information of the Plan's provisions.

General

The Plan is a safe-harbor defined contribution plan offered to all eligible U.S. employees of RFS Technologies Inc. (Sponsor and Plan Administrator), as defined in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was adopted and effective on January 1, 2013, as a result of a spin off from Alcatel/Lucent, RFS Technologies Inc.'s parent company. The Plan Administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Plan Amendment

In 2023, Radio Frequency Systems, Inc. (the prior plan sponsor) was acquired by Amphenol Corporation, and is now operating as a stand-alone organization as RFS Technologies, Inc operating under Amphenol. Effective September 1, 2023, the Plan's name changed to RFS Technologies Inc. Savings Plan. Other than this name change, there was no effect on the Plan.

Contributions

Each year, participants may elect to make pre-tax and/or after-tax contributions up to 60% of their eligible compensation, as defined in the Plan (of which after-tax contributions are limited to 25% of eligible compensation). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Sponsor provides a matching contribution of 100% up to 6% of a participants' salary deferred. The Plan also allows the Sponsor to make discretionary contributions to the Plan. There were no discretionary contributions made to the Plan for the years ended December 31, 2024 and 2023. All contributions are subject to Internal Revenue Service (IRS) limitations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Participants are automatically enrolled at 6% of their eligible compensation and invested in a designated balanced fund until changed by the participant.

Participant Accounts

Separate accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's contributions, Plan earnings and charged with an allocation of administrative expenses. Participants may direct their account balance into one or more investment options offered by the Plan, including mutual funds, a self-directed Brokeragelink investment option, and collective investment trusts. The self-directed Brokeragelink option allows the participant to direct contributions to be invested in any investment permitted under the Plan, including mutual funds, collective trust funds, common stocks, and bonds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - PLAN DESCRIPTION – (CONTINUED)

Vesting

Participants are immediately vested in their voluntary contributions and in the Sponsor's matching and discretionary contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their account balance. A participant may have no more than two loans outstanding at any given time. The loans are secured by the balance in the participant's account and bear interest at rates determined based on commercially acceptable criteria as determined by the Plan Administrator. Loans must generally be repaid within five years, except for loans for the purchase of a primary residence, which must be repaid within fourteen years. For the years ended December 31, 2024 and 2023, all loans had an interest rate ranging from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Termination of service due to death, disability, retirement or termination of employment allows the participant or beneficiary to receive a lump-sum payment or have the payment made as a direct rollover to a qualified retirement account. In-service distributions are permitted upon attainment of age 59.5, qualified reservist, active military, and in the event of certain financial hardships. The Plan permits after-tax contributions to be withdrawn if they have been held in the Plan for at least 24 months, as well the withdrawal of rollover contributions. The Plan also permits involuntary distributions of account balances of terminated participants when the account balances are less than \$7,000 and \$5,000 for the years ended December 31, 2024 and 2023, respectively.

Reclassifications

Prior period financial statement amounts have been reclassified to conform to our current period presentation.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policy utilizing information provided by the investment advisors, custodians, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Asset management fees charged for the administration of all funds are charged against net assets available for benefits of the respective fund. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

NOTE 4 - CERTIFIED INVESTMENTS

The Plan's administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to quoted prices (unadjusted) in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 (Fair Value Measurement) are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Values are determined by obtaining actual prices on nationally recognized securities exchanges.

Self-directed brokerage accounts (Brokeragelink): Accounts primarily consist of cash, mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Collective Investment Trusts: Value at net asset value (NAV) of units held by the Plan at year end which is based on the market value of the underlying investments. The collective trust funds themselves are not listed on public exchanges, but as of December 31, 2024 and 2023, are available to current investors via the Fidelity website or when participants access their account values. The NAV is the basis for current transactions and the collective investment trusts can be redeemed at NAV as of the measurement date. Therefore, management has determined that these investments have a readily determinable fair value because these accounts are valued similarly to mutual funds and should be categorized as a Level 1 investment.

NOTE 6 - TAX STATUS

The Plan adopted a pre-approved plan offered by FMR, LLC. This pre-approved plan received an IRS opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 7 - RELATED- PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Under ERISA, parties-in-interest are defined to include the Plan sponsor, the Plan administrator, employees, officers and directors of the sponsor; direct and indirect owners (or their relatives), if they have combined voting power of 50% or more; the Plan custodian or trustees; other parties with fiduciary responsibilities such as the investment advisor; and a person (or their relatives), who provides services to the Plan such as the Plan auditor, attorney, etc. The Plan holds investments in mutual funds which are managed by the trustee. The Plan issues loans to participants, which are secured by the participants' account balances. The Plan pays administrative fees for recordkeeping, investment advisory, and investment management. These are considered exempt party-in-interest transactions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
