Notes to the Financial Statements

1. Description of Plan

The following description of the R.J. Corman Savings Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Plan became effective January 1, 1998 and was restated effective January 1, 2023. The Plan is administered by a trust, the trustee of which is Central Bank & Trust Co. (Central Bank). Under Secure Act 2.0 provisions, the Plan elected to increase the force-out threshold from \$5,000 to \$7,000, effective January 1, 2024.

Plan Sponsor

The Plan is a multiple-employer plan sponsored by R.J. Corman Railroad Group, LLC (the Plan Sponsor) and its related and controlled companies. The following companies are co-sponsors of the Plan:

Eligibility

Employees that are not considered temporary or seasonal, are not residents of Puerto Rico, and are not members of a collective bargaining unit are eligible to participate in the Plan after reaching the age of 18.

Contributions

Participants are automatically enrolled at a deferral rate of 3% of their annual compensation, as defined by the Plan. Each participant may elect to opt out of the Plan or change their election to their individual accounts on a pre-tax basis, not to exceed the annual maximum limit established by the Internal Revenue Code (IRC). Each participant may direct his or her contribution to any of several investment funds.

The Plan also allows for employer matching contributions, which are elective at the discretion of the employer. All employees that are employed as of the last day of the plan year, regardless of service, will receive a share of employer matching contributions. In 2024, the Plan Sponsor matched 50 percent of each participant's contributions not to exceed the annual maximum limit allowed by the IRC.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Plan Sponsor's contribution, an allocation of plan earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan adoption agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The Plan Sponsor's portion of participant balances is subject to a progressive vesting schedule ranging from 10% upon completion of one year of service to 100% after completion of six years of service.

1. Description of Plan, continued

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$2,500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 2.25% to 8.0%, which is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum payment equal to the value of the participant's vested interest in his or her account as soon as practicable after the close of the Plan year in which termination occurred. Upon termination of service, death, disability, or retirement, a participant is required to take a mandatory distribution for participant balances of \$7,000 or less.

Forfeited Accounts

All forfeitures are applied to employer contributions. As of December 31, 2024 and 2023, forfeited accounts totaled \$267,569 and \$129,859, respectively. During the year ending December 31, 2024, forfeitures totaling \$111,660 were used to reduce employer contributions.

Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies, continued

Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan adoption agreement.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Plan, as provided by the Plan adoption agreement. All other administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 contributions to the applicable participants prior to March 15, 2025.

Subsequent Events

The Plan's administrator has evaluated subsequent events for accounting and disclosure requirements through October 8, 2025, the date that the financial statements were available to be issued.

3. Information Certified and Provided by Trustee and Custodian

The Plan's asset information included in this note and throughout the Plan's financial statements and the supplemental schedule was prepared by or derived from information provided by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower), the custodian of the Plan, and furnished to the Plan Sponsor. The Plan Sponsor has obtained certifications from the custodian that asset information provided to the Plan Sponsor by the custodian related to the asset information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Sponsor instructed the Plan's independent auditors not to perform any auditing procedures with respect to asset information in this note which appears throughout the financial statements and the supplemental schedule.

Empower also certified to the completeness and accuracy of \$5,622,844 of net realized and unrealized appreciation in the fair value of investments, \$2,875,103 of interest and dividends related to the investments and \$91,253 of interest related to the notes receivable from participants for the year ended December 31, 2024.

4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed annuity: Valued by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for the financial statement reporting purposes only. In determining the reasonableness of the methodology, the Plan evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing market data (for example, swap curve rate).

There have been no changes in the methodologies used as of December 31, 2024 and 2023.

4. Fair Value Measurements, continued

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

5. Exempt Party-in-Interest Transactions

Investment expenses paid to Central Bank amounted to \$178,021 for the year ended December 31, 2024.

Additionally, indirect fees are paid to Empower based on investment account values. The indirect fees range from 0.10% to 1.17% of the investment account value. The fees reduce net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

6. Tax Status

The Plan uses a prototype Plan document sponsored by Empower. Empower received an opinion letter from the IRS, dated November 14, 2022, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.
