Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 401(k) Plan for Employees of Matsuo Industries USA, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 401(k) Plan for Employees of Matsuo Industries USA, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A – DESCRIPTION OF PLAN

The following description of the 401(k) Plan for Employees of Matsuo Industries USA, Inc. (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Matsuo Industries USA, Inc. (Company) who have attained age 21 and have completed three months of service, and are not otherwise a part of an ineligible class of employees as outlined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a percentage of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Determined annually, the Company may contribute a matching contribution equal to a uniform percentage of each participant's salary deferral up to 6%. Participants direct the investment into various investment options offered by the Plan. The Plan currently offers various variable annuities and a group annuity fixed income account as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's other contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service unless employed on or after the normal retirement date (age 65), in which case, the participant is 100% vested immediately. In addition, on termination of service for death or disability, a participant becomes 100% vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by a percentage of the participant's vested account balance and bear interest at such a reasonable rate as determined periodically by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Payments from the Plan that are eligible rollover distributions may be made in the form of (1) a direct distribution to the participant or (2) a direct rollover to a traditional individual retirement account or another qualifying employer plan designated by the participant. If the participant does

not elect either form of distribution and the participant's vested account balance does not exceed the Plan's cash-out level (\$5,000), the Plan will distribute the balance without consent. If the distribution is not an eligible rollover distribution, the payment is made in a lump sum.

Forfeited Accounts

Forfeited nonvested accounts, if any, are to be used for the payment of Plan expenses first and then to offset any employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1 and \$3,249, respectively.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses had been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Although participant's accounts are charged with an allocation of some administrative expenses, the Company also typically absorbs certain costs of maintaining the Plan.

Date of Management's Review

Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENTS

Certain Plan investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE D – GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

In 2003, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract (Agreement) with Talcott Resolution Life Insurance Company (formerly named Hartford Life Insurance Company) totaling \$1,369,256 and \$1,437,889 for the years ended December 31, 2024 and 2023, respectively. Talcott Resolution Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Hartford Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may cause the contract to be discontinued. Such events include (1) the Plan fails to provide the information necessary to perform the Agreement and fails to remedy the failure within 31 days from the date notified, (2) the Plan trust is amended in a way that adversely affects the obligations under this Agreement, (3) all group variable funding agreements in this class of business are amended, changed or altered due to changes in any applicable laws and it is determined that obligations under this Agreement or its ability to maintain this class of business are thereby materially affected, (4) the assets held of the participants covered under

the Agreement are less than the amount or number required for the Agreement to be a group funding Agreement under any applicable insurance law, (5) the Plan changes such that it is no longer considered to be an entity which is authorized or eligible to sponsor the Agreement, (6) the Plan or Plan trust fails to maintain its special tax qualified or exempt status under 401(a) of the Code, or (7) at any time the contributions or balances are less than the amount required for this class of business under the underwriting standards in effect as of the Agreement effective date.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the aggregate value of their account regardless of years of service.

NOTE G – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan’s custodian and investment advisors are parties-in-interest under ERISA. Fees paid by the Plan to these service providers amounted to \$20,642 and \$17,492 for the years ended December 31, 2024 and 2023, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Employer by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
