### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Easterseals Arkansas 403(b) Plan (the Plan)**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **NOTE 1: DESCRIPTION OF THE PLAN**

The following description of the Easterseals Arkansas 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### **General**

The Plan, which was established January 1, 2009, and restated effective July 1, 2022, is a defined contribution plan maintained for the benefit of employees of Easterseals Arkansas (the Employer, Plan Sponsor and Plan Administrator). Generally, an employee is eligible to participate in the Plan upon the first day of employment with the Employer.

The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

The Employer utilizes the services of Transamerica Retirement Solutions, LLC (Transamerica) to process participant transactions and maintain participant account balances. State Street Bank and Trust is the Plan's asset custodian.

Certain duties related to the administration of the Plan are performed by employees of the Plan Sponsor; however, the Plan Sponsor does not charge the Plan for the estimated cost of such services. Certain other expenses related to the administration of the Plan are paid directly by the Employer and are not recorded as expenses in the Plan's financial statements. These expenses totaled approximately \$13,000 for the year ended December 31, 2024.

#### **Contributions**

Participants may contribute up to 100% of annual compensation pretax or post tax (Roth), as defined in the Plan, not to exceed limitations imposed by the Internal Revenue Service (IRS). The Plan includes an automatic enrollment provision, which provides that eligible employees are automatically enrolled as participants in the Plan at a salary deferral rate of 3% of eligible compensation, unless the employee elects otherwise. Participants may also contribute amounts from other qualified defined benefit or defined contribution plan (rollovers).

The Plan contains a matching formula where the Employer, at its discretion, may make a matching contribution to eligible employees based on the participant's years of service. A participant becomes eligible to receive an employer matching contribution on the first day of the month coinciding with or following the completion of 90 days of service. Only elective deferrals made after the entry date are considered for purposes of calculating the Employer match. A participant who dies, becomes disabled or retires after reaching normal retirement age during the Plan year is also eligible to receive the Employer matching contribution.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer's matching contributions and allocations of Plan earnings, net of certain administrative expenses. Allocations are generally based on participant account balances, as specified in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### NOTE 1: DESCRIPTION OF PLAN (Continued)

#### Vesting

Participants are fully vested at all times in their own contributions plus actual earnings thereon. A participant is fully vested in contributions made by the Employer, plus earnings thereon, when the participant attains retirement age, becomes disabled or dies. If a participant terminates employment for any other reason, he or she will vest in contributions made by the Employer, plus actual earnings thereon, according to the following schedule:

#### Investment Options

Contributions to the Plan are invested as directed by the participants in various mutual funds offered by the Plan. Participants may change their investment options at any time.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may range from one to five years. The loans are secured by the participant's account and bear interest at rates ranging from 6.50% to 9.50%, which is commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan Administrator. Principal and interest are paid through payroll deductions.

#### Forfeitures

The nonvested portion of a participant's account to which the participant is not entitled upon termination is deemed a forfeiture. As allowed under the Plan agreement, forfeitures are used to pay administrative expenses, reduce future employer matching contributions, or allocated to other participants. At December 31, 2024 and 2023, forfeitures totaling approximately \$201,000 and \$64,000, respectively, were available for future allocation. During the year ended December 31, 2024, there were no forfeitures used to pay administrative expenses, reduce employer matching contributions or allocated to other participants.

#### Payment of Benefits

Upon retirement or other termination of service due to death, disability or other reasons, a participant (or designated beneficiary) may elect to receive an amount equal to the vested value accumulated in his or her account in either a lump-sum payment, a rollover distribution to another qualified retirement plan, partial cash distributions or periodic payments. In the event a participant's account balance does not exceed \$1,000 at the time of termination, a distribution shall be made in the form of a lump-sum payment.

### **NOTE 1: DESCRIPTION OF PLAN (Continued)**

#### **Termination of the Plan**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for further discussion on the determination of fair value amounts.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes gains and losses on investments bought and sold, as well as those held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as investment expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid. There were no amounts allocated to withdrawing participants that have not been paid at December 31, 2024 and 2023.

#### **Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **NOTE 3: INFORMATION PREPARED AND CERTIFIED BY PLAN CUSTODIAN**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, all information pertaining to the Plan's investments, notes receivable from participants and the related activity reflected in the financial statements and supplemental schedule was provided and certified by the Plan's asset custodian, State Street Bank and Trust. This information was not subject to audit procedures except for comparing it to the related information included in the financial statements and supplemental schedule.

### **NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2      Inputs to the valuation methodology include the following:
  - Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets

- Inputs other than quoted prices that are observable for the asset or liability

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5: TAX STATUS**

Effective July 1, 2022, the Plan executed an adoption agreement for the Transamerica Volume Submitter 403(b) Plan (the Prototype). As an adopter of the Prototype, the Plan is not subject to tax under present income tax law.

The Prototype obtained its latest opinion letter on March 31, 2017, in which the IRS informed Transamerica that the Prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Prototype have been amended since receiving the

determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting standards require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. The Plan may be subject to audit by the IRS; however, there are currently no audits for any tax periods in progress.

### ***NOTE 6: RISKS AND UNCERTAINTIES***

The mutual funds in which the Plan's assets are invested are comprised of investment securities, which are exposed to various risks such as interest rate, market, and credit risks. In addition, certain mutual funds may include foreign debt and equity securities in their asset holdings. There are certain additional risks involved when investing in foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments, and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's financial statements.

### ***NOTE 7: SUBSEQUENT EVENTS***

Management has evaluated subsequent events through October 9, 2025, the date that the financial statements were available to be issued.
