*NOTES TO THE FINANCIAL STATEMENTS**December 31, 2024 and 2023*Note 1 – Description of Plan

The following description of Logical Systems, LLC 401 (K) (the “Plan”) provides only general information. Participants should refer to the plan document and the summary plan description for a more complete description of the provisions, which are available from the plan administrator.

General

The Plan is a defined contribution 401 (K) retirement plan available to all employees of Logical Systems, LLC (the “Company”) provided the employee is not a leased employee, a non-resident alien or member of a union. Employees may participate in the 401 (K) deferral component of the Plan immediately upon hire. Employees must complete one year of service and attain age 21 to become eligible for any Company contributions such as Safe Harbor Match and Discretionary Profit Sharing. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

The Plan allows participants to defer into the Plan the maximum allowed by the Internal Revenue Service (IRS) and also provides for a 4% safe harbor employer contribution. The Company makes a safe harbor contribution equal to 100% of the salary deferrals that do not exceed 3% of the employee’s compensation plus 50% of the salary deferrals between 3% and 5% of the employee’s compensations. The Plan also allows the Company to make discretionary profit-sharing contributions. Discretionary profit-sharing contributions were \$2,334,443 for 2024 and \$2,295,768 for 2023. The Company made a safe harbor contribution of \$907,206 for 2024. Forfeitures totaling \$51,030 and \$85,607 partially offset these contributions amounts for the 2024 and 2023 Plan years, respectively.

Participant Investment Account Options

The Plan allows participants to direct varying portions of their contributions and account balances among different mutual funds offered by American Funds.

Participant Accounts

Each participant’s account is credited with the participant’s deferral contributions, the Company’s discretionary matching contributions, the safe harbor employer contributions, and an allocation of the Company’s discretionary profit-sharing contributions, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*NOTES TO THE FINANCIAL STATEMENTS**December 31, 2024 and 2023*Note 1 – Description of Plan (Continued)*Vesting*

Participants are immediately vested in their deferral contributions and the safe harbor employer contribution, plus earnings thereon. Participants vest on a graduated scale in the Company's discretionary matching and profit-sharing contributions and related earnings or losses based upon years of service, with 100% vesting occurring after six years of service. In the event of death, disability, normal retirement age, or if the Plan is discontinued, participants may receive a distribution of the vested portion of some or all their accounts in the Plan.

Payment of Benefits

Upon termination of service for any reason, a participant will be entitled to receive only the "vested percentage" of their account balance. Participants may elect to have their vested account balance distributed to them as soon as administratively feasible following their termination of employment. However, if the value of their account balance does not exceed \$5,000, then a distribution will be made to them regardless of whether they consent to receive it.

Forfeitures

If an employee terminates before fully vested, the non-vested portion of their account will be forfeited on the earlier of the following dates:

- (a) of the distribution of their vested account balance, or
- (b) when they incur five consecutive 1-Year breaks in service.

If an employee receives a distribution of their vested account balance and are rehired, they may have the right to repay this distribution. If the entire amount of the distribution is repaid, the Company will restore their account balance with the forfeited amount.

Note 2 – Summary of Significant Accounting Policies*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities, changes therein

and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of benefits paid to participants are charged directly to the respective participant's account and are included in benefits paid to participants. Investment related expenses are included in net appreciation in fair value of investments.

Note 3 – Information Prepared and Certified by the Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rule and Regulations for Reporting and Disclosure under ERISA. According, Capital Bank & Trust, the custodian of the Plan, has certified the following data included in the accompanying financial statements and the supplemental schedule is complete and accurate:

- Investments at fair value
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted market prices that are observable of the assets or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If assets or liabilities have a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024, and 2023.

Mutual funds: Valued at the net asset value (NAV) of units of the collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchase and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4 – Fair Value Measurements (Continued)

In accordance with Subtopic 820-10, mutual funds that were measured at net asset value per share (or its equivalent) have not been classified within the fair value hierarchy.

The fair value of the investments in the mutual funds has been estimated using the net asset value of the investments. The mutual funds may be redeemed on a daily basis and do not have any redemption restrictions except as noted. Additionally, there are no unfunded commitments.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination participants would become 100% vested in their employer contributions.

The Internal Revenue Service (IRS) has determined that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and informed the sponsor of such in a letter dated June 30, 2020.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax period.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Note 9 – Subsequent Events

Plan management has evaluated subsequent events through October 9, 2024, which is the date that the financial statements were available to be issued. There were no significant matters identified for disclosure during this evaluation.
