We have performed an audit of the accompanying financial statements of Priority 401(k)/Profit Sharing Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **Note 1 - Description of Plan**

The following description of the Priority 401(k)/Profit Sharing Plan (“Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan was intended to meet the requirements of Section 401(a) of the Internal Revenue Code (IRC) and qualify as a defined contribution plan and was established to provide retirement benefits to eligible employees of Priority Acquisition Company, LLC (“Company”).

The assets of the Plan were held for the exclusive benefit of the participating employees. An employee was eligible to participate in the elective deferral and employer matching after they had attained the age of 21. An eligible employee’s entry date into the Plan was the first day of the Plan year quarter coinciding with the date they satisfied the eligibility requirement. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

In June 2024, the Plan’s sponsor, Priority, LLC, was acquired by Stratus Unlimited, LLC. As part of the acquisition the Plan’s net assets available for benefits were transferred to the Stratus Unlimited, LLC 401(k) Plan on December 31, 2024. The 2024 financial statements of the Plan include the changes in net assets available for benefits for 2024 and the transfer out of the Plan’s net assets available for benefits on December 31, 2024 (see Note 7).

#### **Contributions**

The Plan allowed participants to make pre-tax contributions of up to 100 percent of their base salary, subject to certain IRC limitations (\$23,000 for 2024) in each calendar year. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions up to \$7,500 in 2024. Employee contributions were fully vested.

The Company could make a matching contribution on behalf of a participant. Matching contributions for the years ended December 31, 2024 and 2023 equaled 50 percent of the participant’s contribution up to six percent of the participant’s eligible compensation each period.

The Plan also accepted rollovers from other tax-qualified plans.

#### **Participant Accounts**

Participants were allowed to direct their account balance, their contributions and employer contributions into any of the investment options available.

Each participant's account was credited or charged with the participant's contribution and the employer's matching contribution and an allocation of Plan investment income or loss. Participants shared pro rata in any investment income or loss of the funds, based upon individual participant account balances in the respective funds as of the end of each day. Each participant's account could also be charged with an allocation of the Plan's administrative expenses.

Except for fees attributable to particular participants, administrative expenses were allocated pro rata based on individual participant account balances.

#### **Vesting**

A participant is always fully vested in participant and rollover contributions. Employer matching contributions plus actual earnings thereon vested based on a participant's years of service, vesting at a rate of 20 percent per year upon completing two years of service so that a participant becomes fully vested after six years of service.

#### **Payment of Benefits**

In the event of normal retirement, death, or permanent disability, a participant was entitled to receive the entire amount credited to the participant's account. If employment was terminated for any other reason, a participant was entitled to the vested portion of the account.

#### **Notes Receivable from Participants**

Participants could borrow from their accounts a minimum of \$1,000 not to exceed the lesser of \$50,000 or 50 percent of their vested balance. The notes were secured by the balance in the participant's account and bore interest at two percent above the prime rate. Notes were repaid by payroll deductions. The interest rates on notes receivable from participants ranged from 5.25 percent to 10.5 percent at December 31, 2024.

Upon participant termination or retirement, the outstanding loan balance was treated as a distribution to the participant if repayment was not made by the participant, or if an on-going repayment arrangement was not made with the Plan. Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were recorded as distributions based on the terms of the Plan document.

#### **Notes Receivable from Participants (Continued)**

Notes receivable from participants totaling \$179,654 were transferred from the Plan to the Stratus Unlimited, LLC 401(k) Plan on December 31, 2024 (see Note 7).

#### **Forfeited Accounts**

The Plan provided that upon a participant's termination for reasons other than retirement, death or disability, the participant's non-vested funds are forfeited. Forfeited amounts from employer matching contributions were used to pay plan expenses or reduce Company matching contributions. During the year ended December 31, 2024, \$602 of forfeitures were used to reduce Company matching contributions and \$32,208 of forfeitures were used to reduce Plan expenses. At December 31, 2023, forfeited non-vested accounts totaled \$46,727. There were no forfeited non-vested accounts at December 31, 2024.

#### **Plan Merger**

As a result of Priority, LLC being acquired by Stratus in 2024, the Plan will merge with the Stratus Unlimited, LLC 401(k) Plan (see Note 12).

### **Note 2 - Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP"). The financial statements have been prepared to satisfy the reporting and disclosure requirements of ERISA.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Benefits Paid to Participants**

Benefits were recorded when paid to participants.

#### Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the plan's gains and losses on investments bought and sold as well as held during the year.

#### Administrative Expenses

Plan related expenses, consisting primarily of record keeping, administrative fees, custodian fees, and other professional fees were paid for by the Plan and have been recorded as administrative expenses on the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are also included in administrative expenses. Expenses related to investments were included in net appreciation of fair value of investments.

#### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Note 5 - Guaranteed Investment Contract**

The Voya Fixed Account (4450) (“VFA”) was a fully benefit-responsive guaranteed investment contract with Voya. Contributions to the VFA were maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a minimum rate of interest. Voya could credit interest at a current rate higher than the guaranteed minimum interest rate. The guaranteed minimum interest rate and the current rate were expressed as annual effective yields. For the year ended December 31, 2024, the declared rate was 1.65 percent. The interest rate credited to participant accounts was guaranteed not to be below one percent.

The VFA was included in the financial statements at contract value as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There were no reserves against contract value for credit risk. There were no unfunded commitments.

Certain events could limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (2) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (3) premature termination of the contract.

### **Note 6 - Administration of Plan Assets**

The Plan assets were held and managed by Voya as of December 31, 2024 and 2023 and for the year ended December 31, 2024. Voya invested cash, interest and dividend income as directed by the participants of the Plan. On December 31, 2024, the Plan’s net assets available for benefits were transferred to the Stratus Unlimited, LLC 401(k) Plan (see Note 7).

### Note 8 - Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As such, transactions conducted by Voya qualified as party-in-interest transactions.

The Plan paid for expenses related to its investment activity and plan operations. Those transactions qualified as party-in-interest (see Note 2 - administrative expenses).

### Note 9 - Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

### Note 10 - Tax Status

The Plan adopted the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/Cash or Deferred Arrangement (CODA) which has a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. This opinion letter states that the form of the Plan was acceptable under Section 401 of the Code. The Company may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations. Once qualified, the Plan was required to operate in conformity with the Code to maintain its qualification. The Company believes that the Plan was being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.
