## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
BEREXCO LLC 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of BEREXCO LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Empower Retirement, a division of Empower Annuity Insurance Company of America, the custodian of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTE A - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of BEREXCO LLC (the Company), who have completed one year of service and have attained age 18. For plan eligibility purpose, employees will be credited with a year of service at the end of the twelve-month period beginning on their date of hire if they have been credited with at least 500 hours of service during such period. Employees become eligible to participate in the Plan on the first day of the month following the date on which eligibility requirements are met. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides that active participants may make annual pre-tax and Roth after-tax contributions of not less than 1% up to 75% of their eligible compensation to the Plan. Compensation includes overtime pay and bonuses. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Contributions are subject to certain Internal Revenue Code limitations.

The Plan has an automatic deferral feature whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The rate increases by 1% each year until it reaches 6%. Deferral will be invested in a designated balanced fund until changed by the participant.

The Plan is a Qualified Automatic Contribution Arrangement (QACA) Safe Harbor Plan. The Company will make a safe harbor matching contribution in an amount equal to a percentage of employees' elective deferrals. The safe harbor match was \$662,507 for the year ended December 31, 2024. The specified matching percentage for the corresponding level of elective deferrals is shown in the following table.

Each year, the Company may make a discretionary additional matching contribution up to 4% of participants' compensation or a discretionary nonelective contribution. There was no discretionary additional matching contribution or nonelective contribution for the year ended December 31, 2024.

NOTE A - DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's deferral and an allocation of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

Forfeitures of terminated participants' nonvested accounts are used to pay reasonable plan expenses or to reduce future employer contributions. \$14,426 of forfeitures were used to reduce plan expenses during 2024. Unallocated forfeitures at December 31, 2024 and 2023 were \$14,516 and \$8,978, respectively.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Note terms can range from 1 - 15 years. The notes are secured by the balance in the participant's vested account and shall bear a reasonable rate of interest based on current external market rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants immediately vest in their elective deferrals and rollover contributions plus actual earnings thereon. Participants shall be fully vested with respect to Company contributions upon normal retirement age, disability or death.

Vesting in the Company's matching contribution portion of their account is as follows:

Vesting in the Company's matching contribution for participants who were not employed by the Company on January 1, 2020 follows a 6-year graded schedule. Vesting in the Company's discretionary additional or nonelective matching contribution also follows a 6-year graded schedule. Participants receive credit for one year of service for each plan year, provided 1,000 or more hours of service were completed during the plan year.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reason, participants with vested balances of less than \$7,000 will receive a lump-sum amount equal to the participant's vested account. Participants with vested balances in excess of \$7,000 may elect to receive a lump-sum amount, installments or any combination thereof.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Method

The financial statements of the Plan have been prepared using the accrual method of accounting and present the net assets available for plan benefits and changes in those net assets based on fair value.

Investments

All investments are stated at fair value, which is based on quoted market prices. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid. There were no withdrawals requested but unpaid at December 31, 2024.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

NOTE C - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's account shall be fully vested and nonforfeitable.

NOTE D - PLAN EXPENSES

Certain administrative expenses for the Plan are paid directly by the Company and are excluded from these financial statements.

NOTE E - CONCENTRATIONS

Four funds or investment accounts with the highest value comprised approximately 49% and 46% of net assets available for benefits as of December 31, 2024 and 2023, respectively.

The fair value of the cash equivalent and mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The fair value of the guaranteed interest account is reported daily based on the contract value provided by The Lincoln National Life Insurance Company.

During 2024, the Plan transferred \$1,489,688 from Level 1 to Level 2 and \$1,494,977 from Level 2 to Level 1 based on participants' investment options. Transfers are recognized on a daily basis.

NOTE G - TAX STATUS

The IRS has determined and informed the prototype's sponsor by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTES TO FINANCIAL STATEMENTS

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J - RELATED PARTY TRANSACTIONS

Plan investments are in custodial control and managed by Empower Retirement, the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest.

The Plan issues notes to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party in interest transactions.

During 2024, distributions made by the plan Trustee totaled \$30,000.

NOTE K - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY  
(GUARANTEED INTEREST ACCOUNT)

Included in the Plan investment options are Guaranteed Interest Accounts which are fully benefit-responsive traditional group annuity investment contracts with The Lincoln National Life Insurance Company (Lincoln Insurance). The contracts maintain the contributions in pooled separate accounts and are presented at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Lincoln Insurance is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Lincoln Insurance's ability to meet its financial obligations. Lincoln Insurance's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with Lincoln Insurance. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the Plan to terminate the agreement without at least twelve months advance written notice.
