Independent Auditor's Report

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Meridian Behavioral Health, LLC 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Notes to the Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following brief description of the Meridian Behavioral Health, LLC 401(k) Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

General

The Plan is a defined contribution plan with a 401(k) provision covering substantially all employees of Meridian Behavioral Health, LLC (the "Employer"). Excluded employees are individuals under collective bargaining agreements, nonresident aliens who do not receive any compensation from U.S. sources, leased employees, interns and on-call employees. Employees who have completed 500 hours of service within the first six months or one year of service and are age 21 and older are eligible to participate in the Plan. The Plan was amended effective September 1, 2024, to allow employees who are at least 18 years old and have completed six months of service to participate. A subsequent amendment, effective January 16, 2025, revised the eligibility requirements to include all employees aged 18 and older, regardless of length of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and the Internal Revenue Code ("IRC").

Contributions

Participants may elect to defer eligible annual pretax compensation and post-tax salary reduction contributions into the Plan's Employee Roth Contributions account, in addition to, or in lieu of the pretax salary reduction contributions, subject to maximum amounts established by the IRC. Participant contribution elections may be changed upon notice to the Plan Administrator.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution and the allocation of Plan earnings; each participant account is charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Certain expenses and administrative costs incurred in connection with the general administration of the Plan are paid out of Plan assets.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the discretionary employer matching and profit-sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant becomes 20% vested after two years of credited service, increasing 20% for each additional year of credited service until year six when the participant is 100% vested. However, if an active participant dies or becomes permanently disabled prior to attaining the normal retirement age, the participant's account becomes 100% vested.

Notes Receivable From Participants

The Plan does not allow Participants to take a loan from the Plan.

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used to fund future Employer contribution or pay Plan expenses. There were approximately \$40,000 in forfeitures used to pay Plan expenses during the year ended December 31, 2024. Forfeited nonvested accounts totaled approximately \$65,000 and \$69,000 as of December 31, 2024 and 2023, respectively.

Payment of Benefits

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Certain mandatory distribution provisions may apply for smaller account balances of terminated employees.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Accounting Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with US GAAP. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for a discussion of fair value measurements.

Payment of Benefits

Benefit payments are recorded when paid.

Distributions Payable

Excess contributions as a result of a failed non discrimination test were paid in the form of distributions payable during 2025 and 2024. These transactions were accrued as of December 31, 2024 and 2023, the dates of the non discrimination tests.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Plan or the Employer, as provided in the Plan document. Administrative expenses paid by the Employer are excluded from these financial statements. Management fees and operating expenses for investments are charged to the Plan and are not separately reflected.

Fair Value of Financial Instruments

The Company's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds

Mutual funds are valued at the quoted market price.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Subsequent Events

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through September 24, 2025, the date which the financial statements were available to be issued.

3. Certification of Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's trustee (John Hancock Trust Company, LLC) has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

5. Fully Benefit-Responsive Investment Contract

Under group annuity contracts with Empower Annuity Insurance Company and John Hancock Trust Company, LLC, the Plan invests contributions in the Key Guaranteed Portfolio Fund and the Putnam Stable Value Fund. These funds are fixed annuity general account products and meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The Plan held approximately \$60,000 and \$96,000 of traditional investment contracts at contract value at December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the their-party issuer's ability to meet its financial obligation. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probably that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. The group annuity contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. Related-Party and Party-In-Interest Transactions

Substantially all expenses pertaining to the operation of the Plan are paid by the Employer. Additionally, various administrative, legal and accounting services are performed by Employer personnel on behalf of the Plan, for which no charges are made to the Plan and for which the Employer does not intend to obtain reimbursement. Investment expenses are charged against the Plan's investment results. Certain Plan investments are shares of mutual funds managed by a related party to John Hancock Trust Company, LLC, the custodians of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

7. Tax Status

The Plan has adopted a non-standardized pre-approved sponsored by the TSC INC. which received an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of American require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risk factors in the near term could materially affect the amounts reported in the financial statements.

9. Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their Employer contributions, and the Plan assets will be distributed according to the provisions of the Plan documents.

11. Secure 2.0

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2020 CARES Act. Most of the provisions of SECURE 2.0 will become effective in 2024 and beyond. Effective January 1, 2024 the Plan adopted following provisions:

- Federally Declared Disaster Loans: Eligible participants may borrow up to the lesser of \$100,000 or 100% of their vested account balance. Loan repayments may be delayed up to one year. Loans must be issued within 180 days of the applicable disaster date.
- Federally Declared Disaster Withdrawals: Participants affected by a federally declared disaster may withdraw up to \$22,000, exempt from the 10% early withdrawal penalty. Withdrawals may be repaid within three years and are includable in taxable income over three years if not repaid.
- Domestic Abuse Withdrawals: Participants may withdraw the lesser of \$10,000 or 50% of their vested account balance if they self-certify as victims of domestic abuse. These distributions are penalty-free, not subject to 20% withholding, and may be repaid within three years.
