Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Sansum Clinic Match Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Sansum Clinic Match Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of Sansum Clinic Match Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Sansum Clinic Match Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 10 to the financial statements, the Sansum Clinic Match Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. If the identified contracts, as reported by the custodian, were included, net assets available for benefits would increase by approximately \$931,000 and \$986,000 as of December 31, 2024 and 2023, respectively. Investment income of approximately \$78,000 and distributions of approximately \$144,000 related to such accounts, as identified by the custodian, have also been excluded in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. Accounting principles generally accepted in the United States of America (GAAP) require that these accounts and the related income and distributions be included in the accompanying financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Sansum Clinic Match Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of Sansum Clinic Match Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Sansum Clinic Match Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matter

Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to, and we do not, express an opinion on the supplemental schedule.

Note 1 – Description of the Plan

The following description of the Sansum Clinic Match Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of Plan provisions.

General – The Plan is a 403(b) salary deferral plan covering substantially all employees of Sansum Clinic (the Sponsor) and is subject to provisions of the Employee Retirement Income Security Act of 1974(ERISA). The Sponsor serves as Plan administrator. All investments are participant-directed. Lincoln Financial Group Trust Company, Inc. (Lincoln Alliance) serves as the custodian for the Plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (the IRC).

Freezing of Plan – Effective September 15, 2024, the Board of Directors of the Sponsor voted to freeze the Plan. No new participants may enter the Plan and no additional participant contributions may be made to the Plan. All participant account balances and earnings thereon are 100% vested.

Eligibility – Employees are eligible for elective deferrals immediately upon hire. Employees are eligible to receive employer matching contributions and discretionary contributions after completing two years of service (minimum 1,000 hours per year) and upon reaching age 18. Employees who were rehired are immediately eligible upon rehire if they were eligible during their previous employment with the Sponsor.

Participant contributions – Participants may contribute deferrals of up to 100% of pre-tax and/or after-tax annual compensation, as defined in the Plan, subject to certain IRC limitations. The Plan is set up for automatic deferral wherein participants who have otherwise satisfied the eligibility requirements but have not entered into a salary reduction agreement will automatically defer 2% of compensation into the Plan.

Employer contributions – The Sponsor may elect to make matching and discretionary contributions to the Plan. If the Sponsor elects to make matching contributions, the match is 2% of compensation for participants with two to six years of service, 3% of compensation for participants with six to ten years of service, and 5% of compensation for participants with ten or more years of service. The matching contribution shall be allocated to active participants each pay period, based on deferrals made in that pay period. For the purposes of matching contributions, the limit of pre-tax and/or after-tax deferral to be matched is at the discretion of the Sponsor. Discretionary contributions may be made in such amounts as determined by the Sponsor. Allocation of the discretionary contributions will be made in the ratio that each active participant's compensation for the Plan year bears to the total compensation of all active participants for the Plan year. There were no discretionary contributions during the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant's account is credited with the participant's contributions, the Sponsor's matching and discretionary contributions, if any, and an allocation of Plan earnings or losses and charged with participant's administrative expenses. Allocations are based on account balances. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Sansum Clinic Match Plan Notes to Financial Statements

Vesting – Participants are fully vested in all contributions plus actual earnings thereon at all times.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account balance or substantially equal installments over a period elected by the participant. In-service distributions will be permitted only to participants who have attained age 59½. Distributions on account of hardship are also permitted, but only with respect to amounts which are not held as security for a loan.

Transfer of Plan assets to qualified plans – Effective October 7, 2024, individual participants are allowed to transfer assets from the Plan to other qualified plans offered by the Sponsor and affiliated entities, subject to Plan provisions. These are considered transfers of assets as the participant did not have a distributable event from the Plan.

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$1,000, up to a maximum of the lesser of \$50,000 or 50% of their account balance, reduced by their highest outstanding loan balance. Loans are secured by the balance of the participant's account and bear fixed, reasonable rates of interest, as determined by the Plan administrator. The maximum loan term is five years unless the loan is for the purchase of a home, in which case the term of the loan is not to exceed thirty years. As of December 31, 2024, the rates of interest on outstanding loans ranged from 5.25% to 10.5% with various maturities through June 2036.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value and contract value. The Plan's custodian, Lincoln, certifies the contract value of the fixed annuity contract on behalf of Lincoln National Life Insurance Company and the fair market value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes to Financial Statements

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement.

Payment of benefits – Benefits are recorded when paid.

Expenses – Administrative expenses related to operating and maintaining the Plan are paid by the Sponsor; certain investment and transaction fees are paid by participants in the Plan.

Note 3 – Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Units held in registered investment companies are valued using the net asset value (NAV) of the fund, which is valued based on quoted market prices.

Note 4 – Group Fixed Annuity Contract

The unallocated group fixed annuity contract is a fixed annuity contract issued by Lincoln National Life Insurance Company, which guarantees a fixed rate of interest and is backed by the general assets of the issuing company. Due to the nature of these contracts, they do not have specific underlying assets assigned. Unallocated group fixed annuity contracts are between the Plan and the issuer and may not be assigned or sold to another party without the consent of the issuer. The fixed annuity contract is reported at contract value. The contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals.

In addition, the fixed annuity contract allows money to be withdrawn without surrender charges or a market value adjustment for loans, hardship needs, death, retirement or disability benefit, and termination of employment. The fixed annuity contract limits the percentage of the Fixed Account value available for periodic elective transfers to variable accounts within the same Lincoln contract during any 12-month period.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The guaranteed fixed annuity contract guarantees principal and pays a guaranteed minimum interest rate during the accumulation phase, which generally has been 3%. Additional interests may be declared at the discretion of the Lincoln Board of Trustees on an annual basis and remain in effect for the declaration year that begins each March 1 and are not guaranteed for future years. The guaranteed minimum and additional amounts make up the crediting rate.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer. No such events occurred in 2024.

Note 5 – Tax Status

The Plan Document is a volume submitter 403(b) tax deferred annuity plan that received a favorable opinion letter from the Internal Revenue Service dated March 31, 2017, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, management has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.

Note 7 – Information Certified by the Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan, Lincoln Financial Group Trust Company, Inc., has certified to the completeness and accuracy of:

- Investments and notes receivable from participants on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, interest income on notes receivable from participants, dividends, and interest reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the supplemental schedule of assets (held at end of year).

Note 8 – Party-in-Interest Transactions

Parties-in-interest are defined under Department of Labor regulations as fiduciaries of the Plan, any party rendering services to the Plan, the employer, and certain others. The Plan pays expenses to the Plan's operations and investment management to various services providers. Plan investments include the Lincoln Fixed Annuity Fund, which is an unallocated contract managed by Lincoln National Life Insurance Company. Lincoln Retirement Services Company, LLC is the recordkeeper of the Plan and an affiliate of Lincoln Financial Group Trust Company, Inc., and Lincoln National Life Insurance Company; therefore, transactions with these entities qualify as exempt party-in-interest transactions. Fees paid to Lincoln National Corporation were \$140,764 during the year ended December 31, 2024.

Note 9 – Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right to terminate the Plan and discontinue its contributions at any time subject to Plan provisions.

Note 10 – Investments/Activity Excluded from Financial Statements Under DOL FAB No. 2009-02

The Plan has elected to exclude certain annuity and custodial accounts from the statements of net assets available for benefits as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The contracts meet all of the following criteria for exclusion:

- The accounts were issued to current or former employees before January 1, 2009;
- The Sponsor has ceased to have any obligation to make contributions (including employee salary reduction contributions) and in fact ceased making contributions to the accounts before January 1, 2009;
- All of the rights and benefits under the accounts are legally enforceable against the custodians by the individual owners of the accounts without any involvement by the Sponsor; and

- The individual owners of the contracts are fully vested in the accounts.

If the identified contracts, as reported by the custodian, were included in the statements of net assets available for benefits, the net assets available for benefits would increase by approximately \$931,000 and \$986,000 as of December 31, 2024 and 2023, respectively. If the activity of the identified contracts, as identified by the custodian, was included in the statement of changes in net assets available for benefits, investment income would increase by approximately \$78,000 and distributions would increase by approximately \$144,000 during the year ended December 31, 2024.

Note 11 – Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are issued.

Effective April 3, 2025, Plan assets from Sansum Clinic Match Plan merged into the Sutter Health 403(b) Savings Plan from Lincoln Alliance in the amount of \$57,386,702. The merged Plan assets consist of the Lincoln Fixed Annuity contract to be liquidated over a five-year installment period.

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

Note 12 – Reconciliation to Form 5500
