### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Haynes and Boone, LLP Partners' Cash Balance Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits and of Accumulated Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits and of Changes in Accumulated Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## 1. Description of Plan

The following description of the Haynes and Boone, LLP Partners' Cash Balance Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a noncontributory defined benefit, cash balance plan covering Partners of Haynes and Boone, LLP (the Firm or Employer) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established effective January 1, 2014, as restated January 1, 2020, and is funded entirely by contributions to a trust made by the Firm. The Plan is administered by the Retirement Committee whose members are appointed by the Executive Committee of the Firm, are responsible for oversight of the Plan. The Plan's Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### Funding Policy

The Plan's funding policy is for the Firm to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. The minimum funding requirements of ERISA were met in 2024. Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### Participation and Eligibility

A Partner who was a Partner and had completed two years of eligible service, as defined, as of January 1, 2014, became a participant (Partner or Participant) in the Plan as of January 1, 2014. Thereafter, a Partner of the Firm who completes two years of eligible service is eligible to begin participating in the Plan on either January 1, February 1 or July 1 next following the date the service requirement is satisfied. A Participant who ceases to be a Partner but does not terminate service with the Firm will cease to earn additional benefits under the Plan but will not lose benefits previously earned. Participants in the Plan who continue to serve as a Partner past the normal retirement age, as defined, will continue to earn benefits under the Plan.

### Contributions

A notional account (Cash Balance Account) is maintained for each Participant in the Plan. Each Participant, who remains a Partner through the end of the Plan year, will receive an "Annual Pay Credit" to their Cash Balance Account based on various factors such as the applicable schedules assigned by the Firm, attained age and projected Partner compensation. Participants' Cash Balance Accounts are also credited with "Interest Credits" on each valuation date (Valuation Date) during the Plan year. The Valuation Date represents the date on which Charles Schwab Trust Bank, the Trustee, reports a change in investment values. The Interest Credit represents the rate of return on investments held by the Plan as of the beginning of the Valuation Date. For each Valuation Date during the plan year, the Participants' Interest Credit shall be a minimum of 1.5% annualized rate of return (the Minimum Interest Credit) and shall not exceed 7% annualized rate of return (the Maximum Interest Credit). The Plan's actuary determines the actual contribution required by the Firm in order for the Plan to satisfy the Plan's accumulated Plan benefits which are based on such credits. The Valuation Date for new pay credits earning Interest Credits is June 15.

## Actuarial Method

The Plan obtains an actuarial valuation each year from an independent third-party actuary. The valuation is used to determine whether anticipated benefits may reasonably be provided from anticipated contributions when combined with existing assets of the Plan.

## Payment of Benefits

Normal Retirement Benefits are payable as soon as administratively possible after a Participant reaches the Normal Retirement Date (defined as the later of the first day of the calendar month following the month in which the Participant reaches age 62 or completes three years of eligible service). Normal Retirement Benefits are paid if one of the following terms are met: (1) a Participant terminates service from the Firm before reaching Normal Retirement Date and did not request payment before the Normal Retirement date, (2) a Participant ceases being a Partner before Normal Retirement Date but remains with the Firm until the Normal Retirement Date, or (3) a Participant is still a Partner on the Normal Retirement Date and the Participant elects to receive payment of the Cash Balance Account on the Normal Retirement Date.

Benefits payable due to termination of service for any reason other than death are paid or commenced on the Normal Retirement Date unless an election in writing to receive or commence payment of the Cash Balance Account prior to the Normal Retirement Date has been signed by the Participant. The Plan's normal form of benefit is an annuity. Upon a participant's termination of employment with the Employer, the Participant may request to receive, or commence to receive, a distribution of the vested benefits accrued under the Plan. However, if the lump sum value of such participant's vested accrued benefit does not exceed \$1,000, then the participant will automatically receive the amount of his Cash Balance Account in the form of a single lump sum cash payment.

Participants may elect to have all or a portion of their account rolled directly over to the Haynes and Boone Investment Directed Profit Sharing Plan, another qualified retirement plan that accepts rollover contributions, or an individual retirement account at a financial institution. A Participant who remains in service after attaining age 59½ may elect to receive an in-service distribution.

Participants in the Plan are 100% vested in accrued benefits at all times.

## Death and Disability Benefits

Death benefits are payable as soon as administratively possible following the Participant's death and are payable on the first day of the month following the Participant's death. The Plan does not provide for disability benefits.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

## Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Payment of Benefits

Benefits payments to participants are recorded upon distribution.

## Administrative Expenses

The Plan's expenses are paid either by the Plan or the Firm, as provided by the plan document. Expenses that are paid directly by the Firm are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits.

## Recent Accounting Standards

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## Subsequent Events

Subsequent events were evaluated through October 10, 2025, the date the financial statements were available to be issued.

## 3. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on projected net income and age attained during the Plan year. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances, such as retirement, death, and termination of employment, are included, to the extent they are attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated plan benefits.

The actuarial present value of accumulated plan benefits is determined by the Plan's independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal or retirement) between the valuation date and the expected date of payment.

The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2025 and 2024. Had the valuations been performed as of December 31, 2024 and 2023, respectively, there would be no material differences.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

## 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds of registered investment companies and exchange traded funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## 6. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Charles Schwab Trust Bank, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the information reported in the supplemental Schedule H, Line 4(j) - Schedule of Reportable Transactions for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

## 7. Related-Party and Party in Interest Transactions

Certain administrative functions of the Plan are performed by an officer or employees of the Firm. No such officer or employee receives compensation from the Plan.

## 8. Plan Termination

Although it has not expressed any intention to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, distribution of the Plan assets shall be made to the participants according to the provisions in the plan document. If the Plan is terminated, a portion of those benefits are insured by the Pension Benefit Guaranty Corporation (PBGC). Whether a particular participant's accumulated plan benefits will be paid depends on both the priority of those benefits and the level of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guarantee, while other benefits may not be provided for at all.

## 9. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Firm by a letter dated March 18, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position and that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, concentration, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

The effective date of the plan was January 1, 2014. For purposes of this actuarial valuation, the plan was last amended effective January 1, 2023.

## **PLAN YEAR**

January 1 to December 31.

## **CASH BALANCE ACCOUNT**

The sum of Cash Balance Credits and Earnings Credits. As of January 1, 2024, Cash Balance Accounts, excluding Cash Balance Credits for the year, totaled \$66,901,495.

## **CASH BALANCE CREDITS**

Cash Balance Credits shall be credited to eligible participants' Cash Balance Accounts for the year, based on the plan document's provisions. For the 2024 plan year, Cash Balance Credits are estimated to total \$14,059,422.

## **EARNINGS CREDITS**

Earnings Credits shall be credited to participants' Cash Balance Accounts based on the rate of return on plan assets, subject to a cumulative maximum of 7.00% and a cumulative minimum of 1.50%. As of the participant's benefit commencement date, in no event shall cumulative Earnings Credits during a participant's period of plan participation be less than \$0.

## **NORMAL RETIREMENT DATE**

The first of the month next following the month a Participant attains the later of age 62 and three years of eligibility service.

## **BENEFIT AMOUNT**

The Cash Balance Account, or its actuarial equivalent payable as an annuity, subject to IRS maximums. Benefits are payable immediately following termination of employment or while in service for participants who have reached age 59.5.

## **VESTING**

Each participant is always 100% vested in his or her Cash Balance Account.
