NOTE 1 - DESCRIPTION OF PLAN

The following description of the Welch Packaging Group, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan that was established January 1, 1986 to provide for retirement benefits. The Plan covers substantially all full time employees of Welch Packaging Group, Inc. (the "Company" or "Employer") who have six months of service, are age 21 or older and are not covered by a collective bargaining agreement with the Company. The plan automatically enrolls all employees, once they become eligible, unless the participant declines, and withholds 3% of participant compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Company contributions are made at the discretion of the Company's Board of Directors, but cannot exceed amounts deductible for federal income tax purposes. Participants may contribute any amount of compensation not to exceed the limits set by the Internal Revenue Code ("IRC"). The Plan also allows catch-up contributions under Code Section 414(v) for those participants who have attained age 50 by the close of the Plan year. Company matching contributions were 50% of the first 8% of the compensation deferred for the year ended December 31, 2024.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their account plus earnings thereon is based on years of continuous service. A participant is partially vested after 2 years and vesting is increased each year thereafter and are 100% vested after 6 years of credited service.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement. A participant is entitled to his or her vested account balance upon death or disability.

Forfeitures: At December 31, 2024 and 2023, there were no balances in forfeited non-vested accounts. These amounts have been used to reduce employer contributions. During the year ended December 31, 2024, \$198,901 was applied to offset employer contributions receivable reflected in the financial statements.

Payments of Benefits: On termination of service, a participant may elect to receive either a lump sum or direct rollover amount equal to the value of his or her vested interest in the account, or upon death, disability or retirement, elect to receive substantially equal installments over a period of time.

Participant Accounts: Each participant's account is credited with the participant's own contribution and an allocation of (a) the Company's contribution, (b) Plan earnings and (c) forfeitures of terminated participants' non-vested accounts, and is charged with his or her withdrawals and an allocation of Plan losses and administrative expenses. Participants are not entitled to an allocation of employer contributions or forfeitures unless they are employed on the last day of the Plan year, however, a participant who terminates after normal retirement age, death or disability is entitled to receive an allocation of employer contributions or forfeitures. Participants are always entitled to an allocation of earnings/losses at each valuation date until the benefit is paid out. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants: The Plan allows participants to borrow funds against their account balances, subject to certain limitations prescribed by the IRC. The amount of the notes is limited to the lesser of \$50,000 or 50% of the participant's vested account. Loan terms range from 1-5 years and up to 10 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid through payroll deductions.

Administrative and Investment Management Expenses: Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the financial statements as administrative expenses of the Plan. The Plan's recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation in fair value of investments reported by the Plan. All other expenses of the Plan are paid by the Company.

Investment Options: Upon enrollment in the Plan, a participant may direct participant and employer contributions in any of the investment options provided by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principles and policies that significantly affect the determination of net assets available for benefits and changes therein are summarized below.

Basis of Accounting: The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Risks and Uncertainties for Investments: The Plan provides for certain investments. The underlying investments are exposed to various risks, such as interest rate, market, global events, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Benefit Payments: Benefit payments are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, the custodian of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds – The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Company has adopted the Ascensus, LLC non-standardized prototype plan. The Internal Revenue Service has determined and informed Ascensus, LLC, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that the related Plan is exempt from income taxes.

NOTE 5 - TAX STATUS (Continued)

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - PARTIES-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Administrative expenses paid to Ascensus, LLC and Lake City Bank, trustee of the Plan, are considered party-in-interest transactions. Investment management fees are paid by the Plan to the investment managers which are parties-in-interest. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

NOTE 7 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 3, 2025, which is the date the financial statements were available to be issued.

Effective March 1, 2025, Ascensus Trust Company replaced Lake City Bank as the trustee of the Plan.

Effective March 1, 2025, the Plan was amended and significant changes to Plan provisions include a change in service requirements for participation in the Plan from six months to two months of service and 100% vesting of a participant account balance upon death or disability.
