NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 and 2023

1. Description of the plan

The following brief description of the McGrath Automotive Group, Inc. 401(k) Plan (the “Plan”), a contributory defined contribution plan, is provided for general information purposes only. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan’s provisions.

The Plan covers all non-union employees of McGrath Automotive Group, Inc. and affiliates (collectively, the “Company” or “Plan Sponsor”) who are at least twenty years of age and have completed one year of service, defined as 1,000 hours of service during any consecutive twelve-month period. Effective January 1, 2024, the definition of one year of service no longer requires 1,000 hours of service. Employees become participants on January 1, April 1, July 1 or October 1 following meeting age and service eligibility requirements. The Plan allows participants to designate all or a portion of their elective deferrals as Roth elective deferrals. Roth elective deferrals are accounted for separately in the respective participant’s account. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

The Plan is funded by contributions from participants in amounts up to 100% of eligible compensation limited to the maximum amount deductible by employee salary reduction under the Internal Revenue Code. Participants are automatically enrolled with a 3% deferral rate on the first day of the quarter following meeting the age and service requirements, if no election is made by the participant. The deferral rate for those automatically enrolled increases 1% each year thereafter until the maximum deferral rate of 10% is reached. Participants who attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan is also funded by Company matching contributions and discretionary contributions. During 2024 and 2023, the Company made matching contributions equal to 50% of each participant’s elected salary deferral up to 6% of the participant’s compensation for the Plan year, also limited. There were no discretionary employer contributions during 2024 or 2023. Participants may also rollover or transfer amounts representing distributions from other qualified retirement plans.

Participant accounts

Each participant’s account is credited with the participant’s contributions, employer contributions, an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant’s compensation or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of the plan, continued

Vesting

Participants are immediately vested in their salary deferrals and rollover contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. Participants vest 20% after two years of service and 20% for each year of service thereafter becoming 100% vested after six years of service or upon the participant's death, disability or attaining normal retirement age, as defined in the Plan Agreement.

Investment options

Upon enrollment in the Plan, participants direct the investment of their contributions into various investment options offered by the Plan. For participants who are automatically enrolled, their contributions are invested in default investments as defined in the Plan Agreement. Participants may change their investment options at their discretion; changes become effective the next business day.

During 2024 and 2023, Plan management made changes to the Plan's investment options. Any assets invested in a fund removed from the Plan were transferred to a corresponding new fund, unless otherwise directed by the participant. These investment changes were made to achieve better long-term performance and decrease costs.

Forfeited and unallocated funds

During 2024 and 2023, forfeited nonvested accounts totaled \$191,754 and \$79,348, respectively. Forfeitures, to the extent available, may be used reduce Company matching contributions and then to pay administrative expenses of the Plan. Unallocated funds are a result of excess matching contributions removed from participant accounts that will be used to reduce future Company matching contributions. During 2024 and 2023, the Company used forfeitures and unallocated funds in the amount of \$137,671 and \$60,499, respectively, to pay Company matching contributions and \$44,611 and \$19,509, respectively, to pay administrative expenses. As of December 31, 2024 and 2023, there were \$8,899 and \$2, respectively, of forfeitures available for future use.

Payment of benefits

Upon retirement, death, disability or termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her vested benefit or installment payments over a certain period as defined in the Plan Agreement. Participants receive automatic lump-sum distributions for accounts with a value of \$1,000 or less. In addition, participants automatically have balances rolled into an individual retirement account with an affiliate of Principal for accounts with balances between \$1,000 and \$5,000. Effective January 1, 2024, the automatic rollover threshold was increased from \$5,000 to \$7,000.

1. Description of the plan, continued

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Concentrations of investment risk

As of December 31, 2024 and 2023, substantially all of the Plan's pooled separate investment accounts and a common investment trust were in Principal sponsored or affiliated investments. As of December 31, 2024 and 2023, 25% and 23%, respectively, of the Plan's investments were in two mutual funds. In addition, approximately 58% and 55%, respectively, of the Plan's investments were held in one mutual fund family as of December 31, 2024 and 2023. Each mutual fund family as well as the mutual funds held in excess of 10% of the Plan's total investments.

Investment valuation and income recognition

Investments are reported at fair value. The collective investment trusts and pooled separate investment accounts are valued at net asset value which is used as a practical expedient to estimate fair value. Fair value is defined as the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 5 for discussion of investment valuation.

Net appreciation in fair value of investments includes the sum of undistributed net investment income, undistributed realized gain or loss and the unrealized appreciation or depreciation of investment securities held in the collective investment trusts and the pooled separate investment accounts. Net appreciation also includes the Plan's gains and losses on mutual funds bought and sold as well as held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

2. Summary of significant accounting policies, continued

Payment of benefits

Benefits are recorded when paid.

Income tax status

The Plan is a nonstandardized prototype plan. The Internal Revenue Service (“IRS”) has determined and informed the custodian by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent events

Management has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

3. Information prepared and certified by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (“Principal”), a party-in-interest

All assets of the Plan were held by Principal, a party-in-interest as discussed in Note 7, as of December 31, 2024 and 2023. All transactions during the years ended December 31, 2024 and 2023 were executed under formal custody agreements between the Plan and Principal. All securities bought, sold or exchanged were executed under these agreements. Such financial information has not been audited by independent auditors.

3. Information prepared and certified by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (“Principal”), a party-in-interest, continued

In accordance with the provisions of Section 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, Principal has certified the following unaudited financial information to be complete and accurate with respect to the Plan’s assets held by them as of December 31, 2024 and 2023 and activity for the years then ended, respectively:

4. Risks and uncertainties

The Plan invests in various investment securities, which in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

5. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

## 5. Fair value measurements, continued

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective investment trusts: Valued at the NAV of units of a common collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust, up to 12 months, in order to ensure that securities liquidations will be carried out in an orderly business manner. The trust does not have a finite life and the Plan has no unfunded commitments.

Pooled separate investment accounts: Valued at the NAV of shares held by the Plan in the pooled separate account at year-end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments. Investments in the pooled separate accounts can be redeemed immediately at the current net asset value per share. There are no unfunded commitments or significant restrictions on redemptions.

5. Fair value measurements, continued

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: These accounts include various assets self-directed by participants and primarily include mutual funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers between Levels as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels.

6. Administrative expenses

The Plan pays substantially all administrative fees to Principal, a party-in-interest, for the maintenance of investments, contributions and distributions records, and the processing of related transactions. Total fees paid to Principal during 2024 and 2023 were \$179,510 and \$153,077, respectively. Distribution fees are charged directly to the respective participant accounts when incurred and are included in administrative expenses. Other administrative expenses, including audit fees paid to BGHN Associates, P.C., a party-in-interest, are paid by the Plan Sponsor and, therefore, excluded from these financial statements.

7. Related party and party-in-interest transactions

The Company has an agreement with Principal Life Insurance Company to provide record-keeping, administrative, custodial, and transaction processing services for the Plan's investments. The Company also utilizes Strategic Financial Solutions, LLC for investment advisory services. Other party-in-interest transactions are described in Notes 3 and 6.

During 2024 and 2023, the Company failed to remit employee contributions totaling \$-0- and \$4, respectively, to the trust within the time frame required by the Department of Labor under the plan asset rules.
