### Note 1: Description of Plan

The following description of the Gary W. Clem, Inc. DBA Almaco Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Gary W. Clem, Inc. DBA ALMACO (the "Company") except leased employees. An employee becomes eligible to participate in the Plan on the first plan entry date (first day of the plan year quarter) following date of hire and upon obtaining the age of 18. An employee becomes eligible for the Company discretionary match and discretionary profit sharing contribution upon completing one year and 1,000 hours of service and upon obtaining the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

#### Contributions

Participants are allowed to contribute up to 100% of pre-tax annual compensation, as defined in the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also allows Roth contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan.

The Company may contribute a discretionary matching contribution as determined annually. For 2024, the Company made matching contributions equal to 100% of each participant's salary deferrals not exceeding 4% of each participant's compensation. Effective October 1, 2024, the Company discretionary matching contribution was suspended. Catch-up contributions are matched. Rollovers are not matched. Discretionary matching contributions were \$280,052 for the year ended December 31, 2024.

The Company may also contribute a discretionary profit sharing contribution determined by the Company with respect to each plan year. The contribution is allocated based on a uniform percentage of each participant's compensation. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

Contributions are subject to certain limitations.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, and allocations of (a) the Company's discretionary profit sharing contributions, (b) plan earnings (losses), and (c) administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are fully vested in their salary deferrals, rollovers, and safe harbor matching contributions (which ceased effective October 1, 2017), plus actual earnings (losses) thereon. The Company's discretionary matching and discretionary profit sharing contributions plus actual earnings (losses) thereon vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The note terms range from one to five years. Notes may exceed five years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at 1% over the prime interest rate. The interest rates on existing loans range from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum or partial lump sum amount equal to the value of the participant's vested interest in their account or annual installments over a period of time if the account balance is greater than \$7,000. If the participant's vested account balance does not exceed \$7,000, it can be distributed only in a single lump-sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Plan before becoming 100% vested in the Plan's discretionary matching and discretionary profit sharing contributions. The Company may decide in its discretion how to treat forfeitures under the Plan. The amount of unallocated forfeitures from nonvested accounts at December 31, 2024 and 2023, was \$70,429 and \$38,956, respectively. There were no forfeitures used during 2024.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the Plan are included in administrative expenses and are allocated proportionately to participants. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and included in net investment income.

#### Subsequent Events

The Plan has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trusts:* The Plan's five collective trust funds consist of short term money market funds, mutual funds, and exchange traded funds measured at fair value on a recurring basis using quoted prices for identical assets in active markets as of the measurement date.

*Collective investment trust - Galliard Stable Value Return Fund C:* The estimated fair value of the collective trust funds is NAV as a practical expedient, exclusive of the adjustment to contract value. The use of NAV as fair value is deemed appropriate since the collective trust fund does not have a finite life, a readily determinable fair value, unfunded commitments relating to these types of investments, or significant restrictions on redemptions. The practical expedient is used for valuation, unless it is probable that the fund will sell a portion of the investment at an amount different from the net asset valuation.

### **Note 4: Information Prepared and Certified by the Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, notes receivable from participants, and non-interest-bearing cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank ("Charles Schwab"), the Custodian of the Plan.

### **Note 5: Party-in-Interest Transactions**

Certain plan investments are managed by Charles Schwab. Charles Schwab is the Custodian, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees for investment management services during the year ended December 31, 2024, were offset against earnings. Specific detail for management fees is not available from the Custodian.

Steel Capital Management, Inc. (SCMI) is the Plan's investment advisor and receives compensation from the Plan for investment advisory services. In addition, EPIC Retirement Plan Services (RPS) is the Plan's third-party administrator and receives compensation from the Plan for recordkeeping services. Therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary matching and discretionary profit sharing contributions.

### **Note 7: Tax Status**

The Company adopted a non-standardized pre-approved profit sharing plan with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
