Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the New Orleans-Baton Rouge Steamship Pilots Association Health and Welfare Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about New Orleans-Baton Rouge Steamship Pilots Association Health and Welfare Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) DESCRIPTION OF PLAN

The following description of the New Orleans-Baton Rouge Steamship Pilots Association (“NOBRA”) Health and Welfare Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a welfare benefit plan that provides medical benefits through self-insurance and provides other benefits through insurance contracts in place with insurers. The insurers and third-party administrator are responsible for certain aspects of Plan administration (including payment of claims). The Plan covers office employees of NOBRA, retired employees, pilots who are members of NOBRA, surviving spouses, and retired pilots along with their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

NOBRA employees are eligible to participate in the Plan if they are 1) at least 18 years of age, not covered by a collective bargaining agreement, and are regularly scheduled to work at least thirty (30) hours per week or 2) retired after twenty (20) years of service. Active and retired NOBRA pilots are also eligible to participate in the Plan. Apprentice pilots may not participate in the Plan.

Other Matters

This Plan is being treated as a “grandfathered health plan” under the Patient Protection and Affordable Care Act (the Affordable Care Act). As permitted by the Affordable Care Act, a grandfathered health plan can preserve health coverage that was already in effect when that law was enacted.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on a modified cash basis of accounting. This basis of presentation differs from accounting principles generally accepted in the United States of America (GAAP) in that contributions are recognized when received rather than when earned and expenditures are recognized when paid rather than when incurred. Specifically, the variances from GAAP include omission of contributions receivable and benefits payable.

(2) **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Income Tax Status

The Plan was established on June 1, 1992 and was granted a tax exemption from federal income tax under Section 501(c)(9) of the Internal Revenue Code and accordingly is exempt from income taxes. The Plan Administrator believes the Plan is currently designed and is being operated in accordance with applicable sections of the Internal Revenue Code.

The Plan is defined as a group insurance arrangement for purposes of filing its federal information return, Form 5500. The Plan's Form 5500 returns for 2021 through 2023 are subject to examination by the applicable tax authorities, generally for three years after the later of the original or extended due date.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Date of Management's Review

The Plan has evaluated subsequent events through September 12, 2025, the date which the financial statements were available to be issued.

(3) **CONTRIBUTIONS**

The Plan is fully funded by NOBRA, except in situations where an individual participants' medical claims exceed \$100,000 in a given Plan year. In such situations, the Plan has purchased stop-loss insurance to pay for medical claims exceeding the \$100,000 per Plan year amount. Claims paid under that policy are not included in the financial statements.

(4) **BENEFITS**

Medical Claims

The medical, drug, dental and vision benefits are self-funded by NOBRA. NOBRA is fully responsible for the self-funded benefits. Cigna Health and Life Insurance Company (Cigna), the third-party administrator processes claims and provides other services to NOBRA related to the self-funded benefits under an Administrative Services Only (ASO) arrangement.

(4) BENEFITS (CONTINUED)

Medical Claims (continued)

Under this ASO arrangement, Cigna processes and pays the claims made by the participants. Cigna also provides the stop-loss insurance coverage. Cigna then invoices NOBRA for reimbursement of the medical claims paid on a weekly basis, and the stop-loss insurance premiums, and administrative fees on a monthly basis.

Life and Accidental Death and Dismemberment Insurance

The life and accidental death and dismemberment coverage is provided through insurance policies offered by Unum Group. This insurer invoices NOBRA for premiums on a monthly basis.

(5) RELATED PARTY TRANSACTIONS

The Plan paid Cigna, its third-party administrator, administrative fees of \$44,083 for the year ended December 31, 2024. The Plan also receives certain administrative services and office usage at no charge from NOBRA. These transactions qualify as party-in-interest transactions. However, these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(6) FIDELITY BOND

Two ERISA fidelity bonds are in force covering the Plan in the amount of \$3,000,000 and \$2,000,000.

(7) PLAN TERMINATION

Although it has not expressed any intent to do so, NOBRA has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, remaining Plan assets would be distributed to eligible participants and their beneficiaries.

This is a summary annual report of the New Orleans - Baton Rouge Steamship Pilots Association ("NOBRA") Group Health and Welfare Plans ("the Plan") (EIN: 72-0389381) for the year ended December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Self-Insured Benefits

The Plan offers medical/dental/vision coverage, which is self-funded by NOBRA. Benefits for medical, dental, and vision coverage are not pre-funded through a trust or other funding arrangement. NOBRA has committed itself to pay medical, dental and vision benefits covered by the Plan. In accordance with a contract between NOBRA and Connecticut General Life Insurance ("CIGNA"), medical claims above a certain limit are paid by stop loss coverage from CIGNA. CIGNA HealthCare serves as claims administrator for the medical/dental/vision part of the plan. For the plan year ending December 31, 2024, NOBRA paid stop loss premiums of \$947,788. All funding for the stop loss coverage is currently provided by NOBRA. The Plan paid medical, dental and vision claims totaling \$7,354,988 for the plan year ending December 31, 2024.

Fully Insured Benefits

The Plan also offers insured life and accidental death and dismemberment ("AD&D") coverage. The Plan has a contract with Unum Group to pay insured life and AD&D claims incurred under the terms of the Plan. The total life and AD&D premiums paid for the plan year ending December 31, 2024 were \$507,481. All funding for the life and AD&D insurance coverage is currently provided by NOBRA.

Basic Financial Statement

The value of Plan assets, after subtracting liabilities of the Plan, was \$0 as of December 31, 2024, compared to \$0 as of January 1, 2024. During the plan year, the Plan experienced no change in its net assets. During the plan year, the Plan received \$9,054,103 from NOBRA contributions. Plan expenses were \$9,054,103. These expenses included \$7,354,988 in medical/vision/dental benefits, \$1,455,269 in insurance premiums, \$199,763 in commissions and \$44,083 of contract administration fees paid to service providers.
