## Independent Auditor's Report

To the Plan Administrators and Trustees

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed an audits of the financial statements of Summers-Taylor, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Plan Description

The following description of Summers-Taylor, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Summers-Taylor, Inc., the plan sponsor, and a related party company, Summers-Taylor Materials Company, that is under the same management group (collectively, the "Company," the "Plan Sponsor," or the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

All employees of the Company become eligible to make elective deferral contributions on the first day of the calendar month, coincident with or next following the date the employee completes 125 hours of service in a two-month period, provided that employee is eligible for enrollment at the end of that period. This methodology is followed until enrollment or until the employee completes one year of service and is enrolled.

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants are auto-enrolled into the Plan at a 3 percent contribution rate. Participants are eligible for Roth 401(k) contributions, which are on an after-tax basis. Participants age 50 or older by the end of the calendar year who make deferral contributions to the Plan may also make a catch-up contribution. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. A participant's combined pretax and Roth 401(k) contributions cannot exceed the maximum annual amount allowed by law.

Certain 2023 participant contributions were paid after the time frame required by the Department of Labor. The Company remitted the 2023 contributions and the related lost earnings to the Plan in 2024.

The Company may make a discretionary matching contribution to the Plan, as approved by the Employer's board of directors. Participants who have completed 12 months of service and 750 hours of service during the year will be eligible to receive a discretionary contribution. For the years ended December 31, 2024 and 2023, the Employer elected to make a discretionary matching contribution to the Plan equal to 33 percent of each plan participant's contribution (not to exceed 15 percent of the participant's eligible compensation), resulting in a total employer discretionary contribution of \$422,780 and \$313,902, respectively. The participant must be employed on the last day of the plan year to receive the matching contribution.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance, and interest rates are fixed at 6 percent. Loan repayment periods are for a maximum of five years.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

### Note 1 - Plan Description (Continued)

#### *Vesting*

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company 20 percent after two years of service, an additional 20 percent after three years of service, and another 20 percent per year thereafter until they become fully vested after six years of service. The Plan provides for 100 percent vesting of Company discretionary matching contributions and earnings thereon upon attainment of normal retirement age of 65, disability, or death.

#### *Benefit Payments*

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities paid over a period not exceeding the participant's assumed life expectancy. Participants may also receive a distribution upon reaching age 59½ prior to termination of service. If a participant terminates employment for any reason and his or her vested account balance does not exceed \$5,000, the plan administrator may distribute such amount in a lump-sum payment to the participant without consent of the participant.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

#### *Forfeitures*

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are first used to pay the Plan's administrative expenses, with any remaining balance used to reduce the Company's discretionary matching contributions. At December 31, 2024 and 2023, forfeited account balances totaled \$22,305 and \$16,837, respectively.

#### *Party-in-interest Transactions*

Certain investments are specifically managed by Talcott Resolution Life Insurance Company (Talcott). Talcott is a service provider of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. Certain administrative expenses of the Plan are paid by the Company, which qualify as party-in-interest transactions.

#### *Termination*

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### *Investment Valuation and Income Recognition*

Investments held by the Plan are stated at fair value except for the fully benefit-responsive investment contract valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. See Note 6 for further discussion of investment contracts. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 3, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020 indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 4 - Certified Information**

Talcott Resolution Life Insurance Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Empower Annuity Insurance Company of America, on behalf of Talcott.

**Note 5 - Fair Value Measurements**

The following valuation methodology has been used to value the Plan's investments:

***Pooled Separate Accounts***

The pooled separate accounts are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' net underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

- (1) This class represents investments in actively managed pooled separate accounts that invest primarily in equity securities, which may include common stocks, options, and futures.
- (2) This class represents investments in actively managed pooled separate accounts that invest in a variety of fixed-income investments, which may include corporate bonds, both U.S. and non-U.S. municipal securities, interest rate swaps, options, and futures.
- (3) This class represents target retirement fund investments in actively managed pooled separate accounts with investments in both equity and debt securities. The investments may include common stock, corporate bonds, U.S. and non-U.S. municipal securities, interest rate swaps, options, and futures. The investments in these funds are automatically adjusted based on the target retirement date.
- (4) This class represents investments in actively managed pooled separate accounts with investments in real estate. The investments may include real estate property or real estate investment trusts.
- (5) This class represents investments in actively managed pooled separate accounts with balanced investments in both equity and debt securities. The investments may include common stock, corporate bonds, U.S. and non-U.S. municipal securities, interest rate swaps, options, and futures.

**Note 6 - Investment Contracts**

The Plan has a fully benefit-responsive investment contract with Talcott Resolution Life Insurance Company. Talcott maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting but may not be less than 3 percent. When establishing interest crediting rates for this product, the Plan considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the Plan Sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contract and that require the Plan Sponsor to settle an amount different than contract value paid either within 90 days or over time.
