## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ComNet Communications, LLC Employee Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1. Description of Plan

The following description of the ComNet Communications, LLC Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General:** The Plan is a defined contribution 401(k) plan established for the benefit of the employees of ComNet Communications, LLC (the Sponsor). The Plan and trust of which it is a part are intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. Empower Trust Company, LLC (the Trustee) serves as trustee for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** Employees of the Sponsor, who are not governed by a collective bargaining agreement, are not leased employees, or are not contract employees, are eligible to participate on the first day of the month following 60 days of employment.

**Contributions:** Each year, participants may make salary deferral contributions to the Plan through payroll deductions in any whole percentage not less than 1% of pretax annual compensation, as defined in the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of Plan compensation. Auto-enrollment contributions are invested in a designated fund until changed by the participant. The Sponsor makes a discretionary matching contribution of 50% of participants' deferrals up to 8% of the participants' compensation. Participants may rollover amounts representing distributions from other qualified defined benefit or contribution plans. Contributions are subject to certain Internal Revenue Service (IRS) limitations. The maximum employee contribution that can be made in 2024 is \$23,000.

Participants who have attained age 50 before the end of a calendar year may elect to defer additional amounts (called catch-up contributions) to the Plan as of January 1 of that year. The additional amounts may be deferred regardless of any other limitations on the amount that these participants defer to the Plan. The maximum catch-up contribution that can be made in 2024 is \$7,500.

**Participant accounts:** Each participant's account is credited with the participant's contribution and the Sponsor's discretionary matching contribution. Plan earnings are allocated based on participant account balances, as defined.

**Payment of benefits:** In-service withdrawals are permitted in the case of demonstrated financial hardship or after attaining age 59½. Upon termination of service, a participant may elect to receive a lump-sum payment or annuity equal to the value of his or her account.

**Participants' investment options:** Participants must direct their salary deferral contributions to selected investments, as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via direct phone or internet access.

**Vesting:** Participants are immediately vested in their salary deferral contributions, plus actual earnings thereon, if any. The portion of the participant's accounts attributable to the Sponsor's matching contributions becomes 100% vested after three years of service.

#### Note 1. Description of Plan (Continued)

**Participant forfeitures:** Forfeitures related to unvested employer contributions are used to reduce future employer contributions. Former employees can have this forfeiture reinstated if they start working again for the Sponsor, as long as the break in service does not exceed five years. Forfeited non-vested participant accounts totaled \$1 at December 31, 2024 and 2023.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 1%. Loan terms range from one to five years, or longer for the purchase of a principal residence. Principal and interest are paid ratably through monthly payroll deductions.

#### Note 2. Significant Accounting Policies

The Plan's significant accounting policies are as follows:

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5 for discussion of investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation on investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance, plus any accrued interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan agreement.

**Payment of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Income taxes:** U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

#### Note 2. Significant Accounting Policies (Continued)

**Administrative expenses:** Trustee fees, asset fees and loan fees are paid by the Plan. Recordkeeping and all other administrative expenses are paid by the Sponsor.

**Risks and uncertainties:** The Plan provides for various investment options that may invest in equity, fixed income or other investment securities. These investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk and uncertainty associated with certain investment securities, it is possible that participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits could be materially affected in the near term.

#### Note 3. Information Certified or Provided by Empower Retirement, LLC (Trustee) and Massachusetts Mutual Life Insurance Company

The following is a summary of the Plan assets as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by, or derived from, information provided by Empower Retirement, LLC (Empower), as the recordkeeper of the Plan as agent for the Trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Empower on behalf of the Trustee that information provided to the Plan Administrator by Empower on behalf of the Trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets:

Empower also certified to the completeness and accuracy of \$2,728,936 of net appreciation in fair value of investments, \$1,627,409 of dividend income, \$131,096 of interest income on guaranteed investment contracts and \$77,477 of interest income on notes receivable from participants for the year ended December 31, 2024.

#### Note 4. Fair Value Measurements

The Financial Accounting Standards Board Accounting Standards Codification provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this guidance are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Transfers between levels:** The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the ending of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Levels 1, 2 or 3.

#### Note 5. Investment Contract With Insurance Companies

The Plan has a general account-backed benefit-responsive stable value contract, the SAGIC Core Bond Fund, which is a Group Annuity Contract Agreement with MassMutual Life Insurance Company (MassMutual). Business written by MassMutual will be reinsured by Great-West Life & Annuity Insurance Company (GWL&A), an affiliate of Empower Retirement, LLC (Empower). Empower is not affiliated with MassMutual or its affiliates.

Empower maintains the Plan's deposits in a pooled account to which it added interest at the contract stated rate and deducted participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value reported to the Plan by Empower. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan agreement (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestiture or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### Note 6. Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 401(k) of the IRC and, therefore, the trust's net investment loss is exempt from income taxes.

The Plan obtained its latest determination letter on November 14, 2022, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter; therefore, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

#### Note 7. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in benefits accrued to the date of Plan termination.

#### Note 8. Administrative Expenses

Administrative fees paid by the Plan for the year ended December 31, 2024, totaled \$77,553. The Sponsor has paid all other administrative expenses, such as custodian fees, professional fees and personnel expenses.

#### Note 9. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and Guaranteed Investment Contracts managed by Empower, agent for the Trustee and, therefore, these transactions qualify as party-in-interest transactions as defined by ERISA.

#### Note 10. Excess Participant Contributions Payable

The Plan failed to pass the Match Plan Limit Test for the 2024 and 2023 plan years. In order to correct the failure of the tests, federal law generally requires corrective distributions be made no later than the end of the following plan year. The Plan recorded excess contributions payable at December 31, 2024 and 2023, of \$934 and \$13,216, respectively, which were paid in 2025 and 2024, respectively.
