Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

NOTE 1 - Description of Plan:

The following description of the Kris-Tech Wire Co., Inc. (“the Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan covering all eligible employees of the Company and certain affiliates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.
- B. Eligibility - Employees become eligible for participation after attaining age eighteen (18) and completing two consecutive months of service.
- C. Contributions - Participants may contribute up to 100% of pre-tax annual compensation to a maximum of \$23,000 for 2024. Participants who have attained age 50 before the end of the plan year may make “catch-up” contributions of up to \$7,500. Participants may also make “rollover” contributions from other qualified plans. The Plan includes an automatic salary deferral feature whereby the Company will automatically withhold a portion (4%) of the participants pay each pay period and contribute that amount to the Plan as pre-tax 401(k) deferral. A salary deferral agreement may be completed to elect an alternate salary deferral amount or not to defer under the Plan.

The Company elected to make safe harbor matching contributions equal to 100% of employee deferrals not to exceed 4%. The Company may also make profit-sharing contributions at the Company’s discretion. For the years ended December 31, 2024 and 2023 matching contributions were approximately \$400,000 and \$330,00, respectively. The Company’s profit-sharing contribution was approximately \$585,000 and \$560,000 for 2024 and 2023, respectively.

- D. Participant Accounts – Each participant's separate account is credited with the participant's contribution and their share of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, see Note 2 (F). Participants direct investment of their account into various investment options selected by the Plan's administration. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- E. Vesting - Participants are immediately 100% vested in their contributions, employer safe harbor matching contributions and actual earnings thereon. Company profit-sharing contributions and earnings thereon follow a five-year graded vesting schedule noted below. A participant is also 100% vested upon reaching normal retirement age, or in the event of death or disability while employed by the Company.

NOTE 1 - Description of Plan (Continued):

- F. Payment of Benefits - Upon termination of service due to death, disability, or retirement, a participant (or their beneficiaries) will receive a lump sum distribution as soon as administratively feasible following the date on which a distribution is requested or otherwise payable.
- G. Withdrawals - The Plan allows for financial hardship withdrawals for college education, purchase of a primary residence, prevention of eviction or foreclosure, and medical expenses. The Plan also allows for in-service withdrawals to participants attaining age 59 ½.
- H. Forfeited Accounts - Forfeited nonvested accounts will be used to reduce future Company contributions. Amounts used to reduce the Company's contributions were approximately \$45,000 and \$10,000 for 2024 and 2023, respectively.
- I. Participant Loans - Participants may borrow a minimum of \$1,000 up to a maximum of 50% of their vested account balance (not to exceed \$50,000). Repayments are over a period not to exceed 60 months, unless the loan is to be used to acquire a principal residence, in which case the loan is to be repaid within 15 years. Interest is fixed at the prime rate plus 1%. The maximum number of loans outstanding per participant is one.

NOTE 2 - Summary of Significant Accounting Policies:

A. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

B. Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make certain estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Notes Receivable from Participants

Loans to participants are reported at the unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

D. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

DECEMBER 31, 2024

NOTE 2 - Summary of Significant Accounting Policies (Continued):

D. Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments sold during the year as well as unrealized gains and losses on investments held at year end.

E. Payments of Benefits

Benefit payments to participants are recorded when paid.

F. Expenses

Certain expenses of maintaining the Plan are paid by the Plan. Expenses that are paid by the Company, such as audit fees are excluded from these financial statements. Loan initiation and distribution fees are charged directly to participant accounts. Investment related expenses are included in net appreciation of fair value of investments.

G. Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 9, 2025, the date the financial statements were available to be issued. There were no subsequent events requiring recording or disclosure in the financial statements.

NOTE 3 - Fair Value Measurement:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy give the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are describe as follows:

- Level 1 - Input consist of unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access.
- Level 2 - Inputs consist of quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for assets.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

- Level 3 - Inputs to the valuation methodology are unobservable inputs and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan will maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

DECEMBER 31, 2024

NOTE 3 - Fair Value Measurement (Continued):

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used:

Mutual Funds: Are valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

Common Collective Trust: Are valued at Net Assets Value (NAV) of the Plan's units held of the Collective Trust Fund (the "Trust") as of the close of business on each valuation date reported by the Trust. The Trust's NAV is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding. The Trust is not registered under the Investment Company Act and the units are not registered under the Securities Act as the Trust Fund is maintained by a bank. The practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

Investments measured using the NAV per share (or its equivalent) practical expedient method are not part of the fair value hierarchy. The fair value amounts presented in the table below are included for reconciliation purposes to the statement of net assets available for benefits.

NOTE 4 - Inactive Accounts:

Accounts of participants who have withdrawn from participation in the Plan, but for whom disbursement from the Plan has not been made totaled approximately \$2,100,000 and \$9,600,000 at December 31, 2024 and 2023, respectively.

NOTE 5 - Tax Status:

The Plan adopted a Prototype Plan which received a favorable Opinion Letter from the IRS dated June 30, 2020, specifying the form of the Plan satisfies the requirements of Code Section 401 and therefore is exempt from tax. The Plan has been amended since receiving the Opinion Letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The tax status of the Plan is subject to audit. Generally, years after January 1, 2022 are open to audit.

NOTE 6 - Plan Termination:

Although the Company has not expressed any intent to do so, it has the right under the Plan to terminate it at any time, subject to the provisions set forth in ERISA. In the event of termination participants will become 100% vested in their accounts.

NOTE 7 - Risks, Uncertainties and Concentrations:

The Plan's investments are exposed to various risks such as interest rate, credit, and overall market risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and possible that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan's assets, although diversified through investment in several different mutual funds, are all held by Capital Bank and Trust Company. The Plan is dependent on this Custodian for the safeguarding of its assets.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

DECEMBER 31, 2024

NOTE 8 - Legal Proceedings/Contingencies:

The Plan may engage legal counsel to defend it against such potential litigation matters whether asserted or anticipated as the Plan's management judges necessary in the circumstances. The Plan does not believe that there are any current actions that are either not covered by insurance or would have a material effect on its financial condition.

NOTE 9 - Related-Party and Party-In-Interest Transactions:

Certain Plan investments are managed by Capital Bank and Trust Company. They are the Custodian as identified by the Plan and, therefore, these transactions qualify as Party-In-Interest transactions. In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participant's accounts. Therefore, these transactions qualify as party-in-interest transactions. The Plan uses Robert Baird & Co as investment advisors for the Plan and fees paid to these parties qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 10 - Financial Information Certified by the Custodian:

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest, dividends, and interest income on notes receivables from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, (the trustee and custodian of the Plan).
