To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Home State Insurance Group, Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Home State Insurance Group, Inc. 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO THE FINANCIAL STATEMENTS

Note A - Description of the Plan

The following description of the Home State Insurance Group, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Sponsor established the Plan to provide employees with a systematic means of savings and investing for the future. All permissible employees of the Sponsor are eligible to enroll upon attaining the age of 18 and completing 30 days of service. The Plan is a defined contribution plan subject to the provisions of the Employee Income Security Act of 1974 ("ERISA").

Administration

The Sponsor has appointed Mid Atlantic Trust Company to act as Trustee and Custodian of the Plan. PB&H Benefits is recordkeeper and Third-Party Administrator ("TPA") of the Plan.

Eligibility

Employees of the Company who have attained the age of 18, are generally eligible to participate in the Plan after completing 30 days of service. The entry date of the Plan for eligible participants is on the first day of the month coinciding with or next following the date requirements are met.

Nonresident aliens and union employees are excluded from participating in the plan.

Contributions

Each year participants may contribute a percentage of their pre-tax annual compensation not to exceed the limitation (\$23,000 and \$22,500 in 2024 and 2023 respectively) set forth in Section 402(g) of the Internal Revenue Code ("IRC"). Participants who are (or will be) age 50 or older by the end of the calendar year may make pre-tax or after-tax catch-up contributions that exceed the annual elective deferral limit. Participants' total catch-up contributions during 2024 and 2023 cannot exceed \$7,500 and \$7,500, respectively. Participants may also make rollover contributions from other plans.

Note A - Description of the Plan, continued

The Sponsor contributes a matching contribution dollar-for-dollar up to \$4,500. During 2024, the Sponsor funded matching contributions of \$218,644.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor matching contribution and an allocation of any non-elective contribution and earnings (losses) on the investments selected by the participant. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

Investment Options

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Sponsor's contributions into various mutual fund options offered by the Plan.

Vesting

Participants are vested immediately in their elective contributions, plus any earnings on such contributions. The vesting of matching Sponsor contributions plus any earnings thereon is based on years of continuous service accrued by the participant while in covered employment. Participants are vested 20% after two years of service and are 100% vested after six years of service.

Participant Loans

Participants may borrow from their accounts on a pro-rata basis from all contribution sources up to a maximum equal to the lesser of \$50,000.00 or 50% of the participant's vested account balance. Loan terms must not exceed five (5) years unless the loan is to be used in the financing of the participant's homestead in which case the loan may be payable in terms of similar length provided by conventional lending institutions. The loans are secured by the vested balance in the participant's account. As of December 31, 2024, interest rates ranged from 4.25 to 9.50 percent. Principal and interest payments are made by means of payroll withholdings according to the terms of the promissory note and the Plan document. The Plan allows participants to have one loan.

Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

Note A - Description of the Plan, continued

Payment of Benefits

Payment of benefits is recorded when paid.

Forfeited Accounts

All employer contributions credited to a participant's account, but not vested, are forfeited by the participant upon his/her termination from the Plan. Per the Plan document forfeitures may be used to offset future employer contributions or to pay Plan expenses. As of December 31, 2024, there were no forfeitures that have not yet been applied. During 2024, the forfeiture balance of \$7,261 was used to reduce employer's contribution.

Administrative Expenses

Certain expenses incurred in the administration of the Plan are paid directly by the Plan. During the year ended December 31, 2024, the Plan paid fees of \$39,176.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets available for the benefits and changes therein. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan provides various investment options. These investment options are exposed to market risk, which generally means the risk of loss in the value of certain investment securities due to changes in interest rates, commodity prices and general market conditions. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Note B - Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition

Investments are stated at fair value, which is determined using quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Investments in fully-benefit responsive investment contracts are reported at contract value as discussed in Note C. Investments in money market funds are valued at amortized cost, which approximates fair value. Net appreciation (depreciation) in fair value of investments includes realized gains and losses on investments sold during the year and unrealized appreciation (depreciation) of investments held at the end of the year.

Subsequent Events

The Plan has evaluated subsequent events through September 19, 2025, the date which the financial statements were available to be issued. No events have occurred subsequent to the date of the statement of net assets available for benefits that would require adjustment to, or disclosure in, the financial statements.

Contributions

Contributions from Plan participants and the matching contribution, if any, from the Plan Sponsor are recorded in the year in which the participant contributions are withheld from amounts paid. Profit sharing contributions, if any, are recognized upon authorization and in the year the underlying compensation is recognized. All participant and employer contributions are participant-directed.

Expenses

Plan administrative expenses are paid by the Plan.

Note C - Insurance Investment Contract with Metropolitan Life Insurance Company ("MetLife")

On December 31, 2024 and 2023, the Plan had a traditional fully benefit-responsive guaranteed investment contract, in the amount of \$1,941,265 and \$2,196,929 respectively, with Metropolitan Life Insurance Company ("MetLife"). The investment is an unallocated pooled separate account that is backed by assets held in specified insurance company separate accounts. The unallocated investment contract guarantees a credited rate of return that is adjusted quarterly based on current market conditions and the performance of the fund's investments.

The contract value, as reported to the Plan by MetLife, represents contributions made under the contract plus earnings, less participant withdrawals, and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The Plan must provide a 60-day advance notice of its intent to withdraw from the investment. If the Plan ends its participation in the investment, it

Note C - Insurance Investment Contract with Metropolitan Life Insurance Company (“MetLife”), continued

will receive the lesser of the Plan’s contract value of the market value. If the market value is less than the contract value, the Plan has the option of transferring the assets to a fixed rate, fixed maturity general account contract that would maintain the Plan’s contract value. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the Plan documents, 2) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or 3) the failure of the trust to qualify for exemption from federal income taxes, or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which could limit the Plan’s ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note D - Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted process for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical assets or liabilities in inactive markets.
- Inputs other than quoted process that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use to unobservable inputs.

Note D - Fair Value Measurements, continued

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 input).

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023.

Mid Atlantic Trust Company also certified to the completeness and accuracy (including gains and losses on investments bought and sold, as well as held during the year) of \$1,161,010 of net appreciation in the fair value of investments, \$985,454 of dividends, net gain on the sale of assets of \$141,994 and other income of \$44,951 for the year ended December 31, 2024.

Note F – Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note G – Tax Status

The Plan obtained its latest determination letter dated December 9, 1997, and an opinion letter dated March 31, 2008, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving these letters. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been made in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note H – Party-in-Interest Transactions

The Plan allows participant loans. These transactions qualify as party-in-interest transactions. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Note H – Party-in-Interest Transactions, continued

Certain Plan investments are funds managed by the Trustee and the Custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

Note I – Benefit Claims Payable

On December 31, 2024 and 2023, there were no benefit claims payable for distributions requests made prior to year-end.

Note J – Recent Accounting Pronouncements
