Note 1 - Description of Plan

The following description of the Utz Quality Foods, LLC Profit Sharing/401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a participant-directed defined contribution profit sharing plan with a 401(k) feature covering full-time employees of Utz Quality Foods, LLC (the Company) who have completed 30 days of service and part-time employees of the Company who have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 50% of pre-tax annual compensation, as defined in the Plan. Participants may also make after-tax Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Participants will be automatically enrolled in the Plan on the plan entry date, as defined in the plan document, unless they elect to opt out. For the 2023 and 2024 plan years, participants who are automatically enrolled had 3% of their eligible compensation withheld and remitted to the Plan. The Plan included an automatic escalation clause for participant deferrals, which resulted in participant deferrals being automatically increased by 1% of the compensation at the beginning of each plan year until a participant reached a maximum deferral of 10% of compensation. Participants could make an affirmative deferral election at any time to prevent the automatic deferral escalations, including the affirmative election not to participate in the compensation deferrals. Effective January 1, 2025, the automatic escalation clause was discontinued. In addition, annual employees, who defer less than 4% or are not enrolled in the Plan, are automatically enrolled and will have 4% of their eligible compensation deferred. See Note 10 - Subsequent Events.

The Company's Board of Directors has agreed to contribute a matching contribution of 20% of the first 6% of annual compensation that a participant contributes to the Plan for the years ended December 31, 2024 and 2023. Effective January 1, 2025, the Company will match up to 4% of the participant's compensation for the plan year. See Note 10 - Subsequent Events. Participant catch-up contributions are not eligible for the employer matching contribution. Employer matching contributions are credited quarterly to each eligible participant's account. The Company may make an additional discretionary profit-sharing contribution, which is allocated to employees credited with at least 1,000 hours of service during the plan year and who were employed on the last day of the plan year. For the years ended December 31, 2024 and 2023, the Company made a profit-sharing contribution of 3% of 2024 and 2023 total eligible wages depending on the earned compensation of the employees. For the year ended December 31, 2024, the employer matching contribution totaled \$1,458,934 and profit-sharing contribution was \$5,599,124. For the year ended December 31, 2023, the employer matching contribution totaled \$1,723,223 and profit-sharing contribution was \$5,620,893.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of (a) the Company's profit-sharing contribution, (b) plan earnings, (c) forfeitures of terminated participants' nonvested accounts, and (d) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service depending on the type of contribution. For employer matching contributions, a participant was 100% vested after one year of credited service, based on the following vesting schedule:

Effective January 1, 2025, employer matching contributions will vest immediately. See Note 10 - Subsequent Events.

For employer profit-sharing contributions, a participant, terminated from the Company prior to April 30, 2020, is 100% vested after six years of credited service. Effective for participants with one or more hours of service after May 1, 2020, a participant is 100% vested after four years of credited service, based on the following vesting schedule:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is to acquire the participant's principal residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate in effect at the date of the loan. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

For Plan years 2024 and 2023, on termination of service due to death, disability, retirement, or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or in installments under a systematic withdrawal plan. If a participant's account balance is less than \$5,000 but greater than \$1,000 upon termination, a distribution of the participant's account may be made automatically into an individual retirement account. If a participant's account balance is less than \$1,000 upon termination, a distribution of the participant's account may be made automatically in a single lump-sum distribution. Beginning for the 2025 Plan year, if a participant's account balance is between \$0.01 and \$7,000 upon termination, a distribution of the participant's account may be made automatically into an individual retirement account. In-service withdrawals of a participant's vested account balance may be made by participants who have attained the age of 59-1/2. In addition, the Plan allows for hardship distributions and in-service withdrawals, if certain criteria are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$344,518 and \$280,643, respectively. These accounts will be used to pay administrative expenses or reduce future employer contributions. During 2024 and 2023, \$185,561 and \$125,752, respectively, of forfeited nonvested accounts were used to pay administrative expenses. During 2024 and 2023, \$459,018 and \$300,000, respectively, of forfeited nonvested accounts were used to reduce employer contributions.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 - Information Certified and Provided by Fidelity Management Trust Company

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund is valued at cost, which approximate fair value.

Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interests in the collective trust fund are valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The IRS has determined and informed the Company by a letter dated June 29, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company contribution portion of their account.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company. There is also a revenue credit program with Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management and custody services are immaterial.

Note 10 - Subsequent Events

Plan management has evaluated subsequent events through October 9, 2025. This date is the date the financial statements were available to be issued. Effective January 1, 2025, the following changes were made to the Plan:

- Good Health Natural Products, Inc. and R.W. Garcia Holdings, LLC are no longer participating employers in the Plan.
- Employees hired or rehired on or after January 1, 2025 are not eligible to receive the employer matching contribution until the 1st day of the calendar quarter following completion of one year of service.
- Participants who are not enrolled in the Plan or whose deferral is less than 4% are automatically enrolled in the Plan will have 4% of their eligible compensation withheld and remitted to the Plan. Effective January 1, 2025, the automatic escalation of the participant deferrals was removed.
- The employer matching contribution will be replaced with a safe harbor matching contribution equal to 100% of a participant's salary reduction contribution for the plan year not in excess of 4% of the participant's compensation for such plan year. The safe harbor matching contribution will be 100% vested at all times.

In addition, effective October 1, 2025, the Plan changed the trustee from Fidelity Management Trust Company to Empower Trust Company. No other material events subsequent to December 31, 2024 were noted.
