Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Note 1 - Plan Description

The following description of Phillips Manufacturing Company 401(k) Plan, formerly known as Phillips Manufacturing Co. 401(k) Plan (the "Plan"), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Phillips Manufacturing (the "Company") who have completed one month of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral and Roth after-tax contributions up to a maximum of 80 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Newly eligible employees are automatically enrolled to contribute 3 percent of their compensation on a pretax basis unless a participant elects another percentage. The automatic deferral percentage will increase 1 percent on the anniversary of each participant's enrollment date until reaching 10 percent. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for discretionary employer matching contributions. During 2024, non-union employees' discretionary employer matching contributions were 100 percent on the first 1 percent and then 50 percent on the next 4 percent, up to a maximum matching contribution of \$1,500 during the plan year, and union employees' discretionary employer matching contributions were 100 percent on the first 1 percent and then 50 percent on the next 6 percent, up to a maximum matching contribution of \$1,500 during the plan year. During 2025, the \$1,500 limit on matching contributions was removed and the employer matching contribution will be a required safe harbor contribution at a rate of 100 percent on the first 1 percent and then 50 percent on the next 6 percent for all participants. Discretionary contributions will still be allowed by the Plan.

The Company may also makes annual discretionary nonelective contributions to the Plan. No nonelective contributions were made during 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Benefit Payments

Distributions are payable upon termination of service, death, disability, or retirement in the form of a lump sum or installment payments in amounts up to the value of the participant's vested interest in his or her account. Participants may also make in-service withdrawals from their 401(k) accounts and after-tax and rollover contributions upon reaching age 59½.

Hardship Withdrawals

Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document. The Company must approve any such hardship withdrawals.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts, if they meet the hardship withdrawal requirements, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The participant notes receivable are secured by the balance in the participant's account and bear interest at rates determined in accordance with the Plan. Principal and interest are paid ratably through monthly payroll deductions.

Vesting

Participants are immediately 100 percent vested in employee elective, rollover, and after-tax contributions and any income or loss thereon.

Effective in 2025, safe harbor contributions will be 100 vested after 2 years of service.

Vesting in the Company's discretionary matching and nonelective contributions, plus actual earnings thereon, is based on years of service according to the following schedule:

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled approximately \$116,000 and \$95,000, respectively.

The Plan used approximately \$53,000 for the year ended December 31, 2024 to reduce employer contributions and administrative expenses.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The common collective trust fund is deemed to have a readily determinable fair value and is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying net assets. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Note 2 - Summary of Significant Accounting Policies (Continued)

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 30, 2025, which is the date the financial statements were available to be issued.

During 2025, the Plan was amended and union employees are no longer eligible to participate in the Plan. As a result, a separate 401(k) plan specifically for its union members was spun out of the Plan. The total amount of assets spun off was approximately \$1,900,000 affecting 51 union members.

Note 3 - Certified Information

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Note 5 - Fair Value Measurements (Continued)

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
