1. Plan Description

The following description of DWFritz Automation LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 1997 and is a defined contribution plan covering certain eligible employees of DWFritz Automation LLC (the "Company"). Under the terms of the current plan document, eligible employees are able to begin participating in the Plan upon their respective dates of hire with respect to employee salary deferrals and any employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended ("ERISA"). An administrative committee comprised of certain members of the Company's management is responsible for oversight of the Plan. The administrative committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year participants may contribute a portion of their annual compensation, as defined by the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from certain other qualified defined benefit or defined contribution plans. The plan document includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. For the year ended December 31, 2024, the Company elected to contribute a matching contribution of 100 percent of amounts deferred by participants, up to 3 percent of each participant's eligible compensation, as defined in the plan document. The Company may also elect to contribute safe harbor employer nonelective contributions to the Plan. Safe harbor employer nonelective contributions, if authorized by the Company, are allocated to participant accounts based upon eligible compensation during the period in which such discretionary contributions are made. For the year ended December 31, 2024, the Company elected to contribute safe harbor employer nonelective contributions totaling 3 percent of each participant's eligible compensation, as defined in the plan document. Participants direct the investment of their elective salary deferrals and allocation of employer contributions into any of the investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each eligible participant's account is credited with the participant's contributions, as well as allocations of the Company's contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and safe harbor employer nonelective contributions plus earnings thereon. Effective January 1, 2024, current employees of the Company who are participants in the Plan are fully vested in the employer matching and nonelective contributions portions of their accounts.

Employer matching contributions and nonelective contributions vest according to the following schedule for participants who terminated prior to January 1, 2024:

A year of service for vesting is counted from the respective participant's date of hire.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are collateralized by the balance in the participant's account and bear interest at a fixed rate throughout the duration of each loan as defined by the plan document. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon attaining normal retirement age of 65, death, or termination of employment, a participant, or his or her beneficiary, may elect to receive either a lump-sum amount equal to the participant's vested account balance or receive partial payments as requested. The Plan permits in-service distributions under certain conditions as described in the plan document.

Forfeited Accounts

If a participant terminates employment with the Company before becoming fully vested, the unvested portion of his or her account is forfeited. Forfeitures may be used to pay the Plan's administrative expenses or to offset future employer contributions. The non-vested forfeiture account balance as of December 31, 2024 and 2023 was \$100,629 and \$117,862, respectively. During the year ended December 31, 2024, employer contributions were reduced by \$84,221 from forfeited nonvested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates under different assumptions or conditions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

In preparing these financial statements, management has evaluated events and transactions for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1. Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified

(contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. Fair values are provided by the investment custodians for the Plan's investment assets as follows:

Common/collective trusts: The net unit values of the Plan's investments in certain common/collective trusts are valued at the net asset value ("NAV") of units of each collective trust. The NAV, as provided by the trustee, is used to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This value is not used when it is determined to be probable that the Plan will sell the investment for an amount materially different than the reported NAV. Participant transactions, including purchases and sales, may generally occur daily; however, certain common/collective trust investments may be subject to temporary redemption restrictions.

In accordance with the terms of the underlying trust agreement regarding the Fidelity Managed Income Portfolio, participant transactions are executed at the end of each business day at net unit values based on contract value. Were the Plan to initiate a full redemption of the Fidelity Managed Income Portfolio, the investment issuer reserves the right to temporarily delay withdrawal from the trust. Plan level redemptions are subject to a twelve month notice provision. Similar provisions may apply to certain other investments in common/collective trusts held by the Plan.

Registered investment companies: Investments in registered investment companies, including money market accounts and other mutual funds, are valued at the daily closing price as reported by the fund. Registered investment company instruments held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. The funds are required to publish their daily NAV per share and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-In-Interest Transactions

Certain of the Plan's investments are shares of mutual funds managed by affiliates of Fidelity Management Trust Company ("Fidelity"). Fidelity is the Plan's investment custodian and trustee; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for certain investment management services are included in net appreciation in fair value of the investment, as they are paid at the investment level, rather than through direct payments from the Plan. During the year ended December 31, 2024, the Plan made direct payments for other administrative expenses totaling \$60,394. The Company pays directly certain other fees related to the Plan's operations.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in the employer contributions portion of their accounts.

7. Tax Status

The Plan has adopted a volume submitter profit sharing plan agreement. The Internal Revenue Service has determined by a letter dated June 30, 2020 that the prototype plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the

Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Transfers to Sandvik 401(k) Retirement Plan

Effective July 1, 2024, the Plan transferred certain net assets and participant accounts to the Sandvik 401(k) Retirement Plan (EIN: 22-1717737, PN: 006) totaling \$2,896,736.
