Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The San Diego Union-Tribune 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024 and period ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year and period then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Plan Description

The following description of The San Diego Union-Tribune 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan originating effective October 1, 2023 covering eligible employees of The San Diego Union – Tribune, LLC (the “Company”) that have adopted the Plan as of October 31, 2023. Union employees, leased employees, non-resident aliens, and residents of Puerto Rico are excluded from participating in the Plan. Eligibility for purposes of employer matching contributions and employer non-elective contribution, if applicable, is the first business day the participant completes six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The plan committee is responsible for oversight of the Plan and determining appropriate investment offerings and performance.

Effective March 2, 2024, the Plan’s trustee changed from Prudential Bank & Trust (“Prudential”) to Empower Trust Company, LLC (“Empower”).

Eligibility and Contributions

Participants may make both before-tax and Roth contributions ranging from 1% to 75% percent of their annual eligible compensation, as limited by the Internal Revenue Service (IRS), which is adjusted annually for inflation. This maximum percentage may be reduced by the plan administrator in certain circumstances. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the IRS. The Plan also permits rollover contributions from other qualified retirement plans.

The Plan also includes an automatic enrollment provision. Therefore, when an employee becomes eligible to be a participant in the Plan, the Company will automatically, on behalf of the participants, defer 4% of the participants’ eligible compensation (as defined). The automatic enrollment will auto escalate 1% up to 10% of compensation. Participants may cancel, modify, or otherwise change any of the automatic elections.

The Company may make discretionary employer matching contributions and non-elective contributions on participant’s behalf. In order to be eligible for the non-elective contribution, the employee must have 1,000 hours of service in the Plan year and be employed on the last day. The company made no discretionary employer matching contributions and non-elective contributions for the year ended December 31, 2024 and for the period ended December 31, 2023, respectively.

Benefits Payments

Upon death, disability, retirement, or termination of service, a participant or his or her beneficiary may receive, at his or her election, within a reasonable period of time, a lump-sum payment in the amount equal to the participant’s vested account balance. The Plan allows in-service distributions and partial distributions to participants age 59.5 or older who have not terminated employment with the plan sponsor.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Related Party Transactions

Certain plan assets are in investment funds managed by Empower or its affiliates. Empower is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. In addition, the Plan provides for participant notes receivable, which also qualify as party-in-interest transactions, as defined under ERISA guidelines.

Vesting

Participants' contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason. A participant will become fully vested in the event of death or permanent disability. In general, the Company's employer matching contributions and non-elective contributions will be vested based on participant's years of vesting services, which means a 12-month period beginning on participant's date of hire, in accordance with the following schedule:

One Year but less than Two Years	20%

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings, and forfeitures of terminated "participant's nonvested accounts and charged with fees and an allocation of administrative expenses. Allocations are based on participant's compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of the present value of the vested account balances. The notes receivable are secured by the balance in the participant's account and bear fixed interest at rates that determined by plan administrator taking into consideration interest rates currently being charged on similar commercial loans. Loans have a maximum term of 5 years, unless such loan is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 10 years from the date of the loan origination. Principal and interest are paid ratably through payroll deductions. Participant loans are recorded in the financial statements at amortized cost (which represents unpaid principal plus accrued interest). Upon termination of a participant from employment, the participant's loan shall be due in full.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Forfeitures

The portion of a participant's account balance, which is not vested upon termination of employment, is forfeited and remains in the Plan. Forfeitures are used to reduce Company contributions or to pay allowable Plan expenses. Forfeitures were approximately \$917 for the year ended December 31, 2024 and there were no forfeitures for the period ended December 31, 2023, respectively. There were no forfeitures used to reduce plan expenses during the year ended December 31, 2024 or the period ended December 31, 2023, and the forfeiture balance as of December 31, 2024 and 2023 was \$918 and \$0, respectively.

Plan Expenses

Distribution and loan fees are charged directly to the requesting participant's account. Substantially all other administrative expenses are paid by the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 6 for additional information.

Notes Receivable from Participants

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefits Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 10, 2025, which is the date the financial statements were available to be issued.

Note 3. Information Certified by the Custodians

The plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Prudential Bank & Trust, FSB Company and Prudential Retirement Insurance and Annuity Company, qualified institutions, have certified the following investment information included for the period from October 1, 2023 to December 31, 2023 and from January 1, 2024 to March 2, 2024 and as of December 31, 2023 and Empower Trust Company, LLC and Empower Annuity Insurance Company of America, qualified institutions, have certified the following investment information for the period from March 2, 2024 to December 31, 2024 and as of December 31, 2024 in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024 and period ended December 31, 2023
- Investment information included in the accompanying schedules of assets (held at end of year) as of December 31, 2024 and 2023

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Party-in-interest Transaction and Related-Party Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are mutual funds and a guaranteed income fund account managed by Prudential until March 1, 2024 and Empower from March 2, 2024 to December 31, 2024. During the year ended December 31, 2024 and the period ended December 31, 2023, Prudential and Empower were the trustees and record-keepers as defined by the Plan, and therefore, these transactions qualify as party in-interest transactions. Fees paid to Prudential and Empower by the Plan totaled \$6,101 and \$75, respectively, for the year ended December 31, 2024 and the period ended December 31, 2023.

The Company provides certain administrative services at no cost to the Plan.

Note 5. Tax Status

The Plan operates under a pre-approved plan which received a favorable opinion letter dated September 16, 2022, from the Internal Revenue Service ("IRS"), indicating that the pre-approved plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes

that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: The fair value of the pooled separate accounts is determined by the fair value of the underlying mutual funds or stocks and fixed income securities. The fair value of the underlying securities is based on quoted prices of similar assets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. Investment Contract

The Plan offers a fully benefit-responsive investment contract with Empower Annuity Insurance Company (EAIC) as an investment option to plan participants. EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 1.5 percent. When establishing interest crediting rates for this product, EAIC considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.
