Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Cleveland Guardians 401(k) Plan (“Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTES TO FINANCIAL STATEMENTS

The Cleveland Guardians 401(k) Plan

1 Description of Plan

The following description of The Cleveland Guardians 401(k) Plan (the “Plan”) (formerly The Cleveland Indians 401(k) Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan, which began November 1, 1999, is a defined contribution plan covering all employees of the Cleveland Guardians Baseball Company Limited Partnership (the “Company”) who meet the hour and age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated effective May 1, 2021 to reflect recent Plan provisions and amendments as noted in the following disclosures.

Effective January 1, 2024 the Plan was amended to exclude Minor League Players from the Plan.

Eligibility:

All employees of the Company age eighteen and older are eligible to participate in the Plan. All employees of the Company age twenty-one and older, who have worked 1,000 hours in one year of service, are eligible for employer matching and employer non-elective contributions. Major League Players, seasonal employees, and non-resident aliens are not eligible for participation. Effective March 15, 2020, the Plan excludes Minor League Players from matching contributions and non-elective contributions.

Contributions:

Employee Contributions – Participants may elect a portion of their compensation to be contributed to the Plan by the Company. The Plan allows participants to make pre-tax and after-tax contributions and the Plan does not impose limits on participant’s elective deferral percentages for both pre-tax and after-tax contributions. The Company automatically defers a minimum of 3% from the participant’s compensation unless the participant elects a lesser percentage. Automatic enrollment is not available to part-time, temporary, or seasonal employees.

Employer Contributions – Effective March 15, 2020, the matching contribution became discretionary and effective April 15, 2020, the allocation period is as determined by the Company. In addition, the Company has the option to make a non-elective contribution. The non-elective contribution was discretionary effective April 15, 2020. For plan years ending December 31, 2024 and 2023, the company contributed a matching contribution of 50% of participant deferrals, up to 6% of compensation. and a non-elective contribution equal to 6% of the compensation of all benefitting participants.

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code as defined in the Plan agreement.

Participants’ Accounts:

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer discretionary contributions, earnings and losses thereon.

NOTES TO FINANCIAL STATEMENTS

1 Description of Plan, Continued

Vesting:

All participants are 100% vested in employee contributions to the Plan. Participants are not fully vested in employer match contributions until after three years of service, but remain 100% vested in non-elective employer contributions.

Forfeitures:

Forfeitures due to termination from the Plan before a participant is 100% vested that are not used to pay administrative expenses or to restore forfeited accounts shall be allocated to remaining participants in the same manner as the employer's contribution.

Other Plan Provisions:

Normal retirement age is 65. The Plan also provides for early payment of benefits after reaching age 59-1/2.

Payment of Benefits:

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant receives a lump sum amount or installment amounts equal to the value of his or her account. Benefits are recorded when paid.

Hardship Withdrawals:

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

Investment Options:

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Valuation of Investments:

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The fair value of the guaranteed income fund is based on the contributions contributed and disbursements made plus interest based on a crediting rate that is reset quarterly.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as held during the year.

2 Summary of Significant Accounting Policies, Continued

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees:

Substantially all administrative fees are paid by the Company.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Risks and Uncertainties:

The Plan's investments include investments in mutual funds and a guaranteed income fund with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for plan benefits.

Contributions:

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Subsequent Events:

Effective March 15, 2025, there was an amendment to increase the Plan's catch up contribution limit to the greater of \$10,000 or 150% of the regular catch-up contribution limit for the 2024 calendar year as indexed for inflation, for employees who have attained ages 60 through 63 before the close of the taxable year.

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

3 Tax Status

On September 21, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue code. The Plan has been amended; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Annually, informational returns are prepared and filed with the Internal Revenue Service.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

- * Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- * Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
 - * Quoted prices for similar assets or liabilities in active markets
 - * Quoted prices for identical or similar assets or liabilities in inactive markets
 - * Inputs other than quoted prices that are observable for the asset or liability
 - * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- * Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

4 Fair Value Measurements, Continued

Mutual Funds:

The fair value of the mutual funds is based on quoted market prices.

Guaranteed Income Fund:

The fair value of the guaranteed income fund is based on the principal and guaranteed interest credited to participant accounts, and participant principal and interest are fully guaranteed by the entire general account assets of The Standard Insurance Company. The contract value of the account approximates fair value as that is the amount that is paid out upon distribution to the participants. The guaranteed income fund is classified in the Level 3 category of the valuation hierarchy.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy tables is based on the lowest level of any input that is significant to the fair value measurement.

For the year ended December 31, 2024, the plan had purchases and sales of assets using significant unobservable inputs (level 3) of \$96,803 and \$240,828 respectively.
