## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the  
Save-A-Lot 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Save-A-Lot 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Save-A-Lot 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

### NOTES TO THE FINANCIAL STATEMENTS

#### (1) Plan Description

The following description of Save-A-Lot 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

##### *General Information*

The Plan, which was established October 10, 2016 and subsequently amended, is a defined contribution and 401(k) plan covering substantially all full-time employees of Moran Foods, LLC (the “Company”) who meet the eligibility provisions of the Plan. The Plan is subject to provisions of ERISA.

##### *Contributions*

Each year, participants may contribute not less than 1% or more than 50% of their eligible compensation, as defined in the Plan, not to exceed the maximum amount allowed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes a provision for a matching contribution of 100%, not to exceed 4%, of employee’s eligible compensation. Additional amounts may be contributed at the option of the Company’s Board of Directors. Participants direct the investment of the contributions into various investment options offered by the Plan.

##### *Eligible Participants*

Employees are eligible to participate in the Plan if they have completed thirty consecutive days of service.

##### *Participant Accounts*

Each participant’s account is credited with (a) the participant’s contributions, (b) the Company’s contributions, and (c) Plan earnings and appreciation. Each participant’s account is charged with (a) any withdrawals or distributions, (b) Plan losses and depreciation, and (c) an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### *Vesting*

Participants are immediately vested in their elective deferrals and rollover and transfer contributions, plus or minus actual earnings or losses thereon.

For employer contributions to the Plan, participants will vest as follows:

#### (1) Plan Description (Continued)

Participants are also fully vested in employer contributions upon the attainment of normal retirement age, retirement due to disability, death, or the termination of the Plan.

##### *Forfeited Plan Assets*

Nonvested account balances of terminated employees are forfeited. If a terminated employee returns to the Company within 5 years, any previously forfeited employer contribution match is restored. If a participant forfeits any unvested balances in his/her account, the forfeited assets are used to restore forfeited accounts of rehired participants, reduce future employer contributions, or pay plan expenses. Forfeitures used to reduce employer contributions and administrative fees for the years ended December 31, 2024 and 2023 were immaterial. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,089,361 and \$594,733, respectively.

##### *Notes Receivable from Participants*

Subject to provisions under the Plan, participants may borrow from the Plan a minimum amount of \$1,000 up to an amount which does not exceed the lesser of \$50,000 or 50% of the present value of the participant's vested benefit under the Plan. Notes receivable, which are secured by the balance in the participant's account, bear interest rates equal to the prime rate plus 1%, and have terms up to 5 years, unless the loan was made for the participant to acquire his/her principal residence. In this case, the maximum term is 10 years. Principal and interest are paid ratably through payroll deductions.

##### *Retirement and Terminations*

In the case of termination, normal retirement, retirement due to permanent disability, or death, participants or their designated beneficiaries will receive the value of their vested benefits, in accordance with the provisions of the Plan, either in a lump-sum distribution or through installment payments.

##### *In-Service Distributions*

The Plan allows for in-service distributions upon the attainment of age 59 ½ and only from funds in which the participant is 100% vested.

##### *Hardship Withdrawals*

The Plan allows for hardship withdrawals, as defined in the Plan, that are limited to the amount needed to meet the financial need. These withdrawals may not be recontributed to the Plan and may be subject to income tax and penalties.

##### *Administration*

All assets of the Plan are held and managed by Voya Institutional Trust Company ("Voya").

#### (2) Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual method of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. The fair value of the Plan's other financial instruments approximates their carrying amounts, either because the expected collection or payment period is relatively short or because the terms are similar to market trends. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Investment Risk*

Participants in the Plan assume all adverse investment risk connected with any decrease in value of plan assets, and such assets are the sole source of payments under the Plan.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan document.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Administrative Expenses*

Administrative expenses are generally paid by the Plan, except to the extent that the Company, at its discretion, directly pays for certain expenses.

##### *Subsequent Events*

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

#### (3) Transactions with Parties-In-Interest

The Plan is administered by the Company. Employees of the Company serve as the Plan's administrators and participate in the Plan. Administrative expenses are paid by the Plan, except to the extent that the Company, at its discretion, directly pays the expenses. The Plan may reimburse the Company for a reasonable expense incurred in administering the Plan paid by the Company if, at the time of the payment, the Company intended to have the Plan reimburse the Company for the expense. All investment funds are managed by Voya.

#### (4) Fair Value Measurements

Under the Fair Value Measurements and Disclosures topic of the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC"), a guideline is provided for measuring fair value. The topic establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs include quoted prices in active markets for similar assets, quoted prices in inactive markets for similar assets, or inputs that are observable or can be corroborated by observable market data or other means for substantially the full term of the asset; and Level 3 inputs have the lowest priority and are based on prices or valuation techniques that are unobservable and not corroborated by market data. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when an active market comparable is not available and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

##### *Level 1 Fair Value Measurements*

The fair values of mutual funds are based on quoted market prices.

The self-directed brokerage accounts primarily consist of mutual funds that are valued at the quoted market prices.

#### **(5) Pooled Separate Account**

The Plan offers a group annuity contract through a fully benefit-responsive investment contract with New York Life Insurance Company. Contributions to the contract are held in a pooled separate account owned and managed by New York Life Insurance Company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements as reported to the Plan by New York Life Insurance Company, which was \$20,400,536 and \$20,900,233 at December 31, 2024 and 2023, respectively. Contract value approximates fair value for these investments as of December 31, 2024 and 2023. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. New York Life Insurance Company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is updated daily and guaranteed to not be less than zero.

Certain events limit the Plan's ability to transact at contract value with New York Life Insurance Company. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan; or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

#### **(6) Certification**

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C). As permitted under such election, the Plan administrator has obtained certifications from Voya that the investment and loan balances and their related income as reported in the accompanying financial statements are complete and accurate.

#### **(7) Plan Termination Policies**

Although it has not expressed intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions set forth in ERISA. In the event of termination of the Plan, the right of all participants to benefits would become 100% vested and nonforfeitable. The amount of the account balance due each participant would be distributed in accordance with the payment provisions of the Plan.

#### **(8) Internal Revenue Service Status**

The Internal Revenue Service has determined and informed the plan administrator by a letter dated November 1, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan was amended subsequent to this date; however, the plan administrator and management believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan accounts for any uncertain tax positions in accordance with the Income Taxes topic of the FASB ASC. The topic prescribes a recognition threshold and measurement process for financial statement recognition of uncertain tax positions taken or expected to be taken in an annual return/report of an employee benefit plan. In evaluating the Plan's tax position, interpretations and tax planning strategies are considered. The Plan believes its tax exempt status is appropriate based on current facts and circumstances.

#### **(9) Risks and Uncertainties**

The Plan invests in various securities, including investment contracts with an insurance company. The underlying investments may include corporate debt instruments and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **(10) Reclassifications**

Certain accounts relating to prior year have been restated to conform to current year's presentation. These reclassifications have no effect on previously reported Plan benefits.
