Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Community Hospital 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank, similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audits.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following brief description of the Community Hospital 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document and Summary Plan Description, which are available from the Plan administrator, for more complete information.

General — The plan is a defined contribution 403(b) covering qualifying employees of Colorado West Health Care Systems, Inc. (the Organization). Employees are eligible to participate in the Plan for purposes of making deferral contributions and rollover contributions to the Plan from the date of hire. Employees who completed three months of service were eligible for the discretionary matching contributions and non-elective contributions. Effective January 1, 2024, employees are eligible for discretionary matching contributions and non-elective contributions upon participation in the Plan. The Quarterly Retirement Investment Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions — Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

New employees are automatically enrolled in the Plan. The automatic elective deferral contribution upon meeting eligibility requirements is 1% of the employee's compensation. Participants may affirmatively elect a different percentage or elect not to make deferral contributions.

The Organization contributes a non-elective contribution of 1% of the employees' compensation. In 2024 and 2023, the Organization made discretionary matching contributions of 50% of participant elective deferrals up to 3% of the employees' compensation.

Participants' Accounts — Each participant has the option of directing his or her contributions into any of the separate investment options and may change the allocation daily. Each participant shall have one account and such account will be credited with an allocation of the Organization's contributions, the participant's contributions and an allocation of the Plan's earnings and losses. Allocation of Plan earnings or losses, excluding that related to the participant's loans, are based on account balances. Earnings resulting from loans to participants are credited to the respective participant's accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants — Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 or (b) 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a rate of interest comparable to the current interest rates charged by financial institutions for similar loans. The term of the loan is a maximum of five years, unless the loan is for the purchase of a primary residence. Participants may not have more than one loan outstanding at any time. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Principal and interest are paid through regular payroll deductions.

Vesting — Participants are 100% vested in their contributions and their related allocation of the Plan's earnings or losses. Vesting in the Organization's discretionary matching and non-elective contribution portion of their accounts is based on years of service. A participant also becomes fully vested in the Organization's contribution upon early retirement age of 59 ½, death, or disability.

For employees terminated prior to January 1, 2024, vesting is based on years of credited service as set forth in the following table:

Forfeitures — At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$195,796 and \$160,947, respectively. These accounts will be used to reduce Plan expenses or reduce future employer contributions. During the years ended December 31, 2024 and 2023, employer contributions were reduced by \$165,458 and \$125,437, respectively, from forfeited non-vested accounts.

Payment of Benefits — Distribution of the participant's vested account balance will commence as soon as practical after the participant attains age 59½ and requests a distribution or terminates employment. Upon termination of service, an employee's vested account balance of \$5,000 or less will be distributed in a lump-sum amount; and an employee with a vested account balance greater than \$5,000 may elect to receive a lump-sum payment equal to their account balance, rollover the vested account balance to an account of their choice, or maintain the vested balance in the Plan and continue to share in investment gains and losses. The participant's account is distributed to the participant or, in the event of death, to the participant's beneficiary.

Tax Status — The Plan is a prototype plan of Principal Life Insurance Company (Principal). The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Internal Revenue Service (IRS) has determined and informed Principal by a letter dated March 31, 2017, that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has concluded that as of December 31, 2024, the Plan has no material uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Plan Termination — Although it has not expressed any intent to do so, the Organization has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, funds in the participant accounts become 100% vested.

Administrative Expenses — Certain administrative expenses of the Plan are paid by the Organization. Expenses that are paid by the Organization are excluded from the financial statements. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accounts of the Plan are maintained and the accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates — The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of net assets and changes in net assets, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition — Investments are reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The plan administrator determines the Plan's valuation policies utilizing information provided by the asset custodian. See Note 3 for information on fair value measurements.

Contract value is the required relevant measurement for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan's investment in Principal's Fixed Income Guaranteed Option represents a fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions — Contributions from participants are recorded in the year in which the employee contributions are withheld from compensation.

Benefit Payments — Benefits are recorded when paid.

Subsequent Events — Management has evaluated subsequent events for recognition or disclosure through the date of the Independent Auditors' Report, which is the date the financial statements were available for issuance.

3. INVESTMENTS

Fixed Income Guaranteed Option — The Plan has an investment in the Principal Fixed Income Guaranteed Option account, which is a fully benefit-responsive guaranteed interest account issued by Principal Life Insurance Company. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this investment contract. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Interest earned on the Fixed Income Guaranteed Option account is compounded daily to the effective annual interest rate. The interest rate to be credited is determined semi-annually. Amounts may be transferred from the participant's account balance in the Fixed Income Guaranteed Option at any time. Termination of the agreement or full Plan withdrawal from this account could restrict the liquidation of account balances. Management believes this is unlikely to occur.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Fair Value Information — Generally accepted accounting principles require the Plan to use a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2: Prices determined using significant other observable inputs. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Prices determined using significant unobservable inputs.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds – Valued at the closing price reported on the active market on which the investments are traded.

5. PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in a Fixed Income Guaranteed Option of Principal Life Insurance Company and mutual funds of Principal Trust Company, the Plan custodian. Therefore, these transactions qualify as party-in-interest transactions. The Plan has notes receivable from participants, these also qualify as party-in-interest transactions.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. NON-EXEMPT PROHIBITED TRANSACTIONS – DELINQUENT PARTICIPANT CONTRIBUTIONS

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During 2021, contributions of \$17,523 were not timely remitted as a result of a cyber-attack on the payroll system. Management remitted lost earnings of \$94 on these late contributions in 2024.
