**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Jones Plastic & Engineering Company, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description available from the plan administrator for a complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan established on October 1, 1987 for the purpose of providing retirement benefits to all eligible employees of Jones Plastic & Engineering Company, LLC (the “Company”) who are twenty and one-half years or older and who have completed one year of service. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The purpose of the Plan is to provide for eligible employees a qualified plan, which meets the requirements of section 401(k) of the Internal Revenue Code of 1986 (“IRC”), as amended.

Contributions: Participants may defer up to 60% of compensation, not to exceed IRS limitations. The Plan allows participants who have attained age 50 by the end of the Plan year to make catch-up contributions up to certain amounts subject to IRS limits. The Plan allows participants to designate their deferrals as either 401(k) or Roth 401(k) contributions.

For non-union participants, the Plan provides for a “safe harbor” match calculation of 100% of the first 3% of active participants’ compensation contributed to the Plan and 50% of the next 2% of active participants’ compensation contributed to the Plan. The Company’s policy is to fund the matching contribution quarterly.

For union employees, subject to a collective bargaining agreement with the Company, the Plan provides that the Company match 100% of each eligible participant’s elective deferred contributions. Deferral contributions by union participants eligible for the Company match are limited to 2% of the participant’s eligible compensation. The Company’s policy is to fund the matching contribution for union employees annually.

Participant Accounts: Each participant’s account is credited or charged with the participant’s contributions and allocations of (a) the Company’s contribution and (b) the Plan’s investment earnings or losses. Allocations of the Plan’s investment earnings, losses, or expenses are based on participant account balances, as defined. The amount of benefits to which each participant is entitled is the accumulated vested balance of his or her account. All amounts in participant accounts are participant-directed.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. For Company contributions, union participants are 20% vested in Company contributions after one year of service and are vested an additional 20% each year thereafter. Non-union participants are immediately 100% vested in safe harbor match contributions.

Notes Receivable From Participants: A participant may borrow from his or her vested account balance, subject to approval by the plan administrator, with a minimum loan amount of \$1,000, up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are repaid through monthly payments over periods ranging up to five years, except for qualified home loans, which must not exceed ten years. Interest rates are based on the prime lending rate plus one percent and are fixed over the life of the note.

Payment of Benefits: Benefits are recorded when paid upon termination of service due to death, disability, retirement or other reasons. Benefits are paid in lump-sum amounts equal to the value of the participant’s vested interest in his or her account. The Plan has the option of rolling over terminated participants’ accounts with balances between \$1,000 and \$5,000 into an individual retirement account designated by the Plan administrator unless the participant elects otherwise. The Plan has the option to automatically distribute terminated participants’ accounts with less than \$1,000 unless instructed otherwise by the participant.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Company.

Forfeited Accounts: Forfeitures of terminated participants' non-vested accounts are used to offset employer matching contributions. As of December 31, 2024 and 2023, there was \$627 and \$176, respectively, of forfeited non-vested, unallocated accounts available to offset future employer contributions.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Presentation: The Plan's financial statements are prepared under the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America.

Estimates in the Financial Statements: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Notes Receivable From Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Purchases and sales of securities are recognized on the trade date. Interest income is recorded when paid. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan provides for various options in investment securities. The underlying investment securities are exposed to various risks, such as interest rate, liquidity, market, credit risk and global events. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 8, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**NOTE 4 – FAIR VALUE MEASUREMENT**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The effect of a change in valuation technique or its application on a fair value estimate is accounted for prospectively as a change in accounting estimate. When evaluating indications of fair value resulting from the use of multiple valuation techniques, the Plan is to select the point within the resulting range of reasonable estimates of fair value that is most representative of fair value under current market conditions.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

***Mutual funds:*** The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 Inputs).

***Money Market funds:*** The fair values of money market fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 Inputs).

*Collective trust:* The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – INCOME TAX STATUS (Continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds investments issued by Fidelity Management Trust Company and Fidelity Investments, Inc., an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the Plan's trustee and, therefore, these transactions and the Plan's payment of trustee fees, and investment management fees qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Jones Plastic & Engineering Company, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description available from the plan administrator for a complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan established on October 1, 1987 for the purpose of providing retirement benefits to all eligible employees of Jones Plastic & Engineering Company, LLC (the “Company”) who are twenty and one-half years or older and who have completed one year of service. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The purpose of the Plan is to provide for eligible employees a qualified plan, which meets the requirements of section 401(k) of the Internal Revenue Code of 1986 (“IRC”), as amended.

Contributions: Participants may defer up to 60% of compensation, not to exceed IRS limitations. The Plan allows participants who have attained age 50 by the end of the Plan year to make catch-up contributions up to certain amounts subject to IRS limits. The Plan allows participants to designate their deferrals as either 401(k) or Roth 401(k) contributions.

For non-union participants, the Plan provides for a “safe harbor” match calculation of 100% of the first 3% of active participants’ compensation contributed to the Plan and 50% of the next 2% of active participants’ compensation contributed to the Plan. The Company’s policy is to fund the matching contribution quarterly.

For union employees, subject to a collective bargaining agreement with the Company, the Plan provides that the Company match 100% of each eligible participant’s elective deferred contributions. Deferral contributions by union participants eligible for the Company match are limited to 2% of the participant’s eligible compensation. The Company’s policy is to fund the matching contribution for union employees annually.

Participant Accounts: Each participant’s account is credited or charged with the participant’s contributions and allocations of (a) the Company’s contribution and (b) the Plan’s investment earnings or losses. Allocations of the Plan’s investment earnings, losses, or expenses are based on participant account balances, as defined. The amount of benefits to which each participant is entitled is the accumulated vested balance of his or her account. All amounts in participant accounts are participant-directed.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. For Company contributions, union participants are 20% vested in Company contributions after one year of service and are vested an additional 20% each year thereafter. Non-union participants are immediately 100% vested in safe harbor match contributions.

Notes Receivable From Participants: A participant may borrow from his or her vested account balance, subject to approval by the plan administrator, with a minimum loan amount of \$1,000, up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are repaid through monthly payments over periods ranging up to five years, except for qualified home loans, which must not exceed ten years. Interest rates are based on the prime lending rate plus one percent and are fixed over the life of the note.

Payment of Benefits: Benefits are recorded when paid upon termination of service due to death, disability, retirement or other reasons. Benefits are paid in lump-sum amounts equal to the value of the participant’s vested interest in his or her account. The Plan has the option of rolling over terminated participants’ accounts with balances between \$1,000 and \$5,000 into an individual retirement account designated by the Plan administrator unless the participant elects otherwise. The Plan has the option to automatically distribute terminated participants’ accounts with less than \$1,000 unless instructed otherwise by the participant.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Company.

Forfeited Accounts: Forfeitures of terminated participants' non-vested accounts are used to offset employer matching contributions. As of December 31, 2024 and 2023, there was \$627 and \$176, respectively, of forfeited non-vested, unallocated accounts available to offset future employer contributions.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Presentation: The Plan's financial statements are prepared under the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America.

Estimates in the Financial Statements: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Notes Receivable From Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Purchases and sales of securities are recognized on the trade date. Interest income is recorded when paid. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan provides for various options in investment securities. The underlying investment securities are exposed to various risks, such as interest rate, liquidity, market, credit risk and global events. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 8, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**NOTE 4 – FAIR VALUE MEASUREMENT**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The effect of a change in valuation technique or its application on a fair value estimate is accounted for prospectively as a change in accounting estimate. When evaluating indications of fair value resulting from the use of multiple valuation techniques, the Plan is to select the point within the resulting range of reasonable estimates of fair value that is most representative of fair value under current market conditions.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 Inputs).

*Money Market funds:* The fair values of money market fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 Inputs).

**NOTE 4 – FAIR VALUE MEASUREMENT (Continued)**

*Collective trust:* The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – INCOME TAX STATUS**

The Internal Revenue Service has ruled in a letter dated June 30, 2020, that the pre-approved plan qualifies under Section 401(a) of the Internal Revenue Code and is, therefore, not subject to tax under present income tax law. No determination letter specifically for the Plan has been requested. Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC.

**NOTE 5 – INCOME TAX STATUS** (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds investments issued by Fidelity Management Trust Company and Fidelity Investments, Inc., an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the Plan's trustee and, therefore, these transactions and the Plan's payment of trustee fees, and investment management fees qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.
