The following brief description of the Builders Exchange of Lansing and Central Michigan Association Health Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

1. **General** – The Plan was established by Builders Exchange of Lansing and Central Michigan (Plan Sponsor). It is a Multiple Employer Welfare Association (“MEWA”) as defined in Section (3)(40) of ERISA. Because the Plan is sponsored by a bona fide association of employers, the Plan is considered a single welfare plan (a “plan-MEWA”) under the Employee Retirement Income Security Act of 1974 (ERISA), as amended.
2. **Benefits** – The Plan includes various health benefit options for eligible employees and dependents, including hospitalization, surgical, medical, prescription, dental and vision and other related health care benefits. For more complete information concerning eligibility and benefits provided, refer to the plan’s summary plan description.
3. **Contributions** – Employers may contribute to the cost of each benefit. In addition, employees may be required to contribute to the cost of one or more of the benefits, as periodically determined by Employers. Required Employee contributions may vary depending on job classifications. Contributions towards the cost of each benefit, both Employer and Employee contributions, may temporarily be held in the Plan’s trust account after these contributions are paid by the Employer but before they are forwarded to the applicable insurance carrier.

Note B: **Summary of Significant Accounting Policies**

1. **General** – The accounting records of the Plan are maintained on an accrual basis. Revenue is recognized when earned and expenses are recognized when incurred.
2. **Estimates** – The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. **Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Note C: **Tax Status**

The Trust established under the Plan to hold the Plan's assets is qualified and exempt from income tax pursuant to Section 501(c)(9) of the Internal Revenue Code as a tax-exempt organization. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service, and the Plan Sponsor believes the Plan, as amended, continues to qualify and to operate as designed.

Note D: **Tax Uncertainties and Open Years**

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Fund and recognize a tax liability (or asset) if the Fund has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. Management has analyzed the tax positions taken by the Fund, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes it is no longer subject to income tax examination for years prior to December 31, 2021.

Note E: **Risks and Uncertainties**

Cash equivalents, financial instruments which potentially subject the Plan to concentrations of credit risk consist principally of cash. The Plan places its cash with tier I financial institutions. At times, the amount of cash on deposit in banks may be in excess of the respective financial institution's FDIC insurance limit.

Note F: **Priorities Upon Termination**

Although the Plan Sponsor intends to maintain the Plan indefinitely, the Plan Sponsor has the authority to amend or terminate the Plan or any benefit at any time. No amendment or termination can retroactively diminish a participant's right to obtain Plan benefits. Participants will be informed of any material amendment affecting their benefits or changing the operation of the Plan. Additionally, an Employer may also cease its participation in the Plan by ceasing to be a Participating Employer.

Note G: **Party-in-Interest Transactions**

Fees paid during the year for legal, auditing, and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services.



