Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Team Holland, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Team Holland, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Team Holland, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Participants should refer to the Plan document for more complete information.

General

The Plan was established December 1, 2013 and was amended and restated effective January 1, 2022 which included formal amendment to adopt the provisions of the CARES Act and SECURE Act. In addition, the Plan was amended effective as of October 10, 2022 to allow in-service withdrawals upon attainment of age 59 1/2. The Plan is a defined contribution plan covering substantially all employees of Team Holland, Inc. and related entities (together the "Company"). The Plan covers substantially all employees who are 21 years of age and have had twelve months of service. Company officers control and manage the operation and administration of the Plan. The Plan is subject to the provisions of ERISA, as amended.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan, subject to certain Internal Revenue Code ("IRC") limits. The Company will make a safe harbor match, on a dollar-for-dollar basis, of the first 3% of participants' contributions, plus 50% of participants' contributions that exceed 3% up to 5% of each eligible participants' contributions. The Company made a safe harbor matching contribution of \$456,755 for the year ended December 31, 2024. The Company can make additional discretionary contributions. The Company made no such contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, and an allocation of the Company's contributions and investment income or loss. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. During 2024 and 2023, the Plan offered a range of mutual funds as investment options for participants.

Vesting

Participants are vested immediately in their contributions plus actual net earnings thereon. Participants are immediately vested in the Company's safe harbor match contributions plus earnings thereon. Vesting in the Company's discretionary portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are 20% vested in Company discretionary contributions after two years of service and are fully vested upon completion of six years of credited service.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. Loans bear interest at the USA Today Prime Rate plus 1% for the month. Principal and interest is paid ratably through payroll deductions and is credited to each participant's account balance.

Benefit Payments

Upon termination of service due to death, disability, retirement, other termination of employment with the Company, a participant's account with a vested account balance of \$5,000 or less will be mandatorily distributed as soon as administratively feasible without the participant's consent. Distributions under the Plan may be made by lump-sum distributions.

Forfeitures

Forfeitures may be used to reduce certain employer contributions and/or to pay Plan expenses. The balance in the forfeiture account at December 31, 2024 was \$166 and at December 31, 2023 was \$1,288. The Plan used \$1,341 of forfeitures to pay Plan expenses in 2024.

Reclassification

Certain prior year data in financial statements has been reclassified to conform with current year presentation.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") and conform to the accounting requirements of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest is charged until the loan is repaid and loans are not placed on nonaccrual status. Interest income is recognized at the time payment is made. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses and fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

NOTE 3 - RISKS AND UNCERTAINTIES

The Plan utilizes mutual fund investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

NOTE 4 - INCOME TAX STATUS

The Company adopted a non-standardized pre-approved profit sharing plan with CODA ("non-standardized plan"), which received an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") stating that the non-standardized plan, in form only, meets the requirements under the applicable sections of the IRC and is therefore qualified. The Plan has been amended since adopting the non-standardized plan. The Plan has not obtained a separate determination letter from the IRS, nor is it required to do so. The Company and the plan administrator believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021. There are currently no audits for any tax periods in progress.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their employer contributions.

NOTE 6 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

NOTE 8 - FAIR VALUE MEASUREMENT

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were used by the Plan.

Level 1 Fair Value Measurements

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 9 - PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are held by Ascensus. Ascensus is the trustee as defined by the Plan and, therefore, certain transactions qualify as party-in-interest. Fees paid by the Plan to Ascensus for plan administration and custodial services were \$30,335 for the year ended December 31, 2024.

NOTE 10 - CORRECTIVE ACTIONS

During 2024 and 2023, the Company failed to timely remit certain participant contributions to the Plan. An amount was not accrued or recorded in the financial statements because the Company is actively working with their third-party administrator to make the proper corrections.

NOTE 11 - SUBSEQUENT EVENTS

The Plan has evaluated all subsequent events through October 10, 2024, the date the financial statements were available to be issued.
